- 1 A BILL for an Act to amend and reenact section 15.1-27-03.1 of the North Dakota Century
- 2 Code, relating to the determination of weighted average daily membership; to provide an
- 3 effective date; and to declare an emergency.

## 4 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 5 **SECTION 1. AMENDMENT.** Section 15.1-27-03.1 of the North Dakota Century Code is amended and reenacted as follows:
- 7 15.1-27-03.1. Weighted average daily membership Determination.
- 8 1. For each school district, the superintendent of public instruction shall multiply by:
  - a. 1.00 the number of full-time equivalent students enrolled in an extended educational program in accordance with section 15.1-32-17;
    - 0.60 the number of full-time equivalent students enrolled in a summer education program, including a migrant summer education program;
    - c. 0.40 the number of full-time equivalent students who:
      - (1) On a test of English language proficiency approved by the superintendent of public instruction are determined to be least proficient and placed in the first of six categories of proficiencytest in the first, second, and third levels of proficiency; and
      - (2) Are enrolled in a program of instruction for English language learners;
- 19 d. 0.280.10 the number of full-time equivalent students who:
  - (1) On a test of English language proficiency approved by the superintendent of public instruction are determined to be more proficient than students placed

**SECTION 3. EMERGENCY.** This Act is declared to be an emergency measure.
