This bill would remove the initial \$15 fee for a veteran plate and the annual charge of \$10.

For the veteran plate initial \$15 fee, \$10 is deposited into the Highway Tax Distribution Fund and \$5 is deposited in the Veterans' Cemetery Maintenance Fund. For the veteran plate \$10 annual fee, \$5 is deposited in the Veterans' Cemetery Trust Fund and \$5 is deposited in the Veterans' Cemetery Maintenance Fund.

For the 2025-2027 biennium MV estimates a total decrease in revenue by \$191,790. (Highway Tax Distribution Fund would be reduced by \$32,340, the Veteran Cemetery Maintenance Fund reduced by \$87,810 and the Veterans Cemetery Trust Fund reduced by \$71,640.)

For the 2027-2029 biennium MV estimates an annual increase of 7% for new plates and an annual increase of 2% for renewals for a total decrease in revenue by \$204,600. (Highway Tax Distribution Fund would be reduced by \$37,020, the Veteran Cemetery Maintenance Fund reduced by \$93,045 and the Veterans Cemetery Trust Fund reduced by \$74,535.)

This revenue would decrease the distribution through the Highway Tax Distribution Fund. The impact to counties is (22%), cities (12.5%), townships (2.7%), public transit (1.5%), and the State Highway Fund (61.3%) would be applied to the biennial reduction of revenue for the Highway Tax Distribution Fund.
