**SUMMARY OF ACTUARIAL INFORMATION**

**BILL NO:** Engrossed SB 2046

**BILL DESCRIPTION:** WSI Employer Services Bill

**SUMMARY OF ACTUARIAL INFORMATION:** Workforce Safety & Insurance, together with its consulting actuaries, The Burkhalter Group, has reviewed the legislation proposed in this bill in conformance with Section 54-03-25 of the North Dakota Century Code.

The amended legislation establishes a one-time, \$250 premium credit for new employer accounts with a 50% ownership interest held by active members of the N.D national guard or armed forces, or veterans of the military, or a surviving spouse of a veteran; and provides WSI the ability to transmit employer-related notices of decisions and administrative orders electronically.

**FISCAL IMPACT:** No significant impact to premium rate levels is anticipated.
