**3 - Bill and Fiscal Impact Summary**

HB 1067 would require social security survivor income and court-ordered child support to be disregarded income sources for children who are under age 18 and enrolled in a Medicaid 1915(c) waiver. It also increases the age limit for the Medicaid children's waivers.

**4 - Fiscal Impact Sections Detail**

Section 1 of this bill requires Medicaid to disregard social security survivor income and court-ordered child support for children who are enrolled in 1915(c) waivers. These children qualify for Medicaid based on being in a medically needy coverage group and having to spend down income (client share or recipient liability) on medical expenses before they qualify for Medicaid. There are currently nine children who have social security survivor income counted

towards their client share and one child who has child support counted towards their client share.

There is no fiscal impact for the age changes to the waivers. Each waiver has a specific number of slots that cannot be exceeded in a given year, and each slot is budgeted for. This change will enable children to continue participating in the waiver until they age out.

Section 3 of this bill requires a July 1, 2026, effective date.

HB 1067 would require social security survivor income and court-ordered child support to be disregarded income sources for children who are under age 18 and enrolled in a Medicaid 1915(c) waiver

Under this bill, the Department will cover the portion of costs that the client would have paid. The estimated average monthly cost for the Department is \$5,227, which is a total impact of \$62,724 for the 2025-2027 biennium.

For the 2025-2027 biennium, the Department of Health and Human Services would need appropriation increases to the base budget for HB 1012 in the following line item:

Grants - Medical Assistance line of \$62,724, of which \$31,207 is General Fund.

For the 2027 - 2029 biennium, the Department of Health and Human Services would need appropriation authority in the following line item:

Grants - Medical Assistance line of \$125,448, of which \$62,724 is General Fund.
