REENGROSSED SENATE BILL NO. 2113**

(At the request of the Department of Health and Human Services)

A BILL for an Act to create and enact two new sections to chapter 50-06 of the North Dakota Century Code, relating to certified community behavioral health clinics and the financing of health and human services; to amend and reenact section 12.1-04-06, subsection 4 of section 20.1-03-04, sections 25-03.1-03.1 and 25-03.1-04, subsection 3 of section 25-03.1-08, section 25-03.1-10, subsection 3 of section 25-03.1-11, subsection 1 of section 25-03.1-19, subsection 2 of section 25-03.1-26, subdivision b of subsection 2 of section 26.1-36-08, subdivisions c and d of subsection 2 of section 26.1-36-09, subsection 9 of section 43-12.1-04, subsection 6 of section 43-41-02, subdivision b of subsection 1 of section 44-04-18.30, sections 50-06-01, 50-06-01.4, 50-06-01.7, 50-06-05.1, 50-06-05.2, 50-06-05.3, 50-06-05.4, 50-06-05.5, 50-06-06.2, 50-06-06.5, and 50-06-06.13, subsections 1 and 3 of section 50-06-15, sections 50-06-33 and 50-06-41.3, subsection 1 of section 50-06-42, subsection 1 of section 50-06-42.1, and sections 50-06-46, 50-06.2-01, 50-06.2-02, 50-06.2-03, 50-06.3-02, and 50-06.3-04 of the North Dakota Century Code, relating to the powers and duties of the department of health and human services, treatment hearing timelines, and membership of the cross disability advisory council; to provide for a legislative management study; and to provide an expiration date.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. Section 12.1-04-06 of the North Dakota Century Code is amended and reenacted as follows:

12.1-04-06. Temporary detention for purposes of examination.

Whenever there is reason to doubt the defendant's fitness to proceed, the court may order temporary detention of the defendant for the purpose of an examination. The temporary detention must be in the least restrictive appropriate setting, including the state hospital, the life

1 skills and transition center, or other suitable facility for a reasonable period, not to exceed thirty
2 days, for such examination. In lieu of detention, the court may allow the defendant to remain in
3 the defendant's present residential setting or other suitable residential setting for the purpose of
4 examination, subject to any reasonable limitation the court may impose. A ~~human service-~~
5 ~~center~~state-operated behavioral health clinic may be considered if the court is aware an inquiry
6 was made before the court ordered the evaluation to ensure appropriate resources exist at the
7 ~~human service center~~state-operated behavioral health clinic being ordered to conduct the
8 examination. While the defendant is detained, the defendant's legal counsel, family, and others
9 necessary to assist in the defendant's case must have reasonable opportunity to examine and
10 confer with the defendant.

11 **SECTION 2. AMENDMENT.** Subsection 4 of section 20.1-03-04 of the North Dakota
12 Century Code is amended and reenacted as follows:

- 13 4. Life skills and transition center patients, North Dakota youth correctional center
14 students, school for the deaf students, North Dakota vision services - school for the
15 blind students, state hospital patients, clients of ~~regional human service centers~~state-
16 operated behavioral health clinics under direct therapeutic care, and residents of
17 facilities licensed by the department of health and human services may fish without a
18 resident fishing license. Patients of these institutions must be identified. The
19 department shall issue authority to each institution.

20 **SECTION 3. AMENDMENT.** Section 25-03.1-03.1 of the North Dakota Century Code is
21 amended and reenacted as follows:

22 **25-03.1-03.1. Disclosure of health information.**

23 A treating facility or mental health professional may disclose individually identifiable health
24 information to a court, ~~regional human service center~~state-operated behavioral health clinic,
25 state's attorney, appointed counsel, retained counsel, or other mental health professional,
26 including an expert examiner, and the disclosure is a disclosure for treatment, including the
27 provision, coordination, and management of health care and to carry out the purposes of this
28 chapter.

29 **SECTION 4. AMENDMENT.** Section 25-03.1-04 of the North Dakota Century Code is
30 amended and reenacted as follows:

25-03.1-04. Screening and admission to a public treatment facility.

Under rules adopted by the department, screening of an individual to a public treatment facility for observation, diagnosis, care, or treatment for mental illness or a substance use disorder must be performed, in person when reasonably practicable, by a ~~regional human-service-center~~state-operated behavioral health clinic. This screening must be performed in the region where the individual is physically located. Upon the request of a court, a law enforcement official, a mental health professional, the individual's legal guardian, a minor's parent or legal custodian, or the individual requesting services, the ~~regional human-service-center~~state-operated behavioral health clinic shall conduct a screening. If a request for screening is made by a mental health professional and the individual who is the subject of the screening does not authorize the disclosure of the individual's protected health information, upon the request of the ~~regional human-service-center~~state-operated behavioral health clinic, any mental health professional who treated the individual within the previous six months shall disclose, subject to the requirements of title 42, Code of Federal Regulations, part 2, to the ~~human-service-center~~state-operated behavioral health clinic any relevant protected health information regarding that treatment. Upon receipt of the request, the ~~regional human-service-center~~state-operated behavioral health clinic shall arrange for a screening of the individual and, if appropriate, shall treat the applicant or refer the applicant to the appropriate treatment facility. Upon admittance to a public treatment facility, the superintendent or director shall immediately designate a tier 1 or tier 2 mental health professional to examine the individual.

SECTION 5. AMENDMENT. Subsection 3 of section 25-03.1-08 of the North Dakota Century Code is amended and reenacted as follows:

3. In assisting the petitioner in completing the petition, the state's attorney may direct a tier 1 or tier 2 mental health professional designated by the ~~regional human-service-center~~state-operated behavioral health clinic to investigate and evaluate the specific facts alleged by the petitioner. The investigation must be completed as promptly as possible and include observations of and conversation with the respondent, unless the respondent cannot be found or refuses to meet with the mental health professional. A written report of the results of the investigation must be delivered to the state's attorney. Copies of the report must be made available upon request to the respondent, the respondent's counsel, and any expert examiner conducting an examination under

1 section 25-03.1-11. The state's attorney or retained attorney shall file the petition if the
2 information provided by the petitioner or gathered by investigation provides probable
3 cause to believe the subject of the petition is a person requiring treatment. A state's
4 attorney who determines there are insufficient grounds for filing a petition may refer
5 the individual to other community resources. A state's attorney's decision not to
6 institute proceedings may be reviewed under section 11-16-06.

7 **SECTION 6. AMENDMENT.** Section 25-03.1-10 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 **25-03.1-10. Involuntary treatment - Court-ordered examination.**

10 If the petition is not accompanied by a written supportive statement of a tier 1 mental health
11 professional or a licensed addiction counselor who has examined the respondent within the last
12 forty-five days, the court shall order the respondent be examined by an expert examiner of the
13 respondent's own choice or one appointed by the court. The order must state the date and time
14 within which the respondent must appear; the address to which the respondent is to report; a
15 statement that if the respondent fails to appear at the appointed place at or before the ordered
16 date and time, the respondent may be involuntarily taken into custody and transported to the
17 appointed place; and a statement the expert examiner may consult with or request participation
18 in the examination by a mental health professional and may include with the written examination
19 report any findings or observations by that mental health professional. Accompanying the order
20 must be an explanation of the intended uses and possible effects of this examination. The
21 examination may be conducted at a treatment facility, at the respondent's home, or at any other
22 suitable place in the community. A request for examination at the state hospital must be
23 screened and approved by a ~~regional human service center~~state-operated behavioral health
24 clinic. The respondent may be accompanied by one or more relatives or friends at the place of
25 the examination. The costs of the court-ordered examination must be borne by the county that
26 is the respondent's place of residence.

27 **SECTION 7. AMENDMENT.** Subsection 3 of section 25-03.1-11 of the North Dakota
28 Century Code is amended and reenacted as follows:

- 29 3. If the expert examiner concludes the respondent is not a person requiring treatment,
30 the court may without taking any other additional action terminate the proceedings and
31 dismiss the petition. If the expert examiner concludes the respondent is a person

1 requiring treatment, or makes no conclusion whether the respondent is a person
2 requiring treatment, the court shall set a date for hearing and shall give notice of
3 hearing to the persons designated in section 25-03.1-12. If the respondent is in
4 custody and is alleged to be a person who is mentally ill or a person who is both
5 mentally ill and has a substance use disorder, the preliminary hearing date must be
6 within ~~four~~five days, exclusive of weekends and holidays, of the date the respondent
7 was taken into custody through emergency commitment under section 25-03.1-25
8 unless a delay or continuance is concurred in by the respondent or unless extended
9 by the magistrate for good cause shown. If a preliminary hearing is not required, the
10 treatment hearing must be held within ~~four~~five days, exclusive of weekends and
11 holidays, of the date the court received the expert examiner's report, not to exceed
12 fourteen days from the time the petition was served.

13 **SECTION 8. AMENDMENT.** Subsection 1 of section 25-03.1-19 of the North Dakota
14 Century Code is amended and reenacted as follows:

- 15 1. The involuntary treatment hearing, unless waived by the respondent or the respondent
16 has been released as a person not requiring treatment, must be held within fourteen
17 days of the preliminary hearing. If the preliminary hearing is not required, the
18 involuntary treatment hearing must be held within ~~four~~five days, exclusive of weekends
19 and holidays, of the date the court received the expert examiner's report, not to
20 exceed fourteen days from the time the petition was served. The court may extend the
21 time for hearing for good cause. The respondent has the right to an examination by an
22 independent expert examiner if so requested. If the respondent is indigent, the county
23 of residence of the respondent shall pay for the cost of the examination and the
24 respondent may choose an independent expert examiner.

25 **SECTION 9. AMENDMENT.** Subsection 2 of section 25-03.1-26 of the North Dakota
26 Century Code is amended and reenacted as follows:

- 27 2. Upon receipt of the petition and notice of the emergency detention, the magistrate
28 shall set a date for a preliminary hearing, if the respondent is alleged to be a person
29 who is mentally ill or a person who is both mentally ill and has a substance use
30 disorder, or a treatment hearing, if the respondent is alleged to be a person who has a
31 substance use disorder, to be held no later than ~~four~~five days, exclusive of weekends

1 and holidays, after detention unless the person has been released as a person not
2 requiring treatment, has been voluntarily admitted for treatment, has requested or
3 agreed to a continuance, or unless the hearing has been extended by the magistrate
4 for good cause shown. The magistrate shall appoint counsel if one has not been
5 retained by the respondent.

6 **SECTION 10. AMENDMENT.** Subdivision b of subsection 2 of section 26.1-36-08 of the
7 North Dakota Century Code is amended and reenacted as follows:

8 b. In the case of benefits provided for partial hospitalization, the benefits must be
9 provided for a minimum of one hundred twenty days of services covered under
10 this section and section 26.1-36-09 in any calendar year. Services provided
11 under this subdivision must be provided by an addiction treatment program
12 licensed under chapter 50-31. For services provided in ~~regional human service-~~
13 ~~centers~~state-operated behavioral health clinics, charges must be reasonably
14 similar to the charges for care provided by hospitals as defined in this subsection.

15 **SECTION 11. AMENDMENT.** Subdivisions c and d of subsection 2 of section 26.1-36-09 of
16 the North Dakota Century Code are amended and reenacted as follows:

17 c. In the case of benefits provided for partial hospitalization, the benefits must be
18 provided for a minimum of one hundred twenty days of services covered under
19 this section and section 26.1-36-08 in any calendar year. Partial hospitalization
20 must be provided by a hospital as defined under section 52-01-01 and rules of
21 the department of health and human services pursuant thereto or by a ~~regional-~~
22 ~~human service center~~state-operated behavioral health clinic licensed under
23 section 50-06-05.2, offering treatment for the prevention or cure of mental
24 disorder or other related illness. For services provided in ~~regional human service-~~
25 ~~centers~~state-operated behavioral health clinics, charges must be reasonably
26 similar to the charges for care provided by hospitals as defined in this subsection.

27 d. In the case of benefits provided for residential treatment, the benefits must be
28 provided for a minimum of one hundred twenty days of services covered under
29 this section in any calendar year. Residential treatment services must be
30 provided by a hospital as defined under section 52-01-01 and rules of the
31 department of health and human services; by a ~~regional human service-~~

1 ~~center~~state-operated behavioral health clinic licensed under section 50-06-05.2
2 offering treatment for the prevention or cure of mental disorder or other related
3 illness; or by a residential treatment program. For services provided in a ~~regional-~~
4 ~~human service center~~state-operated behavioral health clinic, charges must be
5 reasonably similar to the charges for care provided by a hospital as defined in
6 this subsection.

7 **SECTION 12. AMENDMENT.** Subsection 9 of section 43-12.1-04 of the North Dakota
8 Century Code is amended and reenacted as follows:

- 9 9. A person that provides medications, other than by the parenteral route:
- 10 a. Within a correctional facility, in compliance with section 12-44.1-29;
- 11 b. Within a psychiatric residential treatment facility for children licensed under
12 chapter 25-03.2 and North Dakota Administrative Code chapter 75-03-17;
- 13 c. Within a treatment or care center for individuals with developmental disabilities
14 licensed under chapter 25-16;
- 15 d. Within a group home, a qualified residential treatment program, or an adult foster
16 care facility licensed under section 50-11-01;
- 17 e. Within the life skills and transition center, to the extent the individual who
18 provides medications is a direct training technician or a vocational training
19 technician as approved by the department of health and human services;
- 20 f. Within a ~~human service center~~state-operated behavioral health clinic licensed
21 under chapter 50-06; ~~or~~
- 22 g. Within a primary or secondary school under a program established under section
23 15.1-19-23 if the individual has received education and training in medication
24 administration and has received written consent of the student's parent or
25 guardian; or
- 26 h. Who is an employee of a qualified service provider agency who meets the criteria
27 set forth in subsection 2 of section 50-24.1-18.

28 **SECTION 13. AMENDMENT.** Subsection 6 of section 43-41-02 of the North Dakota
29 Century Code is amended and reenacted as follows:

- 30 6. This chapter does not prevent individuals with master's or doctoral degrees in the field
31 of counseling with specialization in mental health from serving as counselors or

therapists in mental health in state institutions or ~~regional human service centers~~state-
operated behavioral health clinics, if they do not hold themselves out to the public as
social workers.

SECTION 14. AMENDMENT. Subdivision b of subsection 1 of section 44-04-18.30 of the
North Dakota Century Code is amended and reenacted as follows:

b. "Public social services agency" means a state, county, or local public agency that
provides human services, and includes ~~regional human service centers~~state-
operated behavioral health clinics, ~~county social services~~human service zone
boards, ~~multicounty social services districts~~human service zones, and the
department of health and human services.

SECTION 15. AMENDMENT. Section 50-06-01 of the North Dakota Century Code is
amended and reenacted as follows:

50-06-01. Definitions.

As used in this chapter, unless the context otherwise requires:

1. "Behavioral health" means the planning and implementation of preventive,
consultative, diagnostic, treatment, crisis intervention, rehabilitative, and suicide
prevention services for individuals with mental, emotional, or substance use disorders,
and psychiatric conditions.
2. "Behavioral health provider" means any licensed or accredited behavioral health
provider in this state.
3. "Certified community behavioral health clinic" means a private or public behavioral
health clinic or a state-operated behavioral health clinic designated by the department
to deliver a comprehensive range of mental health and substance use disorder
services in accordance with the certification criteria set forth by the department.
4. "Department" means the department of health and human services.
- 4.5. "Human services" means:
 - a. A service or assistance provided to an individual or an individual's family in need
of services or assistance, including child welfare services, economic assistance
programs, medical services programs, and aging services programs, to assist the
individual or the individual's family in achieving and maintaining basic

1 self-sufficiency, including physical health, mental health, education, welfare, food
2 and nutrition, and housing.

3 b. A service or assistance provided, administered, or supervised by the department
4 in accordance with chapter 50-06.

5 c. Licensing duties as administered or supervised by the department or delegated
6 by the department to a human service zone.

7 6. "State-operated behavioral health clinic" means a department-operated behavioral
8 health clinic established under section 50-06-05.2.

9 **SECTION 16. AMENDMENT.** Section 50-06-01.4 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **50-06-01.4. Structure of the department.**

12 1. The department includes the state hospital, the ~~regional human service centers~~state-
13 operated behavioral health clinics, a vocational rehabilitation unit, public health
14 division, and other units or offices and administrative and fiscal support services as the
15 commissioner of the department determines necessary. The department must be
16 structured to promote efficient and effective operations and, consistent with fulfilling its
17 prescribed statutory duties, shall act as the official agency of the state in the discharge
18 of the following functions not otherwise by law made the responsibility of another state
19 agency:

20 a. Administration of programs for children and families, including adoption services
21 and the licensure of child-placing agencies, foster care services and the licensure
22 of foster care arrangements, certification of shelter care services, child protection
23 services, children's trust fund, licensure of early childhood programs, refugee
24 services, in-home community-based services, quality control, and administration
25 of the interstate compacts on the placement of children and juveniles.

26 b. Administration of programs for individuals with developmental disabilities,
27 including licensure of facilities and services, the establishment funding for family
28 members and corporate guardianships, and the design and implementation of a
29 community-based service system for persons in need of habilitation.

30 c. Administration of aging service programs, including nutrition, transportation,
31 advocacy, social, ombudsman, recreation, and related services funded under the

1 Older Americans Act of 1965 [42 U.S.C. 3001 et seq.], home and
2 community-based services, licensure of adult foster care homes, and the
3 committee on aging.

4 d. Administration of behavioral health programs, including reviewing and identifying
5 service needs and activities in the state's behavioral health system in an effort to
6 ensure health and safety, access to services, and quality of services; establishing
7 quality assurance standards for the licensure of substance use disorder program
8 services and facilities; providing policy leadership in partnership with public and
9 private entities; and providing chronic disease management, regional intervention
10 services, and twenty-four-hour crisis services for individuals with behavioral
11 health disorders.

12 e. Administration of economic assistance programs, including temporary assistance
13 for needy families, the supplemental nutrition assistance program, home energy
14 assistance, child care assistance, refugee assistance, work experience, work
15 incentive, and quality control.

16 f. Administration of medical service programs, including medical assistance for
17 children's health insurance program, Medicaid waivers, early and periodic
18 screening, diagnosis and treatment, utilization control, autism services, and
19 claims processing.

20 g. Administration of general assistance.

21 h. Administration of child support.

22 i. Administration of program, services, and licensing outlined in title 23 and other
23 previous duties of the state department of health and state health council.

24 2. The commissioner of the department or commissioner's designee shall consult with
25 and maintain a close working relationship with the department of corrections and
26 rehabilitation and the superintendents of the school for the deaf and the North Dakota
27 vision services - school for the blind to develop programs for individuals with
28 developmental disabilities; and with the superintendent of public instruction to
29 maximize the use of resource persons in ~~regional human service centers~~state-
30 operated behavioral health clinics in the provision of special education services. The

1 commissioner of the department or commissioner's designee shall also maintain a
2 close liaison with human service zones.

3 3. ~~By August 1, 2019, the~~ The department shall establish a template for the development
4 of human service zone plans, including process and content requirements, access
5 point expectations, client grievances procedures, human resources, and locally funded
6 programs or services and how those services will be addressed.

7 4. The department shall develop, with assistance from the North Dakota association of
8 counties, a process for consultation and technical assistance for human service zone
9 working groups ~~by August 1, 2019.~~

10 **SECTION 17. AMENDMENT.** Section 50-06-01.7 of the North Dakota Century Code is
11 amended and reenacted as follows:

12 **50-06-01.7. Behavioral health division - Administration - Fees.**

13 1. The department shall ~~administratively restructure the behavioral health division to~~
14 ~~require the division to~~ develop and revise, when necessary, the state mental health
15 plan and provide the behavioral health division the authority to implement and
16 supervise a unified mental health delivery system and to assure the mental health
17 services provided by the ~~human service centers~~ state-operated behavioral health
18 clinics, the state hospital, and contracted services are in accordance with the state
19 plan.

20 2. The behavioral health division may establish nonrefundable application fees not to
21 exceed three hundred dollars for administration and enforcement of licensing and
22 certification activities. The department shall adopt rules as necessary to implement
23 this section. All fees collected under this section must be paid to the behavioral health
24 division and must be used to defray the cost of administering and enforcing licensing
25 and certification activities.

26 **SECTION 18. AMENDMENT.** Section 50-06-05.1 of the North Dakota Century Code is
27 amended and reenacted as follows:

28 **50-06-05.1. Powers and duties of the department. (Effective through June 30, 2027)**

29 The department has the following powers and duties to be administered by the department
30 through its state office or ~~regional human service centers~~ state-operated behavioral health
31 clinics, human service zones, or otherwise as directed by the department:

- 1 1. To act as the official agency of the state in any social welfare or human service activity
2 initiated by the federal government not otherwise by law made the responsibility of
3 another state agency.
- 4 2. To administer, allocate, and distribute any state and federal funds that may be made
5 available for the purpose of providing financial assistance, care, and services to
6 eligible persons and families who do not have sufficient income or other resources to
7 provide a reasonable subsistence compatible with decency and health.
- 8 3. To provide preventive, rehabilitative, and other human services to help families and
9 individuals to retain or attain capability for independence or self-care.
- 10 4. To do needed research and study in the causes of social problems and to define
11 appropriate and effective techniques in providing preventive and rehabilitative
12 services.
- 13 5. To provide for the study, and to promote the well-being, of a child in need of protection,
14 a child in need of services, and delinquent children.
- 15 6. To provide for the placing and supervision of children in need of substitute parental
16 care, subject to the control of any court having jurisdiction and control of any such
17 child.
- 18 7. To recommend appropriate human services related legislation to the legislative
19 assembly.
- 20 8. To direct and supervise human service zone activities and administer a statewide
21 program for state-funded human services, staffing, and administration costs related to
22 the administration of human services.
- 23 9. To secure, hold, and administer for the purpose for which it is established any property
24 and any funds donated to it either by will or deed, or otherwise, or through court order
25 or otherwise available to the department, and to administer those funds or property in
26 accordance with the instructions in the instrument creating them or in accordance with
27 the instructions in the court order or otherwise.
- 28 10. To formulate standards and make appropriate inspections and investigations in
29 accordance with such standards in connection with all licensing activities delegated by
30 law to the department, including early childhood programs, nonmedical adult care
31 facilities and maternity homes, and persons or organizations receiving and placing

children, and to require those facilities, persons, and organizations to submit reports and information as the department may determine necessary.

11. To permit the making of any surveys of human service needs and activities if determined to be necessary.

12. To issue subpoenas, administer oaths, and compel attendance of witnesses and production of documents or papers whenever necessary in making the investigations provided for herein or in the discharge of its other duties. A subpoena may not be issued to compel the production of documents or papers relating to any private child-caring or child-placing agency or to compel the attendance as a witness of any officer or employee of those facilities except upon the order of a judge of the district court of the judicial district in which the facilities are located.

13. To provide insofar as staff resources permit appropriate human services, including social histories, social or social-psychological evaluations, individual, group, family, and marital counseling, and related consultation, when referred by self, parent, guardian, human service zone, court, physician, or other individual or agency, and when application is made by self (if an adult or emancipated youth), parent, guardian, or agency having custody; also, on the same basis, to provide human services to children and adults in relation to their placement in or return from the life skills and transition center, state hospital, or North Dakota youth correctional center.

14. To provide insofar as staff resources permit social services, including social-psychological evaluations, predisposition reports, treatment, and aftercare services when requested by the judge of a juvenile court. A court order under section 27-20.3-09, 27-20.4-08, or 27-20.4-17 or pursuant to rules adopted by the judicial branch regarding treatment, if available, at the state hospital or life skills and transition center shall comply with the requirements set forth in chapters 25-03.1, 25-03.3, and 25-04.

15. To provide insofar as staff resources permit social services, including social-psychological evaluations, predisposition reports, and treatment, when requested by the judge in a criminal case. A court order under section 12.1-32-02 or 12.1-32-07 or pursuant to rules adopted by the judicial branch regarding treatment, if

1 available, at the state hospital or life skills and transition center shall comply with
2 requirements set forth in chapters 25-03.1, 25-03.3, and 25-04.

3 16. To act as the official agency of the state in the administration of the supplemental
4 nutrition assistance program and to direct and supervise human service zone
5 administration of that program. The department with the consent of the legislative
6 assembly or the budget section if the legislative assembly is not in session may
7 terminate the program if the rate of federal financial participation in administrative
8 costs provided under Public Law 93-347 is decreased or limited, or if the state or

- 12 1. The department shall develop a plan for an integrated, multidisciplinary continuum of
13 services for individuals with serious and persistent mental illness. The continuum may
14 consist of an array of services provided by private mental health professionals, private
15 agencies, human service zones, ~~regional human service centers~~state-operated
16 behavioral health clinics, community-based residential care and treatment facilities,
17 and private and public inpatient psychiatric hospitals. ~~When appropriate, access to the~~
18 ~~continuum must be through regional human service centers.~~ Within the limits of
19 legislative appropriations, the plan for a continuum may include:
 - 20 a. Programs, and appropriate related facilities, to provide socialization skills.
 - 21 b. Programs, and appropriate related facilities, to provide basic living skills.
 - 22 c. Appropriate residential facilities and other housing options.
 - 23 d. Appropriate training, placement, and support to enhance potential for
24 employment.
 - 25 e. Appropriate delivery and control of necessary medication.
 - 26 f. Appropriate economic assistance.
 - 27 g. An inpatient facility with appropriate programs to respond to persons who require
28 hospitalization.
 - 29 h. Peer and recovery support.
 - 30 i. Crisis service that is available twenty-four hours a day seven days a week.

2. The continuum of care must provide that a person requiring treatment be submitted to the least restrictive available conditions necessary to achieve the purposes of treatment. The department shall ensure appropriate cooperation with human service zones and private providers in achieving the continuum of care.

SECTION 25. AMENDMENT. Section 50-06-06.13 of the North Dakota Century Code is amended and reenacted as follows:

50-06-06.13. Treatment services for children with serious emotional disorders.

1. The department shall establish a program to provide out-of-home treatment services for a Medicaid-eligible child with a serious emotional disorder. The department may not require a parent or legal guardian to transfer legal custody of the child in order to have the child placed in an out-of-home treatment program if the sole reason for the placement is the need to obtain services for the child's emotional or behavioral problems. With departmental approval, a parent with legal and physical custody or a legal guardian of the child may obtain treatment services for the child through the program. A parent without physical custody of a child, who disagrees with a child's treatment under this section, may request a judicial determination regarding the child's treatment.
2. The department may establish a program to prevent out-of-home placement for a Medicaid-eligible child with a behavior health condition as defined in the "Diagnostic and Statistical Manual of Mental Disorders", American psychiatric association, fifth edition, text revision (2013).

SECTION 26. AMENDMENT. Subsections 1 and 3 of section 50-06-15 of the North Dakota Century Code are amended and reenacted as follows:

1. Individually identifiable information concerning an individual applying for or receiving assistance or services under any program administered by or under the supervision and direction of the department is confidential, except that any such information, including an individual's social security number, may be used and disclosed:
 - a. In the administration of any such program;
 - b. In accordance with a program's participation in the department's master client index data matching system, unless prohibited by federal law;
 - c. As specifically authorized by the rules of the department; or

- 1 d. As permitted or required by other law; or
2 e. Notwithstanding confidentiality laws set forth in titles 14, 23, 25, 43, and 50 and
3 the department's rules, within and between the department's divisions to assist
4 with or to provide assistance or services under any program administered by or
5 under the supervision and direction of the department. The disclosure of
6 information under this subdivision must comply with applicable federal laws and
7 regulations.

- 8 3. As used in this section, "individually identifiable information" means information,
9 including an individual's name, address, telephone number, facsimile number, social
10 security number, electronic mail address, program identification number, protected
11 health information, personally identifiable information, or any other unique identifying
12 number, characteristic, or code, as well as demographic information collected from an
13 individual, that:

- 14 a. Is created or received by the department; and
15 b. Relates to:
16 (1) The past, present, or future assistance or services applied for or received by
17 an individual under any program administered by or under the supervision
18 and direction of the department that identifies the individual or with respect
19 to which there is a reasonable basis to believe the information can be used
20 to identify the individual; or
21 (2) A report, or any other information obtained, concerning an applicant or a
22 provider of or an individual applying for or receiving assistance or services
23 under any program administered by or under the supervision and direction
24 of the department.

25 **SECTION 27. AMENDMENT.** Section 50-06-33 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **50-06-33. Dementia care services.**

28 As used in this section, "dementia" means the condition of an individual involving loss of
29 memory and impairment of cognitive functions severe enough to interfere with the individual's
30 daily life. The department shall contract with a private provider for a dementia care services

1 program in each area of the state served by a ~~regional human service center~~state-operated
2 behavioral health clinic. The dementia care services must include:

- 3 1. Identifying available services within the region;
- 4 2. Providing information to medical professionals, law enforcement, and the public
5 regarding the symptoms of dementia, the benefits of early detection and treatment,
6 and the services available to individuals with dementia and their caregivers;
- 7 3. Assessing the needs of individuals with dementia and their caregivers;
- 8 4. Training care providers to manage and provide for the care of individuals with
9 dementia;
- 10 5. Providing consultation services to individuals with dementia and their caregivers; and
- 11 6. Facilitating the referral of individuals with dementia and their caregivers to appropriate
12 care and support services.

13 **SECTION 28. AMENDMENT.** Section 50-06-41.3 of the North Dakota Century Code is
14 amended and reenacted as follows:

15 **50-06-41.3. Behavioral health bed management system.**

- 16 1. The department shall establish and maintain a behavioral health bed management
17 system to improve utilization of behavioral health bed capacity.
- 18 2. Public and private providers of residential or inpatient behavioral health services,
19 except the department of corrections and rehabilitation and geropsychiatric facilities,
20 shall participate in and report daily.
- 21 3. Geropsychiatric facilities shall participate in and report weekly and within forty-eight
22 hours of a bed becoming available.
- 23 4. Public and private providers of residential or inpatient behavioral health services
24 required to participate in and report to the department shall provide the information
25 and documentation necessary to maintain the behavioral health bed management
26 system in the form and manner prescribed by the department, unless otherwise
27 specified.

28 **SECTION 29. AMENDMENT.** Subsection 1 of section 50-06-42 of the North Dakota
29 Century Code is amended and reenacted as follows:

- 30 1. The department shall establish and administer, within the limits of legislative
31 appropriations, a voucher system to address underserved areas and gaps in the

1 state's substance abuse treatment system and to assist in the payment of addiction
2 treatment services provided by licensed substance abuse treatment programs,
3 excluding ~~regional human service centers~~state-operated behavioral health clinics and
4 hospital- or medical clinic-based programs for medical management of withdrawal. An
5 out-of-state licensed substance abuse treatment program located within a bordering
6 state may participate in the voucher program to serve an underserved area of this
7 state pursuant to the rules adopted by the department. The department shall develop
8 rules to include processes and requirements for an out-of-state provider to receive
9 reimbursement only for outpatient and community-based services upon a provider
10 completing an assessment of need and receiving approval from the department.

11 **SECTION 30. AMENDMENT.** Subsection 1 of section 50-06-42.1 of the North Dakota
12 Century Code is amended and reenacted as follows:

- 13 1. A licensed substance abuse treatment program, excluding ~~regional human service-~~
14 ~~centers~~state-operated behavioral health clinics and hospital or medical clinic-based
15 programs for medical management of withdrawal, may apply for a competitive
16 substance use disorder treatment voucher system grant. A licensed substance abuse
17 treatment program is eligible for a one-time grant award. To receive a grant, a licensed
18 substance abuse treatment program shall:
- 19 a. Submit an application in the form and manner prescribed by the department;
 - 20 b. Enter a grant agreement with the department;
 - 21 c. Use grant funds for a licensed substance abuse treatment program with fewer
22 than seventeen beds in an underserved area, as determined by the department,
23 in the state's substance abuse treatment system;
 - 24 d. Use the grant funds to support the provision of substance use disorder treatment
25 in underserved areas of the state's substance abuse treatment system;
 - 26 e. Provide and disclose information needed to comply with the department's data
27 collection requirements; and
 - 28 f. Operate in compliance with grant requirements.

29 **SECTION 31. AMENDMENT.** Section 50-06-46 of the North Dakota Century Code is
30 amended and reenacted as follows:

50-06-46. Cross-disability advisory council - Appointment - Duties. (Expired effective August 1, 2025~~2027~~)

1. The cross-disability advisory council shall participate with and provide feedback to the department regarding the implementation, planning, and design of the cross-disability children's waiver, level of care reform for the comprehensive developmental disabilities Medicaid home and community-based waiver, and a service option that will allow payment to a legally responsible individual who provides extraordinary care to an eligible individual through the Medicaid 1915(c) waivers. This subsection does not apply to the Medicaid 1915(c) home and community-based services aged and disabled waivers.
2. The department shall contract with a qualified, independent third party to facilitate and provide support services to the council. The contracted facilitator and the department shall appoint the cross-disability advisory council members in accordance with subsection 3 and establish the length of member terms and the structure of the cross-disability advisory council. A representative from the contracted facilitator shall serve as the presiding officer of the advisory council.
3. The cross-disability advisory council consists of ~~up to~~ fifteen voting members. ~~A majority of the members of the council must be family members of individuals with a disability, or must be~~ who represent a broad range of disabilities and regions of the state. The members are:
 - a. Two individuals with a disability, who receive Medicaid home and community-based services. ~~The remaining members of the council must be appointed based on their professional subject matter expertise in or knowledge of the needs and interests of individuals with disabilities. The council's membership must represent different regions of the state and a broad range of disabilities that pertain to the Medicaid home and community-based services.;~~
 - b. One individual with a developmental disability or who is Medicaid qualified, who does not receive Medicaid home or community-based services;
 - c. Seven individuals that work with individuals with disabilities, individuals with behavioral health needs, or individuals with fetal alcohol spectrum disorder;

- 1 d. One individual representing tribal communities, with a focus on disability
2 services;
3 e. Two individuals who are parents or guardians of children under the age of
4 eighteen with disabilities; and
5 f. Two individuals who are parents or guardians of individuals age eighteen or over
6 with disabilities.

7 4. Upon request of the department, state agency representatives shall participate with
8 the cross-disability advisory council in a nonvoting role.

9 4.5. The cross-disability advisory council shall meet at least quarterly and may appoint
10 subcommittees to address specific topics or disabilities, which may include autism
11 spectrum disorder, traumatic brain injury, and fetal alcohol spectrum disorder. A
12 majority of the voting members of the council constitutes a quorum.

13 5.6. The cross-disability advisory council shall:

- 14 a. Discuss strategies to address gaps or needs regarding individuals with
15 disabilities and Medicaid home and community-based services, including
16 eligibility of legally responsible individuals;
17 b. Provide for the active participation of stakeholders, including consumers and
18 providers; and
19 c. Receive information from the department and its consultants.

20 6.7. The cross-disability advisory council members, excluding the contracted facilitator, are
21 entitled to reimbursement from the department for travel and lodging at the same rate
22 as provided for state officers and employees.

23 **SECTION 32.** A new section to chapter 50-06 of the North Dakota Century Code is created
24 and enacted as follows:

25 **Certified community behavioral health clinics - Rules.**

- 26 1. To operate in this state, a certified community behavioral health clinic must be certified
27 by the department.
28 2. The department shall adopt rules for the certification of community behavioral health
29 clinics, including assessment of need in the proposed location.
30 3. The department may deny a request to become or revoke a certified community
31 behavioral health clinic's certification based on failure to comply with the rules adopted

1 by the department or deny a request to become a certified community behavioral
2 health clinic based on the assessment of need determination.

3 **SECTION 33.** A new section to chapter 50-06 of the North Dakota Century Code is created
4 and enacted as follows:

5 **Financing of health and human services.**

- 6 1. The powers and duties carried out by the department under this title may be financed
7 out of a special fund within the state treasury to be known as the health and human
8 services operating special fund;
- 9 2. The commissioner of the department or the commissioner's designee and the state
10 treasurer shall deposit in the health and human services operating special fund, at
11 such times as they may become available;
- 12 a. All moneys received from any of the counties within the state;

22 supported by itemized vouchers must be signed by the commissioner of the
23 department or by the commissioner's designee and certified to the office of
24 management and budget.
- 25 4. Any funds received from federal agencies must be deposited and disbursed as
26 provided and in accordance with Acts of Congress or the regulations of the federal
27 agencies from which the funds were received.

28 **SECTION 34. AMENDMENT.** Section 50-06.2-01 of the North Dakota Century Code is

1 **50-06.2-01. Purpose - Interpretation.**

5 effectuate the following public purposes:

- 6 1. To help individuals or their families to achieve, maintain, or support the highest
7 attainable level of personal independence and economic self-sufficiency.

9 unable to protect their own interests.
- 10 3. To provide a continuum of community-based services adequate to appropriately
11 sustain individuals in their homes and in their communities and to delay or prevent

- 13 4. To preserve, rehabilitate, and reunite families.
- 14 5. To assist in securing referral or admission of individuals to institutional care when other
15 forms of care are not appropriate.

16 **SECTION 35. AMENDMENT.** Section 50-06.2-02 of the North Dakota Century Code is
17 amended and reenacted as follows:

18 **50-06.2-02. Definitions.**

19 As used in this chapter:

- 20 1. "Comprehensive human services" means services included in the comprehensive
21 human services plan published by the state agency and human services required by
22 state law or state agency regulation or federal law or regulation as a condition for the
23 receipt of federal financial participation in programs administered under the provisions
24 of this title.
- 25 2. "Family home care" means the provision of room, board, supervisory care, and
26 personal services to an eligible elderly or disabled person by the spouse or by one of

4 administering human services within a designated area in accordance with an
5 agreement or plan approved by the state agency.

8 ~~6.5.~~ "Human services" means:

9 a. A service or assistance provided to an individual or an individual's family in need
10 of services or assistance, including child welfare services, economic assistance
11 programs, medical service programs, and aging service programs, to assist the
12 individual or the individual's family in achieving and maintaining basic
13 self-sufficiency, including physical health, mental health, education, welfare, food
14 and nutrition, and housing.

15 b. A service or assistance provided, administered, or supervised by the department
16 in accordance with chapter 50-06.

17 c. Licensing duties as administered or supervised by the department or delegated
18 by the department to a human service zone.

20 which agrees to meet standards for service and operations established by the state
21 agency.

23 8. "State-operated behavioral health clinic" means a department-operated behavioral
24 health clinic established under section 50-06-05.2.

25 **SECTION 36. AMENDMENT.** Section 50-06.2-03 of the North Dakota Century Code is
26 amended and reenacted as follows:

27 **50-06.2-03. Powers and duties of the state agency.**

28 1. The state agency has the following powers or duties under this chapter:

29 4. a. To act as the official agency of the state in the administration of the human
30 services for individuals and families in conformity with state and federal
31 requirements.

- 1 2. b. To prepare, at least biennially, a comprehensive human services plan which

- 3 a. (1) Include human services determined essential in effectuating the purposes of

7 make available in approved human service zone plans as a condition for the

11 comprehensive human services plan on behalf of those individuals and families
12 determined to be eligible for those services under criteria established by the state
13 agency.
- 14 4. d. To supervise and direct the comprehensive human services administered by
15 human service zone and ~~human service centers~~state-operated behavioral health
16 clinics through standard-setting, technical assistance, approval of human service
17 zone and regional plans, preparation of the comprehensive human services plan,
18 evaluation of comprehensive human services, and distribution of public money

- 5 and to delay or prevent institutional care.
- 6 6- f. To take actions, give directions, and adopt rules as necessary to carry out the
- 7 provisions of this chapter.
- 8 2. For purposes of this chapter, resources do not include the individual's primary home
- 9 and the first fifty thousand dollars of liquid assets.

10 **SECTION 37. AMENDMENT.** Section 50-06.3-02 of the North Dakota Century Code is

12 **50-06.3-02. Fees for services at regional centers.**

13 The department may charge and collect fees and expenses for services provided through

14 ~~its regional human service centers~~state-operated behavioral health clinics, and may authorize

15 charging of fees for child support services. The department may establish fee scales which

16 recognize the service recipient's or responsible relative's ability to pay. The department shall

17 adopt such rules as are necessary to implement this chapter and to define terms used in this

18 chapter.

19 **SECTION 38. AMENDMENT.** Section 50-06.3-04 of the North Dakota Century Code is

20 amended and reenacted as follows:

21 **50-06.3-04. Liability for payment.**

22 The recipient, patient, recipient's or patient's estate, and recipient's or patient's spouse are

23 liable for fees and expenses for services rendered by the department, through its ~~regional-~~

24 ~~human service centers~~state-operated behavioral health clinics, and for care and treatment

25 expenses charged at the state hospital. The parents of a recipient or patient are responsible for

26 services, care, and treatment provided prior to the eighteenth birthday of the recipient or patient.

27 **SECTION 39. LEGISLATIVE MANAGEMENT STUDY - NON-OPIOID TREATMENT**

28 **OPTIONS TO REDUCE PAIN.** During the 2025-26 interim, the legislative management shall

29 consider studying options to help patients with moderate to severe pain reduce pain while safely

30 improving functional outcomes and quality of care. The study may include an examination of

31 non-opioid pharmacological treatment options and existing opioid settlement funds, and explore

- 1 options to use those funds to develop and implement an education and awareness campaign
- 2 on non-opioid treatment options. The legislative management shall report its findings and
- 3 recommendations, together with any legislation necessary to implement its recommendations,
- 4 to the seventieth legislative assembly.
