**SEN. LARSON** rose on a point of personal privilege.

**REMARKS OF SENATOR LARSON**

**MADAM PRESIDENT:** Yesterday, we voted on SB 2095, and it came out with a nay vote. It is the bill where we were going to perhaps exempt law enforcement from jury duty; specifically, criminal cases, not civic cases.

Madam President, I did not want to leave the chambers with the idea that law enforcement was unwilling to do their civic responsibility. That is not the case, and as the Senator from District 41 mentioned yesterday, officers want to serve on jury duty.

I just want to make that clear that the officers do want to; but in a criminal case where law enforcement are the ones that made the arrest, they are nearly always bumped off from the jury pool because like my colleague to my left here said, they don't want the law enforcement that made the arrest to taint the jury pool.

That was the reason for bringing this bill forward. I did not want to leave our assembly with the idea that law enforcement didn't want to do their civic duty and responsibility.
