ENGROSSED HOUSE BILL NO. 1012

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of various divisions of
2 the department of health and human services; to create and enact a new section to chapter
3 6-09 of the North Dakota Century Code, relating to an extraordinary medical needs housing
4 loan fund; to amend and reenact sections 50-06-06.6, 50-06-42, 50-24.5-02.3, and 50-33-05,
5 and subsection 1 of 50-36-03 of the North Dakota Century Code and subsection 6 of the new
6 section to chapter 54-07 of the North Dakota Century Code created in section 1 of Senate Bill
7 No. 2176, as approved by the sixty-ninth legislative assembly, relating to leases of department
8 of health and human services property, substance use disorder treatment program, basic care
9 payment rates, state of residence for child care assistance, opioid settlement advisory
10 committee, and children's cabinet; to provide for a transfer; to authorize a line of credit; to
11 provide legislative intent; to provide for a legislative management study; to provide an
12 application; to provide an exemption; to provide for a report; and to provide an effective date.

13 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

14 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
15 as may be necessary, are appropriated out of any moneys in the general fund in the state
16 treasury, not otherwise appropriated, and from other funds derived from special funds and
17 federal funds, to the department of health and human services for the purpose of defraying the
18 expenses of its various divisions, for the biennium beginning July 1, 2025, and ending June 30,
19 2027, as follows:

SECTION 3. FUNDING TRANSFERS - EXEMPTION - AUTHORIZATION - REPORT.

Notwithstanding section 54-16-04, the director of the office of management and budget shall transfer appropriation authority between line items within subdivisions 1, 2, 3, 4, 5, and 6 of section 1 of this Act and any other appropriation authority for the department of health and human services approved by the sixty-ninth legislative assembly, for the biennium beginning July 1, 2025, and ending June 30, 2027, as requested by the department of health and human services. The department of health and human services shall notify the legislative council of any transfer made pursuant to this section. The department of health and human services shall report to the budget section after June 30, 2026, any transfer made in excess of \$50,000 and to the appropriations committees of the seventieth legislative assembly regarding any transfers made pursuant to this section.

SECTION 4. FULL-TIME EQUIVALENT POSITION BLOCK GRANT PROGRAM - REPORT. Section 1 of this Act includes funding for a full-time equivalent position block grant program. This funding as approved by the sixty-ninth legislative assembly is available for defraying the expense of full-time equivalent positions as determined by the department of health and human services. Notwithstanding any other provision of law, the department is authorized to increase or decrease authorized full-time equivalent positions subject to the

1 availability of funds and the provisions of this section. The department of health and human
2 services many not increase full-time equivalent positions for the purpose of transferring human
3 service zone employees to state employment. Pursuant to section 3 of this Act, the department
4 is authorized to transfer appropriation authority of up to the underfunded amount of \$6,307,309
5 to the salaries and wages block grant line item. The department of health and human services
6 shall report to the office of management and budget and legislative council any adjustments to
7 full-time equivalent positions.

8 **SECTION 5. DEPARTMENT OF HEALTH AND HUMAN SERVICES - SALARIES AND**
9 **WAGES BLOCK GRANT - VACANT POSITIONS - REPORT.** The department of health and

10 human services shall report to the budget section quarterly during the 2025-26 interim regarding
11 the status of its salaries and wages block grant and vacant positions and employee turnover.

12 The report must include:

- 13 1. The legislative appropriation for salaries and wages allocated by the department to
14 major department programs by funding source and the number of FTE positions the
15 department is allocating to each major program based on the legislative appropriation;
- 16 2. Any changes to salaries and wages funding or FTE positions allocated to major
17 department programs;
- 18 3. Any new FTE positions added, the cost of the position for the remainder of the
19 biennium, and the cost to continue funding the position in the subsequent biennium by
20 funding source;
- 21 4. Any FTE positions removed and related funding;
- 22 5. The number of FTE positions that become vacant and the number filled each month;
- 23 6. The number of vacant FTE positions at the end of each month;
- 24 7. Salaries and wages savings resulting from vacant positions and employee turnover
25 each month by funding source; and
- 26 8. The use of salaries and wages savings for other purposes for each month by funding
27 source.

28 **SECTION 6. BEHAVIORAL HEALTH FACILITY GRANT - STRATEGIC INVESTMENT**
29 **AND IMPROVEMENTS FUND - APPLICATION.**

- 30 1. Section 1 of this Act includes the sum of \$5,000,000 from the strategic investment and
31 improvements fund for a behavioral health facility grant pursuant to this section.

1 2. The department shall require an entity receiving funding under this section to operate
2 the facility for at least ten years and require the grant amount to be repaid if the entity
3 does not operate the facility for at least ten years.

4 3. The requirements of chapter 54-44.4 do not apply to the selection of a grant recipient,
5 the grant award, or payments made under this section.

6 **SECTION 7. INFANT AND TODDLER CARE PROVIDER SUPPORT DIRECT PAYMENT -**

7 **ONE-TIME - REPORT.** Section 1 of this Act includes the sum of \$13,500,000 of one-time
8 funding from the general fund for direct payments to licensed child care providers to support
9 high-quality early childhood care for infants and toddlers. The department shall administer the
10 direct payment program and include the following provisions:

11 1. To qualify for a direct payment under this section, a direct payment recipient must:

12 a. Be a licensed child care facility within the state of North Dakota;

13 b. Be enrolled in the state's bright and early quality rating system at a two-star,
14 three-star, or four-star rating level; and

15 c. Provide care for children from birth through three years of age.

16 2. Eligible providers may receive up to \$300 per month for each child from birth through
17 seventeen months of age and up to \$180 per month for each child from eighteen
18 through thirty-six months of age.

19 3. The department shall distribute the direct payments on a quarterly basis. Direct
20 payments may not be used for non-child care-related expenses or debt repayment.

21 4. Direct payment recipients shall submit annual reports to the department detailing fund
22 usage, enrollment statistics, and other information requested by the department.

23 5. The department shall provide reports to the legislative management and to the
24 appropriations committees of the seventieth legislative assembly on direct payments
25 and the effectiveness of the program.

26 **SECTION 8. INTERMEDIATE CARE FACILITY MEDICALLY AND BEHAVIORALLY**

27 **COMPLEX SERVICES GRANT - APPLICATION.** Section 1 of this Act includes the sum of
28 \$4,400,000 of one-time funding from the community health trust fund for providing a one-time
29 grant to a licensed intermediate care facility in the south central human service region for
30 providing services to children or young adults with medically and behaviorally complex
31 conditions. To be eligible to receive the grant under this section, a licensed intermediate care

1 facility must provide early intervention, clinical, and residential services, provide community and
2 home support, education, recreation and leisure activities, and assistive technology; and
3 provide services in at least eight communities for individuals with intellectual or developmental
4 disabilities. The grant funds awarded may be used only for the costs of providing services to
5 children and young adults with medically and behaviorally complex conditions. The
6 requirements of chapter 54-44.4 do not apply to the selection of a grant recipient, the grant
7 award, or payments made under this section.

8 **SECTION 9. SPECIAL HEALTH CARE NEEDS GRANT - APPLICATION.** Section 1
9 of this Act includes the sum of \$50,000 from the general fund for providing a grant to a provider
10 in the south central human service region for statewide education, information, training, and
11 peer support to families with children with special health care needs, medically complex
12 conditions, or a disability. The requirements of chapter 54-44.4 do not apply to the selection of a
13 grant recipient, the grant award, or payments made under this section.

14 **SECTION 10. CRISIS SERVICES GRANTS - APPLICATION.** Section 1 of this Act includes
15 the sum of \$585,000 from the general fund for providing crisis services grants. The grants
16 include the sum of \$300,000 for crisis organizations that provide crisis services to young adults
17 who are at risk of being homeless or experiencing other serious adverse life events and the
18 sum of \$285,000 to a volunteer-based ecumenical ministry organization. The requirements of
19 chapter 54-44.4 do not apply to the selection of a grant recipient, the grant award, or payments
20 made under this section.

21 **SECTION 11. MEDICAL HOUSING FOR INDIVIDUALS WITH EXTRAORDINARY**
22 **MEDICAL NEEDS - ONE-TIME FUNDING.**

- 23 1. Section 1 of this Act includes the sum of \$200,000 from the general fund for the
24 preliminary design consultation and project administration of developing housing for
25 individuals with disabilities that have extraordinary medical needs and for rent
26 subsidies for individuals residing in these housing facilities, for the biennium beginning
27 July 1, 2025, and ending June 30, 2027.
- 28 2. The department of health and human services shall collaborate with the North Dakota
29 housing finance agency, individuals with disabilities, caregivers, and families to solicit
30 proposals for the development of accessible housing for individuals with disabilities
31 that have extraordinary medical needs, for the biennium beginning July 1, 2025, and

1 ending June 30, 2027. The department shall solicit proposals from public entities,
2 for-profit organizations, and nonprofit organizations to design, construct, maintain, and
3 operate the housing facility. Proposals must:

- 4 a. Ensure that services in the facility may be provided separately from the facility
5 ownership interests;
- 6 b. Ensure that individuals residing in the facility may choose among independent
7 living service providers; and
- 8 c. Comply with the federal home and community-based settings rules as defined
9 under 42 CFR 441.301(c)(4).

10 **SECTION 12. COMMUNITY CULTURAL CENTER GRANT - STRATEGIC INVESTMENT**

11 **AND IMPROVEMENTS FUND - APPLICATION.** Section 1 of this Act includes the sum of
12 \$300,000 from the strategic investment and improvements fund for the purpose of providing a
13 one-time community cultural center programming grant in the west central human service
14 region. An entity may apply for a grant under this section if the entity certifies to the department
15 the funds will be used for programs within the community cultural center. The requirements of
16 chapter 54-44.4 do not apply to the selection of a grant recipient, the grant award, or payments
17 made under this section.

18 **SECTION 13. JUVENILE JUSTICE DIVERSION SERVICES AND PROGRAMS - TASK**

19 **FORCE - REPORT.** Section 1 of this Act includes the sum of \$500,000 of one-time funding from
20 the community health trust fund for juvenile justice diversion services and programs. The
21 department of health and human services must use the funding for services to youth at risk of
22 juvenile justice involvement but who have not committed delinquent acts as defined in chapter
23 27-20.4.

24 The department shall establish a task force with representation from divisions in the
25 department, human service zones, the department of public instruction, elementary and
26 secondary schools, and members of the legislative assembly, to review juvenile justice diversion
27 services and program. The department shall report its findings and recommendations to the
28 legislative management and children's cabinet.

29 **SECTION 14. OTHER FUNDS - INSURANCE TAX DISTRIBUTION FUND.** The other

30 funds line item in subdivision 5 of section 1 of this Act includes the sum of \$1,125,000 from the
31 insurance tax distribution fund for rural emergency medical services grants.

1 **SECTION 15. OTHER FUNDS - COMMUNITY HEALTH TRUST FUND.** The other funds
2 line items in section 1 of this Act includes the sum of \$41,431,522 from the community health
3 trust fund for the following purposes:

23 **SECTION 16. OTHER FUNDS - HUMAN SERVICE FINANCE FUND.** The other funds line
24 items in section 1 of this Act includes the sum of \$242,112,030 from the human service finance
25 fund for state-paid economic assistance and social and human services.

26 **SECTION 17. OTHER FUNDS - OPIOID SETTLEMENT FUND.** The other funds line item in
27 section 1 of this Act includes the sum of \$8,000,000 from the opioid settlement fund for opioid
28 remediation and abatement efforts.

29 **SECTION 18. OTHER FUNDS - STRATEGIC INVESTMENT AND IMPROVEMENTS**
30 **FUND** The other funds line items in section 1 of this Act includes the sum of \$18,446,784 from
31 the strategic investment and improvements fund for the following purposes:

10 **SECTION 19. OTHER FUNDS - BANK OF NORTH DAKOTA LINE OF CREDIT - CHILD**

11 **WELFARE TECHNOLOGY PROJECT.** The other funds line item in subdivision 2 of section 1 of
12 this Act includes the sum of \$8,411,218 from a Bank of North Dakota line of credit. The
13 department of health and human services may borrow up to \$8,411,218 through a line of credit
14 from the Bank of North Dakota during the biennium beginning July 1, 2025, and ending
15 June 30, 2027, for costs associated with a child welfare technology project. The interest rate on
16 the line of credit may not exceed the prevailing interest rate charged to North Dakota
17 governmental entities. If the department accesses the line of credit, it shall request a deficiency
18 appropriation from the seventieth legislative assembly to repay the line of credit.

19 **SECTION 20. LABORATORY BUILDING STEERING COMMITTEE.** The department of

20 health and human services shall maintain the laboratory building steering committee to oversee
21 the design and construction of the laboratory building project, for the biennium beginning July 1,
22 2025, and ending June 30, 2027, or until work is completed, whichever occurs earlier. The
23 committee must include representation from the department of health and human services,
24 department of environmental quality, office of management and budget, the governor's office,
25 and the legislative assembly. The legislative assembly representation must include one member
26 of the senate appointed by the senate majority leader, one member of the house appointed by
27 the house majority leader, and one member of the minority party from either the senate or the
28 house appointed by the minority leaders of the senate and the house.

29 **SECTION 21. NEW STATE HOSPITAL - STEERING COMMITTEE.** The department of

30 health and human services shall establish a new state hospital facility steering committee to
31 oversee the design and construction of a new state hospital facility, for the biennium beginning

1 July 1, 2025, and ending June 30, 2027. The committee must include representation from the
2 department of health and human services, office of management and budget, the governor's
3 office, and the legislative assembly. The legislative assembly representation must include one
4 member of the senate appointed by the senate majority leader, one member of the house
5 appointed by the house majority leader, and one member of the minority party from either the
6 senate or the house appointed by the minority leaders of the senate and the house.

7 **SECTION 22. CAPITAL PAYMENTS.** During the biennium beginning July 1, 2025, and
8 ending June 30, 2027, the department of health and human services is authorized to expend
9 funds for the payment of special assessments at the state hospital, southeast human service
10 center, and life skills and transition center. Pursuant to section 3 of this Act, the director of the
11 office of management and budget may transfer appropriation authority between line items within
12 section 1 of this Act and any remaining appropriation authority for the department of health and
13 human services approved by the sixty-ninth legislative assembly. The department of health and
14 human services may transfer funds for the payment of special assessments at the state
15 hospital, southeast human service center, and life skills and transition center ahead of the
16 special needs assessments schedule. Notwithstanding section 54-27-12, the department of
17 health and human services may spend funds for the payment of special assessments at the
18 state hospital and life skills and transition center.

19 **SECTION 23. CAPITAL PROJECTS - EMERGENCY COMMISSION AND BUDGET**

20 **SECTION APPROVAL.** During the biennium beginning July 1, 2025, and ending June 30, 2027,
21 pursuant to section 3 of this Act, the director of the office of management and budget may
22 transfer appropriation authority between line items within section 1 of this Act and any remaining
23 appropriation authority for the department of health and human services approved by the sixty-
24 ninth legislative assembly for capital projects and maintenance pertaining to operation of its
25 facilities, including demolition projects. Notwithstanding section 54-27-12, the department of
26 health and human services may spend up to \$10,000,000 for capital projects and maintenance
27 pertaining to operation of its facilities, including demolition projects, under this section and may
28 seek emergency commission and budget section approval to spend more than \$10,000,000
29 under this section.

30 **SECTION 24. PERMANENT SUPPORTIVE HOUSING GRANTS.** Section 1 of this Act
31 includes the sum of \$4,672,536 from the general fund for permanent supportive housing grants.

1 The department of health and human services shall develop a funding methodology to distribute
2 the funding to qualified entities that utilize best practices for permanent supportive housing,
3 provide recovery-oriented and person-centered services, submit process and outcome
4 measures to the department of health and human services, and authorize the department of
5 health and human services to conduct onsite visits to review program operations.

6 **SECTION 25. EXPENDITURES MAY NOT EXCEED APPROPRIATION - MEDICAL**
7 **ASSISTANCE EXPANSION PROGRAM - APPLICATION.**

- 8 1. Section 1 of this Act includes the sum of \$662,099,340, of which \$66,209,934 is from
9 the general fund, for the medical assistance expansion program, for the biennium
10 beginning July 1, 2025, and ending June 30, 2027. The expenditures for individuals
11 eligible for the medical assistance expansion program may not exceed this amount.
- 12 2. The department of health and human services may exceed appropriations for
13 increases in medical assistance expansion program caseload, for the addition of
14 coverage consistent with the traditional Medicaid 1915(i) state plan, utilization rates,
15 and reduction in federal medical assistance percentage.
- 16 3. The managed care organization under contract with the department of health and
17 human services to manage the medical assistance expansion program shall reimburse
18 providers within the same provider type and specialty at consistent levels and with
19 consistent methodology and may not provide incentive, quality, or supplemental
20 payments to providers, unless part of a value-based program approved by the
21 department of health and human services. The managed care organization shall
22 reimburse all North Dakota substance use providers of American society of addiction
23 medicine level 2.5 at consistent levels and with consistent methodology. The managed
24 care organization may consider urban and rural providers as different provider types.
- 25 4. The managed care organization and the department of health and human services
26 shall ensure payments to Indian or Tribal 638 health care providers, federally qualified
27 health centers, and rural health clinics meet the federally required minimum levels of
28 reimbursement. Critical access hospitals may not be paid less than one hundred
29 percent of Medicare allowable costs and human service centers may not be paid less
30 than one hundred percent of the current traditional Medicaid rate. Behavioral health
31 services involving partial hospitalization, intensive outpatient, professional services,

1 and residential behavioral health services provided in facilities that are not institutions
2 for mental diseases are not subject to the provisions in subsection 6.

3 5. The department of health and human services shall ensure providers within the same
4 provider type and specialty are reimbursed at consistent levels and with consistent
5 methodology and shall ensure the capitation rates under risk contracts are actuarially
6 sound and are adequate to meet managed care organization contractual requirements
7 regarding availability of services, assurance or adequate capacity and services, and
8 coordination and continuity of care.

9 6. Except for the provisions in subsection 4, managed care organization premium
10 payments must be built using the assumption that rates paid to providers under the
11 medical assistance expansion program may not exceed one hundred forty-five percent
12 of Medicare reimbursement rates paid to providers on January 1, 2025.

13 **SECTION 26. HUMAN SERVICE CENTERS - CERTIFIED COMMUNITY BEHAVIORAL**
14 **HEALTH CLINICS - FULL-TIME EQUIVALENT POSITIONS - REPORT.** The department of
15 health and human services shall continue the process of the human service centers becoming a
16 certified community behavioral health clinic to provide continuous community-based behavioral
17 health services for children and adults. The department of health and human services shall
18 pursue additional federal funding as available. Subject to the availability of generated income,
19 the department of health and human services may add full-time equivalent positions for the
20 clinics to provide direct services for the period beginning with the effective date of this Act and
21 ending June 30, 2027. The department of health and human services shall report to the office of
22 management and budget and legislative council each time a position is added.

23 **SECTION 27. INTERMEDIATE CARE FACILITY MORATORIUM.** The department of health
24 and human services may not add any new licensed intermediate care facility for individuals with
25 intellectual disabilities beds to the state's licensed bed capacity between July 1, 2025, and
26 June 30, 2027.

27 **SECTION 28. EXEMPTION - UNEXPENDED APPROPRIATIONS.** The following
28 appropriations are not subject to the provisions of section 54-44.1-11 and any unexpended
29 appropriation authority may be continued into the biennium beginning July 1, 2025, and ending
30 June 30, 2027:

- 14 5. The sum of \$4,150,000 appropriated from the general fund for defraying the expenses
15 of additional human service centers to begin the process of becoming a certified
16 community behavioral health clinic to provide continuous community-based behavioral
17 health services for children and adults in chapter 44 of the 2023 Session Laws;
- 18 6. The sum of \$18,941,847 appropriated to the department of health and human services
19 in chapter 549 of the 2021 Special Session Laws;
- 20 7. The sum of \$55,120,000 appropriated from the federal state fiscal recovery fund for a
21 public health laboratory capital project in chapter 4 of the 2023 Session Laws;
- 22 8. The sum of \$1,000,000 appropriated from the general fund for the purpose of
23 employer-led child care cost-share program in chapter 446 of the 2023 Session Laws;
- 24 9. The sum of \$986,555 appropriated from the general fund for the purpose of
25 streamlining background checks project in chapter 446 of the 2023 Session Laws;
- 26 10. The sum of \$1,000,000 appropriated from the federal state fiscal recovery fund for the
27 implementation of a virtual behavioral health crisis care program for rural law
28 enforcement in chapter 44 of the 2023 Session Laws; and
- 29 11. The sum of \$500,000 appropriated from the general fund and the sum of \$500,000
30 appropriated from federal funds for the purpose of program integrity audits in
31 chapter 44 of the 2023 Session Laws.

1 12. The sum of \$1,950,000 appropriated from the general fund to the department of health
2 and human services for a northwest human service region behavioral health facility
3 grant in chapter 44 of the 2023 Session Laws.

4 **SECTION 29. LEGISLATIVE INTENT - UTILIZATION RATE ADJUSTMENT.** It is the intent
5 of the sixty-ninth legislative assembly that the department of health and human services seek a
6 deficiency appropriation from the seventieth legislative assembly for any expenditures that
7 exceed appropriated amounts as a result of underfunding, utilization rates, value-based
8 purchasing for nursing facilities, reduction in federal medical assistance percentage, and
9 unexpected contract cost increases that exceed ten percent, during the biennium beginning
10 July 1, 2025, and ending June 30, 2027, if funding is not sufficient to pay actual expenses.

11 **SECTION 30. LEGISLATIVE INTENT - PROVIDER RATE INCREASE.** Except as
12 otherwise noted, section 1 of this Act includes funding for human service provider inflation
13 increases of two percent for the first year and one and one-half percent the second year of the
14 biennium beginning July 1, 2025, and ending June 30, 2027. The provider inflation increase in
15 this section does not apply to nursing facilities.

16 **SECTION 31. LEGISLATIVE INTENT - MEDICAL ASSISTANCE.** It is the intent of the
17 sixty-ninth legislative assembly that the department of health and human services review the
18 amount, duration, coverage, utilization rates, medical necessity, and scope of medical
19 assistance services, and report any findings and recommendations to the seventieth legislative
20 assembly.

21 **SECTION 32. FEDERAL FUNDING APPEAL LIMITATION.** Except as otherwise
22 specifically provided by federal law, a person may not appeal a denial, revocation, reduction in
23 services or payment, or the termination of a program or service by the department of health and
24 human services due to the unavailability of federal coronavirus funding received under federal
25 law resulting from the federal coronavirus pandemic emergency declarations, for the biennium
26 beginning July 1, 2025, and ending June 30, 2027.

27 **SECTION 33. DEPARTMENT OF HEALTH AND HUMAN SERVICES - LONG-TERM**
28 **STRUCTURED RESIDENCES PLAN - REPORT.** During the 2025-26 interim, the department of
29 health and human services shall review options and develop a plan to establish long-term
30 structured residences. The department shall review necessary changes to statutes, rules,
31 policies, and the estimated fiscal impact of establishing the residences. A long-term structured

1 residence must be a highly structured therapeutic residential mental health treatment facility
2 that is staffed continuously and designed to treat adults under chapters 12.1-04.1 and 25-03.1
3 who have severe and persistent mental illness and who have reached the maximum benefit
4 from the mental health resources available elsewhere in the community or hospital. The
5 department shall present a report to the legislative management by October 1, 2026, regarding
6 its plan to establish long-term structured residences.

7 **SECTION 34.** A new section to chapter 6-09 of the North Dakota Century Code is created
8 and enacted as follows:

9 **Extraordinary medical needs housing loan fund - Continuing appropriation.**

- 10 1. The Bank of North Dakota shall administer a loan program to provide loans for new
11 construction projects to provide housing for individuals with disabilities that have
12 extraordinary medical needs. A construction project may include a land purchase and
13 the construction costs of the project. The applicant must comply with project
14 requirements as approved by the department of health and human services and the
15 North Dakota housing finance agency.
- 16 2. The extraordinary medical needs housing loan fund is a special fund maintained in the
17 state treasury from which the Bank shall provide loans under this section. The fund
18 consists of revenues transferred under legislative authorization, interest upon moneys
19 in the fund, and collections of interest and principal on loans made from the fund. All
20 moneys in the fund are appropriated on a continuing basis to the Bank for the purpose
21 of providing loans under this section.
- 22 3. The developer of the housing facility for individuals with disabilities that have
23 extraordinary medical needs may submit an application to the Bank for a loan. The
24 application must:
- 25 a. Provide detail on the proposed construction project and its compliance with the
26 department of health and human services and the North Dakota housing finance
27 agency requirements;
- 28 b. Demonstrate the need and long-term viability of the project; and
- 29 c. Include financial information the Bank determines appropriate to verify eligibility.
- 30 4. A loan approved under this section:
- 31 a. May not exceed three million three hundred thousand dollars for a project;

- 1 **b.** Must have an interest rate that does not exceed two percent; and
2 **c.** Must have a repayment schedule of no longer than twenty years.
3 **5.** A recipient of a loan under this section shall complete the financed construction project
4 within twenty-four months of the approval of the loan. Failure to comply with this
5 subsection may result in forfeiture of the entire loan received under this section.
6 **6.** The Bank shall deposit in the fund all principal and interest paid on the loans made
7 from the fund. The Bank may deduct from interest payments a service fee for costs of
8 administering the loan program. The fund must be audited annually pursuant to
9 section 6-09-29 and the cost of the audit and any other actual costs incurred by the
10 Bank on behalf of the fund must be paid from the fund.

11 **SECTION 35. AMENDMENT.** Section 50-06-06.6 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **50-06-06.6. Department may lease real and personal property.**

14 The commissioner of the department or commissioner's designee may lease surplus farm-
15 and pastureland at the state hospital and the life skills and transition center. The commissioner-
16 or designee also may enter into further leases of real or personal property at the life skills and
17 transition center or the state hospital upon a specific finding that the granting of each such
18 leasehold interest will result in a net economic gain for the department, taking into account all
19 identifiable costs. Any lease of space for the purpose of providing child care services must meet
20 requirements as determined by the department. The commissioner of the department or
21 commissioner's designee may prescribe the terms and conditions of any leases entered into
22 pursuant to this section and may renew existing leases. ~~Any~~The term of any lease entered into
23 ~~must be subject to renewal or cancelable each biennium~~may not exceed ninety-nine years.

24 **SECTION 36. AMENDMENT.** Section 50-06-42 of the North Dakota Century Code is
25 amended and reenacted as follows:

26 **50-06-42. Substance use disorder treatment voucher system - Mental health**
27 **treatment voucher system for incarcerated individuals.**

28 4. The department shall establish and administer, within the limits of legislative
29 appropriations, a voucher system to address underserved areas and gaps in the state's
30 substance abuse treatment system and to assist in the payment of addiction treatment services
31 and medical costs provided by licensed substance abuse treatment programs, excluding

1 regional human service centers and hospital- or medical clinic-based programs for medical
2 management of withdrawal.

3 1. An out-of-state licensed substance abuse treatment program located within a
4 bordering state may participate in the voucher program to serve an underserved area
5 of this state pursuant to the rules adopted by the department. The department shall
6 develop rules to include processes and requirements for an out-of-state provider to
7 receive reimbursement only for outpatient and community-based services upon a
8 provider completing an assessment of need and receiving approval from the
9 department.

10 2. Services eligible for the voucher program include only those levels of care recognized
11 by the American society of addiction medicine, with particular emphasis given to
12 underserved areas and programs. The department shall ensure that a licensed
13 substance abuse treatment program, hospital, and medical clinic program accepting
14 vouchers collects and reports process and outcome measures.

15 3. The department shall develop requirements and provide training and technical
16 assistance to a licensed substance abuse treatment program, hospital, and medical
17 clinic program accepting vouchers. A licensed substance abuse treatment program,
18 hospital, and medical clinic program accepting vouchers shall provide evidence-based
19 services.

20 4. The department shall allocate funding appropriated for the substance use disorder
21 treatment voucher as follows:

22 a. ~~No~~

23 a. Except as provided in subdivisions c and d, no more than ~~forty-five~~fifty percent of
24 the appropriated amount may be allocated for residential substance use disorder
25 services administered by licensed substance abuse treatment programs with
26 more than sixteen beds.

27 b. The remaining appropriation must be allocated for residential programs with
28 sixteen or fewer beds, nonresidential outpatient, and ancillary substance use
29 disorder services administered by licensed substance abuse treatment programs.

- 1 c. The department, during the last quarter of the biennium, may reallocate projected
2 unused funds that were allocated under paragraph 2 to residential facilities
3 outlined in paragraph 1.
- 4 d. The department may reimburse a licensed substance abuse treatment program
5 with more than sixteen beds the incurred direct medical costs of an eligible
6 individual who does not have resources to cover the medical costs. The
7 department may develop rules and may not exceed the total amount
8 appropriated for medical cost reimbursement.

9 **SECTION 37. AMENDMENT.** Section 50-24.5-02.3 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **50-24.5-02.3. Basic care payment rates.**

- 12 1. The department shall determine limits for the care of residents of basic care facilities
13 that qualify as vendors of an aged, blind, and disabled persons program and for
14 implementing provisions of this chapter based on data demonstrating the most recent
15 costs that must be incurred for the care of residents in efficiently and economically
16 operated basic care facilities. The department shall determine the limits every four
17 years by July first, beginning with July 1, 2023.
- 18 2. The department shall establish the limits by using the median rates from the most
19 recent data available. The direct care limit must be the median plus eighteen percent.
20 The indirect care limit must be the median plus twelve percent.
- 21 3. For the rate year beginning July 1, 2023, the department shall increase rates and
22 limits three and one-half percent for inflation. For the rate year beginning July 1, 2024,
23 the department shall increase rates and limits three and one-half percent for inflation.
- 24 4. The department shall provide a rate increase in the amount of five dollars per day for
25 the period beginning July 1, 2023, and ending June 30, ~~2025~~2027, after which the
26 increase is not effective. This rate increase may not be included in any calculation of
27 inflation increase.
- 28 5. Within the limits of legislative appropriations, the department shall establish an
29 uncompensated care expense of three hundred sixty-five days.

30 **SECTION 38. AMENDMENT.** Section 50-33-05 of the North Dakota Century Code is
31 amended and reenacted as follows:

1 **50-33-05. State of residence.**

2 Only child care assistance units physically residing within the boundaries of the state are
3 eligible for child care assistance, unless the individual is employed by an early childhood
4 program within the boundaries of the state and the individual has been approved for the state's
5 child care assistance child care workforce benefit.

6 **SECTION 39. AMENDMENT.** Subsection 1 of section 50-36-03 of the North Dakota
7 Century Code is amended and reenacted as follows:

8 1. The committee is composed of:

- 9 a. One member of the North Dakota association of counties appointed by the
10 chairman of the legislative management, who shall serve a term of two years.
- 11 b. One member of the North Dakota league of cities appointed by the chairman of
12 the legislative management, who shall serve a term of two years.
- 13 c. One member of the North Dakota state association of city and county health
14 officials appointed by the chairman of the legislative management, who shall
15 serve a term of two years.
- 16 d. One member who represents the highway patrol appointed by the highway patrol
17 superintendent, who shall serve a term of two years.
- 18 e. The executive director of the department's division of behavioral health.
- 19 f. ~~The managing director of the office of recovery reinvented~~One member in
20 recovery appointed by the governor.
- 21 g. One member appointed by the governor who shall serve as a nonvoting member
22 and as the presiding officer of the committee, who shall serve a term of two
23 years.

24 **SECTION 40. AMENDMENT.** Subsection 6 of the new section to chapter 54-07 of the North
25 Dakota Century Code, as created by section 1 of Senate Bill No. 2176, as approved by the
26 sixty-ninth legislative assembly, is amended and reenacted as follows:

- 27 6. a. The office of the governor shall provide staffing and administrative services for
28 the children's cabinet and coordinate with other designated working groups on
29 children and family issues.

- 1 b. The governor or the governor's designee serving on the cabinet may appoint a
2 representative to serve in that official's capacity at a meeting if the governor or
3 governor's designee is unable to attend.

4 **SECTION 41. HOUSING AVAILABILITY ASSESSMENT - COLLABORATION WITH**
5 **HOUSING FINANCE AGENCY.** The department of health and human services shall collaborate
6 with the North Dakota housing finance agency and other appropriate stakeholders to assess the
7 availability of housing for individuals requiring extraordinary health care support services, for the
8 biennium beginning July 1, 2025, and ending June 30, 2027. Based on the results of the
9 assessment, if necessary, the department shall develop a plan to expand access to housing
10 providing the least restrictive environment for individuals requiring extraordinary health care
11 support services.

12 **SECTION 42. BEHAVIORAL HEALTH CLINICS, NORTH DAKOTA STATE HOSPITAL,**
13 **AND LIFE SKILLS AND TRANSITION CENTER FUNDING.** Section 1 of this Act includes
14 funding for the behavioral health clinics, North Dakota state hospital, and life skills and transition
15 center as follows:

28 **SECTION 43. LEGISLATIVE MANAGEMENT STUDY - STUDENT TRUANCY AND**
29 **ABSENTEEISM.** The legislative management shall consider studying, during the 2025-26
30 interim, truancy and student absenteeism in kindergarten through grade twelve public schools.

1 The legislative management shall report its findings and recommendations, together with any
2 legislation necessary to implement its recommendations, to the seventieth legislative assembly.

3 **SECTION 44. LEGISLATIVE MANAGEMENT STUDY - OBESITY HEALTH**

4 **IMPLICATIONS.** The legislative management shall consider studying, during the 2025-26
5 interim, the health implications of obesity on the residents of the state and options to increase
6 access to prevention and treatments for obesity. If conducted, the study must review costs
7 associated with obesity including comorbidities, treatments available for obesity, obesity
8 diagnosis guidelines including use of body mass index compared with percentage of body fat,
9 and examining the difference between being an individual who is healthy and overweight as
10 compared to an obese individual. The legislative management shall report its findings and
11 recommendations, together with any legislation necessary to implement its recommendations,
12 to the seventieth legislative assembly.

13 **SECTION 45. LEGISLATIVE MANAGEMENT STUDY - MATERNAL HEALTH**

14 **SERVICES - ACCESS AND WORKFORCE.**

- 15 1. During the 2025-26 interim, the legislative management shall consider studying
16 access to maternal health services. The study must include:
- 17 a. Consideration of the availability of prenatal and childbirth services, including
18 provider shortages and service use.
 - 19 b. Development of strategies to increase the number of obstetricians, family
20 doctors, and midwives providing maternal health services in this state.
 - 21 c. A review of coverage and reimbursement for doulas and midwives, including
22 training and certification needs.
 - 23 d. Consideration of insurance and public policy options to improve maternal health
24 outcomes, including through the Medicaid program.
 - 25 e. Input from health care providers, insurers, public health officials, and maternal
26 health experts.
- 27 2. The legislative management shall report its findings and recommendations, together
28 with any legislation necessary to implement its recommendations, to the seventieth
29 legislative assembly.

30 **SECTION 46. LEGISLATIVE INTENT - LIFE SKILLS AND TRANSITION CENTER.** It is the
31 intent of the sixty-ninth legislative assembly that during the 2025-26 interim, the department of

1 health and human services review the facilities and land at the life skills and transition center to
2 identify the portions of the life skills and transition center campus that are necessary for delivery
3 of services and the portions of the campus that could be conveyed to a local government or
4 related public or not-for-profit community development entity to redevelop to optimize local
5 community development goals and the successful operation of the life skills and transition
6 center. It is further the intent of the legislative assembly that the department of health and
7 human services present any request to convey any portions of the campus to the seventieth
8 legislative assembly.

9 **SECTION 47. DISABILITY SERVICE ACCREDITATION STUDY - LEGISLATIVE**

10 **MANAGEMENT REPORT.** During the 2025-26 interim, the department of health and human
11 services shall study accreditation requirements and provider costs for serving individuals with
12 intellectual and developmental disabilities, including the cost of accreditation relative to the cost
13 of providing services and reimbursement. The department shall report its findings and
14 recommendations, together with any legislation necessary to implement recommendations to
15 the legislative management by September 1, 2026.

16 **SECTION 48. VALUE-BASED CARE INCENTIVE PROGRAM - PAYMENT WITHHOLD**
17 **FOR NURSING FACILITIES - COLLABORATION WITH NORTH DAKOTA LONG TERM**

18 **CARE ASSOCIATION.** During the 2025-26 interim, the department of health and human
19 services, in collaboration with the North Dakota long term care association, shall develop a
20 payment withhold structure for value-based payments to provide funding for the value-based
21 care incentive program for nursing facilities. The department shall implement the payment
22 withhold beginning July 1, 2027. The department may not implement a payment withhold before
23 July 1, 2027.

24 **SECTION 49. LEGISLATIVE MANAGEMENT STUDY- DISABILITY SERVICES.**

- 25 1. During the 2025-26 interim, the legislative management shall study the efficiency,
26 effectiveness, and outcomes of developmental disability services provided by the
27 department of health and human services. The study must include:
- 28 a. A review of the approval process, an analysis of accountability measures, an
29 assessment of gaps in services, and an evaluation of overall program
30 management.

- 1 b. An assessment of whether the department is effectively managing cases and
- 2 complying with federal law in the provision of support and services to individuals
- 3 with disabilities.
- 4 c. Input from advocates, clients from the disability community, zone directors,
- 5 service providers, and health care providers who serve individuals with
- 6 disabilities.
- 7 d. Collaboration with the cross-disability advisory council.
- 8 2. The legislative council may contract with a consultant with expertise in the provision of
- 9 developmental disability services to assist in the study.
- 10 3. The legislative management shall report its findings and recommendations, together
- 11 with any legislation necessary to implement its recommendations, to the seventieth
- 12 legislative assembly.

13 **SECTION 50. APPROPRIATION - COMMUNITY HEALTH TRUST FUND - LEGISLATIVE**
14 **COUNCIL - DISABILITY SERVICES - ONE-TIME FUNDING.** There is appropriated out of any
15 moneys in the community health trust fund, not otherwise appropriated, the sum of \$150,000, or
16 so much of the sum as may be necessary, to the legislative council for the purpose of
17 contracting for consulting services for a disability services study, for the biennium beginning
18 July 1, 2025, and ending June 30, 2027. The appropriation in this section is considered a
19 one-time funding item.

20 **SECTION 51. LEGISLATIVE MANAGEMENT REPORT - BEHAVIORAL HEALTH**
21 **FACILITY GRANTS.** During the 2025-26 interim the department of health and human services
22 shall provide reports to the legislative management regarding the award of grant funding to
23 increase the number of behavioral health beds in the state.

24 **SECTION 52. EFFECTIVE DATE.** Section 36 of this Act becomes effective on July 1, 2026.

25 **SECTION 53. EFFECTIVE DATE.** Section 7 of this Act becomes effective on January 1,
26 2026.
