HB 1014 - Industrial Commission Budget

Request for additional Housing Incentive Funds to be available if SIIF bucket fills throughout the biennium. As has been demonstrated, based on project applications in previous biennia there is much more need for affordable housing development and rehabilitation than Housing Incentive Funds available.

Including trigger language gives a signal to the market that funding may be available, and communities should plan accordingly. **This would greatly benefit rural communities and smaller projects** to give them time to put something together and compete as each funding round occurs. It also allows funds to get out the door to align with cheaper building costs than waiting for another legislative session.

Proposed language:

- **\$25 million** is available only if the state treasurer certifies to the office of management and budget that oil and gas tax revenue allocations to the strategic investment and improvements fund under section 57-51.1-07.5 have exceeded **\$420,000,000** during the 2025-27 biennium. The appropriation in this section is considered a one-time funding item.

 NDCHP membership recommended the reallocation to ensure local control, meet community needs, remedy landlord relationships
 NDCHP lobbyist requested this reallocation to streamline homeless/housing/rental funding within one state agency
 NDHFA will grant the \$13.5 Million out to agencies across the state
 House Appropriations HR Division supported the reallocation due to DHHS capacity/focus on current programs
 Governor Armstrong is supportive of the reallocation to NDHFA

Comment Senate had kept \$500,000 in HB 1012 as a placeholder to ensure that the funding was reallocated to SB 2014

In the 2024 NDHG application round there were 25 applications for a total of:

\$2,885,349 requested
\$909,115 available
 \$1,976,234 over-subscription

2023/2024 combined = \$5,710,737 in requests, \$3,671,622 more than available.

The Emergency Solutions Grant (ESG) is a federal grant for the same activities as NDHG.

In the 2023 ESG application round there were 23 applications for a total of:

\$565,007 available
 \$1,467,328 over-subscription

In the 2024 ESG application round there were 21 applications for a total of:

\$2,190,403 requested
\$881,870 available
 \$1,308,533 over-subscription

2023/2024 combined = \$4,222,738 in requests, \$2,775,861 more than available.

In 2023/2024 combined there were \$9,933,475 in requests for NDHG & ESG.

The Continuum of Care (CoC) is another federal grant for people exiting homelessness with medium-to-long term support (e.g. transitional housing, rapid rehousing, permanent supportive housing), which is also administered by NDHFA. In 2024 alone there were \$5,719,695.00 in requests, **\$1,770,115 more** than the \$3,949,579 available.
