Mr. Chairman Klemin and the members of the House Judiciary Committee,

My name is Sara Planteen, I am the mother of 3 children who were up until recently enrolled in one of North Dakota's public schools, and I am here today to testify in support of SB2307. I am here to ask you to protect my children and all the children in ND and their innocence. We live in a world where it is more important to belong, then it is to do what is right for our children and God.

In August my children came home from Sargent Central Public School in Forman and told me the school had a new book series that we had recently seen at a book store and discussed with our children it wasn't appropriate for them to read. This new book series is written below a middle school reading level and is a cartoon book that is said to be for grades 9-12. The summaries on booklooks.org state it contains self harm, gender ideologies, explicit sexual activities, alcohol use by minors, profanity, derogatory terms and alternate sexualities. Book 5 even has a content warning. It was on the front display when you came into the library and accessible for all grades PreK-12. After verifying the books were indeed on the front display and accessible to all students prek-12 we asked the librarian to move the books to a more age appropriate area, but were told no. A conversation with the principal and superintendent got me nowhere. School board policy states a request for reconsideration should be filed. I filed that on October 11th. My request for review was passed around the school for staff to read. Some staff then sent a statement to the school board members stating there was nothing wrong with the books in question, before some school board members even knew what was going on. Finally on October 30th, 13 business days later, after everyone else was done reading it, scheduled a special meeting to appoint a committee. School board policy states, the board shall appoint a curriculum review committee annually before the commencement of the school year, that being in July. When I looked at the annual meeting minutes 2 school board members were selected for this committee, the committee may include the following, but not required. But it clearly is stated that you **HAVE TO APPOINT** the committee **before** the commencement of the school year. Why would we need to appoint a review committee now in October AFTER the complaint had been filed. Clearly it didn't fit the agenda, so the superintendent hand-picked committee members that included teachers and staff that had already signed a statement saying there was nothing wrong with the books. Do you think my request was given a fair and unbiased review if people reviewing it already wrote a statement saying there was nothing wrong with the books? School board policy was clearly not followed. I keep hearing "this is a parent problem" & parents need to be monitoring what their kids are reading. How many parents that send their children to a public school are privileged enough to be able to take time off to go to the school library with their children during their designated library time during the school day? What if they have multiple children? I feel public schools should be held to a higher standard. You are using tax payer dollars to supply a teacher and books.

On November 13th I presented the school board with a petition that had 228 signatures requesting the book series be removed and school policies updated as they haven't been updated in 10 years. Not just an individual, 228 signatures. Just a few years ago only 29 people showed up to vote for the school board, 228 signatures is substantial. The staff rallied up students to attend to hold up signs, some students going against parents consent. One school board member stated everyone in the building said it should be here. Do parents, community members and tax

payers not get a say anymore only teachers, staff and administration? An elementary teacher stated on behalf of the teachers and staff they only saw illustrations of kissing, cuddling, hand holding and people in bed together but nothing showing graphic or erotic behavior and if an elementary student finds the book they are violating school board policy. There was no need for the kids to find the books, they were put right in front of them. Multiple parents with students as young as 8 years old came forward and said their child had checked out the books or looked at them in the library. Why would the school even have books that would violate school board policy if a student found it? Ultimately that night the Sargent Central Public School board did nothing with my review for reconsideration or the petition. Clearly community input is not valued when it does not match the administration's opinion.

Parents have the right to expect that schools will act in the best interest of their children. When schools fail to follow their own policies, when they dismiss parental concerns, then it is the duty of our elected officials to step in and ensure that order and accountability are restored.

I have included the school board policies referenced, school board minutes, Booklooks.org summary, and pictures from the book for you to make a decision on actual information, not someone's opinion.

I urge a DO PASS on Senate Bill 2307. Thank you. I stand for questions.

# PROCEDURE FOR REVIEWING COMPLAINTS ABOUT INSTRUCTIONAL/RESOURCE MATERIAL

#### **Review Committee**

The Board· shall appoint a curriculum review committee annually before the commencement of the school year. The committee may be included of the following individuals:

- A media specialist;
- 2. A teacher from each educational level serviced by district schools as selected by the Superintendent;
- 3. A parent or parents;
- The principal(s);
- 5. The Superintendent
- School board members as assigned

The committee may obtain the assistance of individuals with expertise in an area/subject that comes before the committee for review and may hold a public forum to receive community input when instructional or resource material is contested.

#### **Review Procedure**

When a complaint or request for review of instructional material is made, the following procedure shall be followed:

- The building principal shall require the complainant to complete a Request for Reconsideration of Instructional/Resource Material form.
- The building principal shall submit the completed form to the Superintendent who shall call the review committee meeting to initiate the review process as soon as practicable.
- 3. If the item being contested is a library book, the item may be placed on reserve in the library during the review process, requiring parental permission to check out. If the review relates to curricular material, the principal shall be responsible for issuing notice to parents of the instructional material under review and provide parents the option of electing an alternative assignment for their children during the course of the review process.
- Review committee members shall read/view/listen to all or a substantial portion of the contested material.
- The review committee shall generate a report of recommendations.
   Recommendations to remove or restrict access to material must be based on the following criteria:
  - a. The material is pervasively vulgar.
  - b. The material is not educationally suitable.
  - c. The material is not age-appropriate.
  - d. The material is part of the curriculum and forces students to profess or deny a belief in what they are reading or engage or refrain from

engaging in a practice contrary to their religious belief.

Recommendations shall not be made in an attempt to suppress a viewpoint or limit student exposure to divergent ideas. Mere exposure to an idea does not violate students' rights and the District shall not prescribe what is orthodox in politics, nationalism, religion, or other matters of opinion. Consequently, the committee should consider alternatives to removing instructional/resource material such as, but not limited to, an opt-out option for curricular material or placing check-out restrictions on library material.

- 6. Committee recommendations shall cite specific passages, sections, pages, and/or chapters that formed the basis of the recommendations.
- 7. If the review committee does not unanimously agree on the recommendations, the dissenting committee members may generate a minority report. This report must contain all components listed above.
- 8. The review committee shall issue recommendations to the Board as soon as practical.
- 9. The Board shall read the challenged material before acting on the recommendations.
- The board's ruling is final. All findings and records related to the review process shall be retained by the Superintendent.
