## WELCOMING CHAPLAIN MCCOY

A resolution welcoming the Chaplain of the Day, the Reverend N. E. McCoy of Jamestown, a voice familiar to generations of North Dakotans through thirty-eight years in the radio ministry.

WHEREAS, the Reverend N. E. McCoy of Jamestown is a name and voice familiar to generations of North Dakotans through his radio ministry; and

WHEREAS, through his daily broadcasts the past thirty-eight years, the Reverend McCoy has reached and enriched the homes and lives of thousands of citizens of North Dakota and neighboring states; and

WHEREAS, during his fifty-one distinguished years in the ministry, the Reverend McCoy has demonstrated time and again his concern for the troubled and less fortunate as a sponsor for prisoners on parole, supervising them and helping them secure employment; and

WHEREAS, for the past fifteen years, Reverend McCoy has worked with prisoners within the confines of the North Dakota Penitentiary as the official prison chaplain; and

WHEREAS, over the years, Reverend McCoy has actively worked with American servicemen, having served as chaplain of the North Dakota National Guard during World War II; and

WHEREAS, during his fifty-one years in the ministry and thirty-eight years in the radio ministry, the Reverend McCoy has been recognized for his service to mankind through numerous awards, among them the Jamestown College Distinguished Service Award, the Jamestown Chamber of Commerce Outstanding Citizen Award, and the Sertoma International Service to Mankind Award; and

WHEREAS, the Reverend McCoy honored the North Dakota House of Representatives by serving as its chaplain during the 1935 session;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NORTH DAKOTA:

That the House of Representatives welcomes the return to its chamber and is honored by the presence of the Chaplain of the Day, the Reverend N. E. McCoy.

## APPOINTING HOUSE PHOTOGRAPHER

A resolution to appoint an official photographer for the House of Representatives of the Forty-fourth Legislative Assembly of the state of North Dakota.

WHEREAS, for historical purposes it has been the custom of all North Dakota Legislative Assemblies to have composite group pictures made of all members of such assemblies; and

WHEREAS, Manda-Color Studio of Mandan, North Dakota, offers to take six proof color photographs of each Representative, the Clerk of the House, the Assistant House Clerk, the House Bill Clerk, the House Desk Reporter, and the House Sergeant-at-Arms, and to retouch said proofs; to make a composite color picture, size 38 x 49 inches, framed and ready to hang, of the photographs of the aforementioned; to make 107 color copies of said picture, 14 x 11 inches in size, one for each person pictured therein; and to make one 5 x 7 inch color, and one 5 x 7 inch black and white, photograph of each Representative; all the foregoing at a cost of \$1,905.00;

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF NORTH DAKOTA:

That Manda-Color Studio of Mandan, North Dakota, be and is hereby appointed official photographer for the House of Representatives of the Forty-fourth Legislative Assembly of the state of North Dakota; and

BE IT FURTHER RESOLVED, that the Manda-Color Studio of Mandan, North Dakota, is hereby awarded the sole privilege of photographing members of the House of Representatives and the above-mentioned House employees of the Forty-fourth Legislative Assembly, at a cost of \$1,905.00 to be charged as a legislative expense; and

BE IT FURTHER RESOLVED, that the photographs shall be delivered on or before June 1, 1975.

That Master Scott Andes be heartily commended for his many activities and congratulated for being selected as the North Dakota Easter Seal Poster Child, and that in all of his activities he carry with him the very warmest admiration and best wishes of the members of the North Dakota House of Representatives; and

## COMMENDING BISMARCK WRESTLING TEAM

A resolution congratulating the Bismarck Demons wrestling team on winning the 1975 North Dakota State Class A Wrestling Championship and congratulating Coach Jerry Halmrast for his ninth state wrestling championship in sixteen years and for being named as coach of the year.

WHEREAS, the Bismarck Demons won the 1975 Class A wrestling championship for the ninth time in the past sixteen years by scoring a record, for a championship tournament, 146 points; and

WHEREAS, the 1975 Bismarck Demons have a record of nine wins and no losses in dual meet competition and have won eight tournaments, including the state championship tournament, and have defeated the South Dakota championship team and the second runner-up to the Minnesota state championship team; and

WHEREAS, individual state champions for the Demons include: Brian O'Hara at 98 pounds, David Reimnitz at 119 pounds, Brian Hanson at 126 pounds, Lon Brew at 132 pounds, Steve Martinson at 138 pounds, Mark Reimnitz at 145 pounds, and Dan Woodward at heavyweight; and

WHEREAS, Coach Jerry Halmrast, a member of the House of Representatives of the Forty-fourth Legislative Assembly, has led nine Bismarck Demon wrestling teams to state championships in the past sixteen years and has been named coach of the year;
