CHAPTER 860

SENATE MEMORIAL RESOLUTION NO. 1
(Senators Lashkowitz, Satrom)

DEATHS OF U.S. MARSHALS

A memorial resolution commemorating U.S. Marshal Kenneth Muir and Deputy U.S. Marshal Robert S. Cheshire, Jr., whose lives were taken while in the line of duty.

WHEREAS, Kenneth Muir served in the U.S. Marshal's office since 1959 and as U.S. Marshal for the state of North Dakota since December 1981; and

WHEREAS, Robert S. Cheshire, Jr. served as Deputy U.S. Marshal since 1978; and

WHEREAS, U.S. Marshal Kenneth Muir and Deputy U.S. Marshal Robert S. Cheshire, Jr., died on February 13, 1983, from gunshot wounds received while in the line of duty; and

WHEREAS, it is the intention of the Forty-eighth Legislative Assembly, as representative of all North Dakota citizens, to commemorate U.S. Marshal Kenneth Muir and Deputy U.S. Marshal Robert S. Cheshire, Jr., for their dedicated service to the people of this state in the U.S. Marshal's office;

NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF NORTH DAKOTA:

That the Forty-eighth Legislative Assembly commemorates U.S. Marshal Kenneth Muir and Deputy U.S. Marshal Robert S. Cheshire, Jr., and for their dedicated service to the people of this state in the United States Marshal's office; and

BE IT FURTHER RESOLVED, that all North Dakota citizens extend their sorrow and deepest sympathy to the spouses and families of these brave men, and express their firm belief that they did not die in vain; and

BE IT FURTHER RESOLVED, that the Secretary of State send enrolled copies of this resolution to Mrs. Kenneth Muir and Mrs. Robert S. Cheshire, Jr., and to the U.S. Marshal's offices in Bismarck and Fargo, North Dakota.

CHAPTER 861

SENATE MEMORIAL RESOLUTION NO. 2 (Committee on Memorial Resolutions) (Kilander)

DECEASED SENATE MEMBERS MEMORIALIZED

A memorial resolution for deceased members of the Senate of the State of North Dakota.

WHEREAS, God in His wisdom has seen fit to summon to eternal rest His servants and our former colleagues:

C. W. "BILL" BAKER, who served in the Thirty-seventh and Thirty-eighth Legislative Assemblies, from the twenty-ninth district, died March 14, 1982.

RALPH CHRISTENSEN, who served in the Forty-seventh Legislative Assembly, from the thirty-sixth district, died April 16, 1982.

OLE S. JOHNSON, who served in the Thirty-fourth through the Thirty-seventh Legislative Assemblies, from the eighteenth district, died December 18, 1981.

KENNETH L. MORGAN, who served in the Thirty-fifth through the Thirty-eighth Legislative Assemblies, from the thirty-seventh district; the Thirty-ninth through the Forty-second Legislative Assemblies, from the twenty-sixth district; and the Forty-third through the Forty-fifth Legislative Assemblies, from the twenty-seventh district, died September 25, 1982.

ROBERT M. NASSET, who served in the Fortieth through the Forty-fourth Legislative Assemblies from the thirty-eighth district, died May 9, 1981.

ELTON W. RINGSACK, who served in the Thirty-sixth through the Thirty-eighth Legislative Assemblies, from the fourth district, and the Thirty-ninth through the Forty-fourth Legislative Assemblies, from the sixteenth district, died May 17, 1982.

FRANK S. SHABLOW, who served in the Forty-third through the Forty-seventh Legislative Assemblies, from the tenth district, died July 12, 1981.

KENNETH T. URDAHL, SR., who served in the Thirty-ninth Legislative Assembly, from the twenty-third district, died March 20, 1982.

WHEREAS, today, we, as members of the Senate of the Forty-eighth Legislative Assembly of the State of North Dakota, pause to mourn the passing of our former colleagues, and to honor their memories; and

WHEREAS, these legislators rendered outstanding service to the people of the state by their contribution to their fellowmen and their communities;

That we express our keen sorrow on their passing and our appreciation, on behalf of the people of North Dakota, of the loyal and devoted service of these, our former colleagues; and
