<sup>1</sup> This amendment provides a funding source switch from general fund moneys to special funds. The Veterans' Home is to consider methods to increase revenue from basic care services to generate the additional special funds. In addition, the salaries and wages line item is increased by \$100,000.

<sup>2</sup> This amendment removes the funding for an information management analyst position. The FTE for the position is maintained and may be funded from other sources from within the budget.

<sup>3</sup> This amendment removes a 0.6 FTE and funding for the chief financial officer position. A vacant 0.6 nurse position was reclassified to a chief financial officer position. The Veterans' Home was using other vacancies to apply toward the remaining 0.4 FTE needed for the chief financial officer position.

<sup>4</sup> This amendment removes the Governor's recommendation for state employee salary increases. The full funding of employee health insurance coverage as provided for in the executive budget recommendation is retained.

<sup>5</sup> This amendment decreases funding for salaries and wages.

<sup>6</sup> This amendment decreases funding for operating expenses.

The Senate added intent language that the governing board of the Administrative Committee on Veterans' Affairs may adjust FTE positions, subject to the availability of funds, at the Veterans' Home.

The Senate provided for line item transfer authority during the 2001-03 biennium within existing appropriation authority for implementing technology and telecommunications changes.

The Senate provided the Veterans' Home an exemption from the moratorium on expansion of skilled nursing care bed capacity for the conversion of up to 18 basic care beds to skilled care beds and provides an appropriation to the Department of Human Services for additional related Medicaid reimbursement costs to the Veterans' Home.

The Senate removed the requirement for periodic reports to the Budget Section on the status of the Administrative Committee on Veterans' Affairs progress in developing and implementing a strategic plan for the Veterans' Home.

The Senate provides an appropriation to the Department of Human Services to provide a separate payment rate class for the Veterans' Home and provides an appropriation to the Department of Human Services for the Medicaid reimbursement costs.

The Senate provides an appropriation to the Office of Management and Budget for grants to private pay veterans with long-term health care needs residing at the Veterans' Home. This amount is based on the current 5,666 private pay bed days per year at the Veterans' Home and additional per resident fees of \$31.19 because of the rate class change.

The Conference Committee added language authorizing the governing board of the Veterans' Home to add two FTE positions during the 2001-03 biennium, subject to the availability of funds.

The Conference Committee provided for line item transfer authority of up to \$150,000 during the 2001-03 biennium within existing appropriation authority for implementing technology and telecommunications changes.

The Conference Committee provides for the purchase of eight skilled care beds by the Department of Human Services, which are to be transferred to the Veterans' Home. The Conference Committee also provided an appropriation to the Department of Human Services for additional related Medicaid reimbursement costs to the Veterans' Home.

The Conference Committee provided that periodic reports to the Budget Section on the status of developing and implementing a strategic plan for the Veterans' Home be made by the Veterans' Home governing board, rather than the Administrative Committee on Veterans' Affairs.

The Conference Committee provided for a Legislative Council study of the desirability and feasibility of implementing a separate rate class for the Veterans' Home.
