NOTICE OF INTENT TO AMEND AND REPEAL ADMINISTRATIVE RULES

TAKE NOTICE that the North Dakota Veterans Home will hold a public hearing to address proposed amendments to and repeal of N.D. Administrative Code Articles 86-03, at 10:00 am, Friday, November 21, 2008, in Meeting Room D at the Bismarck Comfort Inn, 1030 East Interstate Ave, Bismarck, ND. The purpose of the proposed amendments is to implement changes to the administrative rules. The proposed amendments are not expected to have an impact on the regulated community in excess of \$50,000.


