## Provide explanation:

The legislature has an ongoing history of accepting federal funds to support election administration through the Help America Vote Act (HAVA). Funds were most recently appropriated during the 2023 Legislative Session, S.B. 2002. SOS requests authorization to receive and expend federal funds of \$462,135 from a new source; the Department of Defense for the federal Electronic Absentee Systems for Elections (EASE 3.0) Grant as appropriated under the DoDGARS 22.315. 10 U.S.C. 2358 which allows for the Federal Voting Assistance Program (FVAP).

Statutory provisions that relate to this request:

Implementation of a secure balloting portal compliant with Military and Overseas Voter Empowerment (MOVE) Act and requirements set forth in NDCC16.1-07-08 (2)(3). Electronic Absentee Systems for Elections (EASE 3.0) Grant as appropriated under the DoDGARS 22.315. 10 U.S.C. 2358.

Provide an explanation as to how the request supports state priorities, improves state efficiencies, and promotes effective state government:

The receipt of EASE 3.0 Grant dollars augments the funds available to support the state's responsibility for election administration. The funding will be used to improve the voting process for absentee voters, specifically related to Electronic Absentee Voting Systems for the acquisition and implementation of a secure ballot delivery portal for Uniformed and Overseas Citizens Absentee Voting Act (UOCAVA) population.



Provide any other relevant information:

The North Dakota Secretary of State represents over 2,500 eligible UOCAVA voters identified in our 53 counties. We recognize that UOCAVA voters traditionally have a lower voting percentage than domestic voters and that the MOVE act was passed to narrow the turnout gap between UOCAVA and domestic voters.
