- 64 total Special Agents placed around North Dakota

    - SA Matt Schimetz (Rolla)

# FORCE MULTIPLIER

---

- NDBCI can bring in agents from surrounding or outside the area to meet the needs, and more:
  - Agents are trained in both Criminal Investigations and Narcotics Investigations
  - Nine (9) agents are assigned to Cyber Units in Fargo (3), Minot (3) and Bismarck (3)
  - NDBCI has Drone capabilities around the state
  - Two (2) Special Agents that are certified video and audio enhancements
  - Multiple Special Agents certified in shooting reconstruction and blood pattern analysis – Tennessee National Forensic Academy

# CRIME SCENE INVESTIGATION

---

- NDBCI has crime scene vehicles available
  - Grand Forks
  - Bismarck
  - Williston
- Each crime scene vehicle has specialized equipment and can be brought to the scene
- NDBCI has Special Agents that can scan a scene quickly using specialized equipment
