## **Item Description**

**FTE changes** - The 2013-15 biennium appropriation includes funding for 55 FTE positions, an increase of 1 FTE position from the 2011-13 authorized level of 54 FTE positions. The Legislative Assembly did not change the executive recommendation to convert a long-term temporary employee to a 1 FTE administrative assistant position.

**Accrued leave payments** - In Section 1 of House Bill No. 1019, the Legislative Assembly identified \$176,130 from the general fund and \$5,447 of other funds for accrued leave payments.

**Marina purchase** - Section 7 of House Bill No. 1019 requires the Parks and Recreation Department to obtain an appraisal from a certified appraiser prior to the purchase of a marina at Lake Sakakawea State Park.

One-time funding - In Section 2 of House Bill No. 1019, the Legislative Assembly identified \$7,447,800, of which \$6,177,500 is from the general fund, as one-time funding for parks capital projects and deferred maintenance (\$3,897,800), parks equipment (\$350,000), Lewis and Clark Interpretive Center grant (\$1,350,000), parks strategic plan (\$100,000), community grant program (\$500,000), and International Peace Garden capital projects (\$1,250,000).

## Status/Result

The temporary employee was converted to a 1 FTE administrative position on July 1, 2013.

The Parks and Recreation Department has spent \$5,545 from the accrued leave payments line item related to employee turnover through March 2014. The department does not anticipate transferring funds from the accrued leave payments line item to the salaries and wages line item during the 2013-15 biennium.

The Parks and Recreation Department completed the purchase of the marina at Lake Sakakawea State Park in November 2013 for \$746,057 plus an appraisal fee of \$21,481.

Funding was approved for the operation of the marina at the March 2014 Budget Section meeting. The department anticipates that the revenue generated from boat slip rentals will provide funding for operating expenditures.

All one-time funding is anticipated to be used by the end of the 2013-15 biennium as follows:

Game and fish operating fund - Section 3 of House Bill No. 1019 provides that \$122,000 from the game and fish operating fund, or federal or other funds available to the Game and Fish Department, must be transferred to the Parks and Recreation Department for maintenance, operating, and extraordinary repairs expenses relating to boat ramps at state parks for the 2013-15 biennium.

International Peace Garden - The 2013-15 biennium appropriation includes \$2,223,699 from the general fund for the International Peace Garden, an increase of \$1,183,000 from the 2011-13 biennium appropriation amount of \$1,040,699. The Legislative Assembly did not change the executive recommendation to provide \$973,699 for the operating grant for the International Peace Garden, an increase of \$200,000 from the 2011-13 biennium level of \$773,699. The Legislative Assembly provided one-time funding of \$1,250,000 from the general fund for capital projects at the International Peace Garden, including repairs to the Peace Tower.

**Emergency Commission and Budget Section approvals** - The Parks and Recreation Department has received Emergency Commission or Budget Section approval to increase spending authority for various purposes.

The Game and Fish Department has transferred 20 percent of the funds and anticipates transferring the remaining 80 percent of the funds by the end of the biennium.

The Parks and Recreation Department transferred the first payment of \$486,850 on July 1, 2013, for the operations at the International Peace Garden. The second payment of \$486,849 will be made on July 1, 2014.

Funds for the International Peace Garden Tower repair and capital project were transferred on July 1, 2013. The department anticipates the project will be completed by the end of the biennium.

The Parks and Recreation Department received approval from the Emergency Commission and Budget Section for the following items:

- Increase special funds spending authority by \$129,000 in the natural resources line item relating to a grant from the North Dakota outdoor heritage fund for the department's natural resource stewardship project.
- Increase special funds spending authority by \$112,000 relating to a grant from the North Dakota outdoor heritage fund for the department's trail restoration and improvement project.
- Increase special funds spending authority by \$130,000 of parks revenue for expenses relating to the operation of the marina at Lake Sakakawea State Park.
- Increase special funds spending authority by \$150,000 from the department's operating account to relocate trails affected by energy development in Little Missouri State Park.

The Parks and Recreation Department received approval from the Budget Section to increase spending authority from the department's operating fund for various capital projects that had bids exceed original project authorization amounts. These projects include:

**Mineral lease revenue** - In a letter opinion dated October 18, 2011, the Attorney General stated the Parks and Recreation Department may deposit revenue from mineral lease bonus payments and lease royalties from lands under the management and control of the Parks and Recreation Department in the state park fund.

The Parks and Recreation Department began earning mineral lease bonus and royalty revenue in March 2011 and began depositing the revenue in the state park fund in October 2011. From March 2011 through March 2014, the department has received \$3,601,332 in mineral lease bonus and royalty payments which have been deposited in the state park fund. The department expended approximately \$2 million of the mineral lease bonus and royalty revenue during the 2011-13 biennium and anticipates spending approximately \$1,257,800 of the mineral lease bonus and royalty revenue during the 2013-15 biennium on the following projects:
