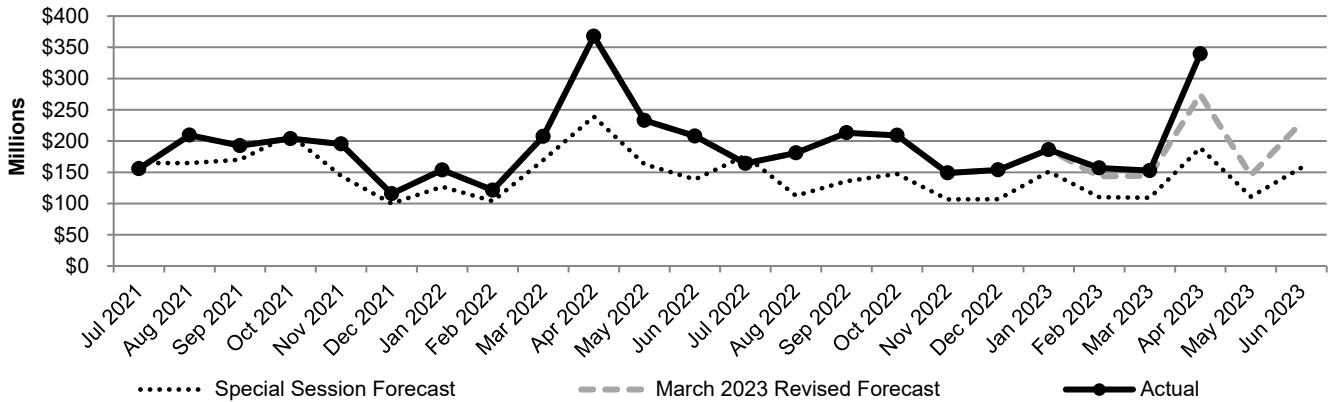
SUMMARY

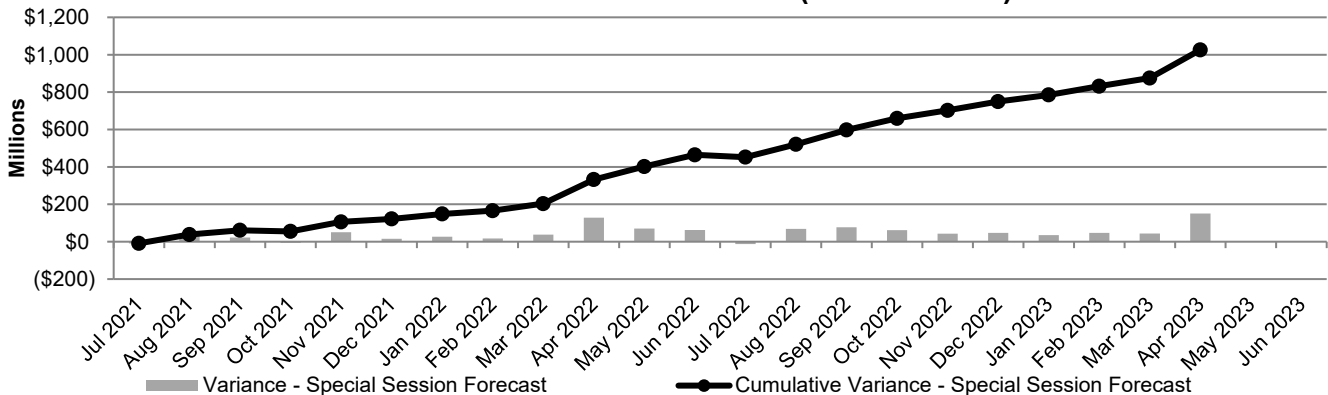

COLLECTION DETAILS

The schedule below provides information on general fund revenue collections for April 2023 and for the biennium to date based on actual collections, the November 2021 legislative forecast ("special session forecast") which was prepared at the close of the November 2021 special legislative session, and the March 2023 revised legislative forecast ("March 2023 revised forecast"). The forecasted amounts for the oil and gas taxes have been adjusted to reflect the actual allocations, because the allocations are limited to \$400 million per biennium.
