It was moved by _____ and seconded by _____ that the House (Senate) Appropriations Committees of the 69th Legislative Assembly adopt, for Legislative Council budget status reporting purposes, the following estimated revenue adjustments (as shown for the proposed adjustments in the schedules above):

- Adjustment to unspent 2023-25 biennium general fund appropriations \$71,490,929.
- Adjustment to 2023-25 biennium estimated total general fund revenues \$27,633,724.
- Adjustment to 2025-27 biennium estimated total general fund revenues (\$74,621,363).
- Estimated oil price and daily oil production for the remainder of the 2023-25 biennium Oil prices remaining at \$62 per barrel and oil production remaining at 1.15 million barrels per day.
- Estimated oil price and daily oil production for the 2025-27 biennium Oil prices decreasing from \$59 to \$57 per barrel and oil production decreasing from 1.15 to 1.1 million barrels per day.
