Continuing Appropriations

Lignite research fund - North Dakota Century Code Section 57-61-01.5 - Research, development, and marketing for the lignite industry. For the 2021-23 biennium, the fund had \$10,000,000 of oil and gas tax revenue allocations, \$8,734,914 of coal tax revenue allocations, \$1,423,156 of investment and other income, \$9,789,352 of grants payments, \$2,039,873 of study and marketing expenditures, \$647,610 of administrative expenditures, and a June 30, 2023, fund balance of \$29,488,701.

North Dakota outdoor heritage fund - Section 54-17.8-02 - For grants to conserve natural areas, restore wildlife and fish habitats, and provide access to sportsmen. For the 2021-23 biennium, the fund had \$15,000,000 of oil and gas tax revenue allocations, \$107,994 of interest income, \$10,570,193 of grant payments, \$98,917 of administrative expenditures, and a June 30, 2023, fund balance of \$40,495,372, including \$39,367,281 obligated for grants and \$1,128,091 unobligated.

North Dakota Pipeline Authority administrative fund - Section 54-17.7-11 - For operations of the North Dakota Pipeline Authority. For the 2021-23 biennium, the fund had \$601,014 of revenues, \$332,386 of expenditures, and a June 30, 2023, fund balance of \$440,113.


Oil and gas research fund - Section 57-51.1-07.3 - Oil and gas research and education. For the 2021-23 biennium, the fund had \$14,500,000 of oil and gas tax revenue allocations, \$9,500,000 of transfers from the strategic investment and improvements fund (SIIF), \$80,848 of other revenues, \$17,283,301 of grant payments, and \$702,356 of other expenditures, and a June 30, 2023, fund balance of \$22,378,336.

Renewable energy development fund - Section 54-63-04 - Renewable energy research, development, and education. For the 2021-23 biennium, the fund had \$3,000,000 of transfers from the resources trust fund, \$34,290 of other revenues, \$1,808,862 of grant payments, \$69,142 of other expenditures, and a June 30, 2023, fund balance of \$6,084,787.

Clean sustainable energy fund - Section 54-63.1-07 - Grants, loans, and other financial assistance for clean sustainable energy project research and development. For the 2021-23 biennium, the fund had \$25,000,000 of transfers from the general fund, \$20,000,000 of transfers from the federal State Fiscal Recovery Fund, \$562,612 of other revenues, \$10,898,844 of grant payments, \$1,751,000 of provisions for loan losses, \$1,509,000 of interest expense from a line of credit, \$138,551 of other expenditures, and a June 30, 2023, fund balance of \$47,796,217.
