Abandoned oil and gas reclamation fund - North Dakota Century Code Section 38-08-04.5 - Abandoned oil and gas reclamation. For the 2021-23 biennium, the fund had \$15,641,051 of oil and gas tax revenue allocations, \$5,383,786 of fee and penalty revenues, \$2,982,783 of federal funds, \$12,410,022 of well site reclamation expenses, \$135,911 of other expenditures, and a June 30, 2023, fund balance of \$25,312,303.

Carbon dioxide storage facility administration fund - Section 38-22-14 - For defraying costs of processing applications for regulating carbon dioxide storage facilities. 
