Selected Highlights

- Adds \$3,282,749, of which \$2,089,044 is from the general fund and \$1,193,705 is from other funds, for salary increases of up to 3 percent effective July 1, 2025, and 3 percent effective July 1, 2026
- Adds \$2,108,033, of which \$1,254,414 is from the general fund and \$853,619 is from other funds, for a
 health insurance premium increase of \$250 per month (15.2 percent), from \$1,643 to \$1,893, per employee
- Adds \$5,559,202, of which \$3,714,807 is from the general fund and \$1,844,395 is from other funds, to replace the 2023-25 biennium new FTE pool (\$220,000) and 2023-25 biennium vacant FTE pool (\$5,339,202)
- Adds \$495,000 from the general fund for a scientist position and a research specialist position, but does not include FTE authorization for the positions
- Removes \$1,823,942, of which \$320,198 is from the general fund and \$1,503,744 is from other funds for supplies, repairs, travel, and temporary salaries
- Adds \$1 million from other funds for research equipment
- Adds one-time funding of \$1.5 million from SIIF for deferred maintenance
- Adds one-time funding of \$620,000 from SIIF to complete the interior of the Oakes irrigation research site

Significant Audit Findings
