GENERAL FUND REVENUE General Fund Revenue Collections

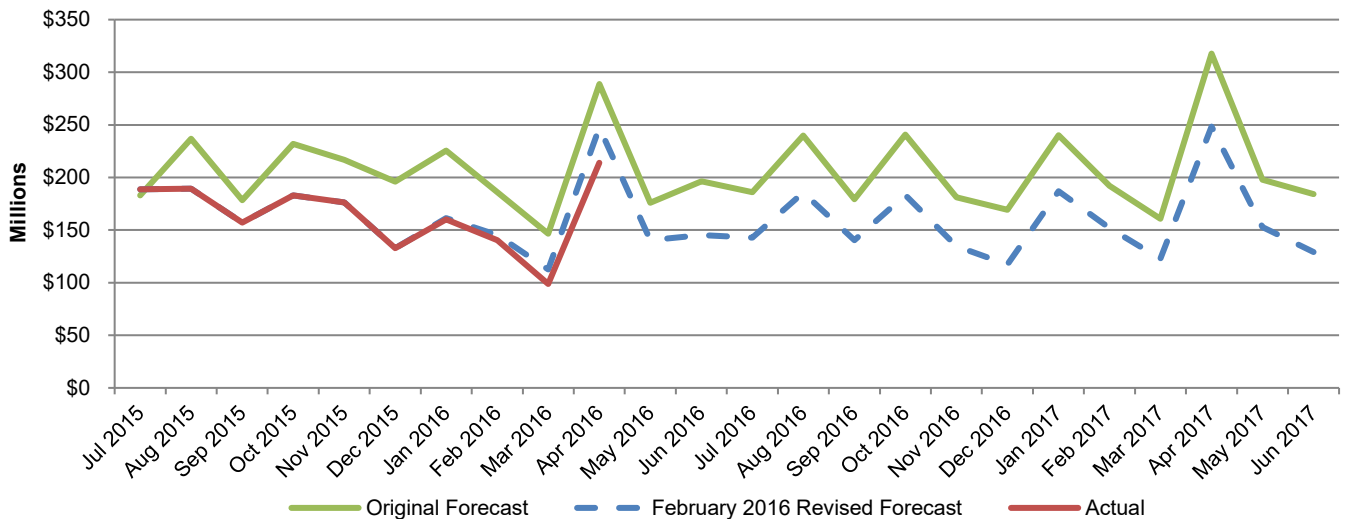

OIL TAX REVENUE ALLOCATIONS Oil Production, Oil Prices, and Rig Counts

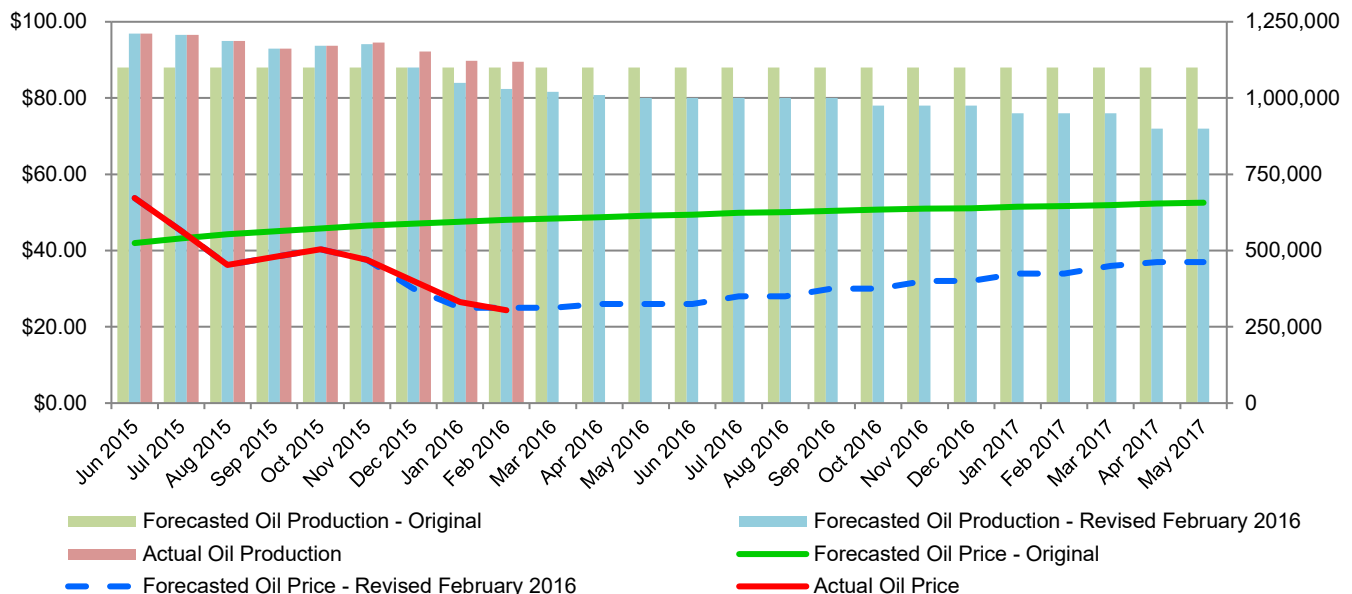

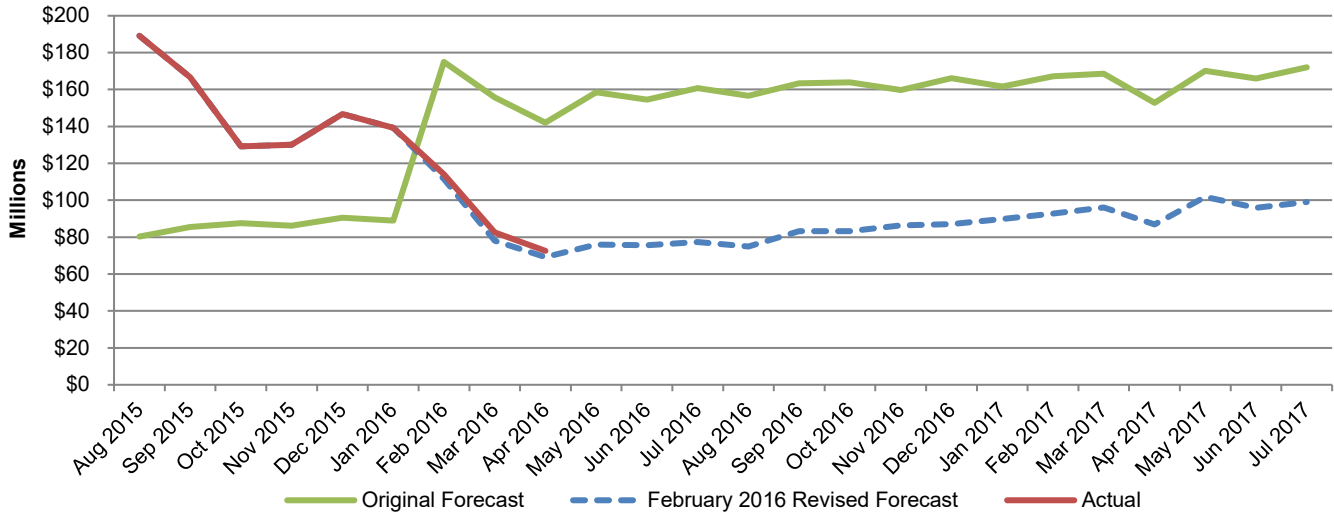
Oil Production and Prices
