

## GENERAL FUND REVENUES MONTHLY UPDATE

This memorandum provides an update on general fund revenues for the month of September 2017 and for the biennium to date. **The forecasted amounts reflect the 2017 legislative revenue forecast**, prepared at the close of the 2017 legislative session.

### GENERAL FUND REVENUE COLLECTIONS

The schedule below compares actual and forecasted general fund revenue collections for the month of September 2017 and for the biennium to date. The forecasted amounts for the oil and gas taxes have been adjusted to reflect the actual allocations, because the allocations are limited to \$400 million per biennium.
