## OIL AND GAS TAX REVENUES MONTHLY UPDATE

This memorandum provides an update on oil production and prices, oil and gas tax revenue collections, and oil and gas tax revenue allocations for January 2023 and for the biennium to date. The forecasted amounts reflect the 2021 legislative revenue forecast ("original forecast") which was prepared at the close of the 2021 regular legislative session and the January 2023 revised legislative forecast ("January 2023 revised forecast"). The oil revenue forecast was not changed during the November 2021 special legislative session.

### OIL PRODUCTION AND PRICES

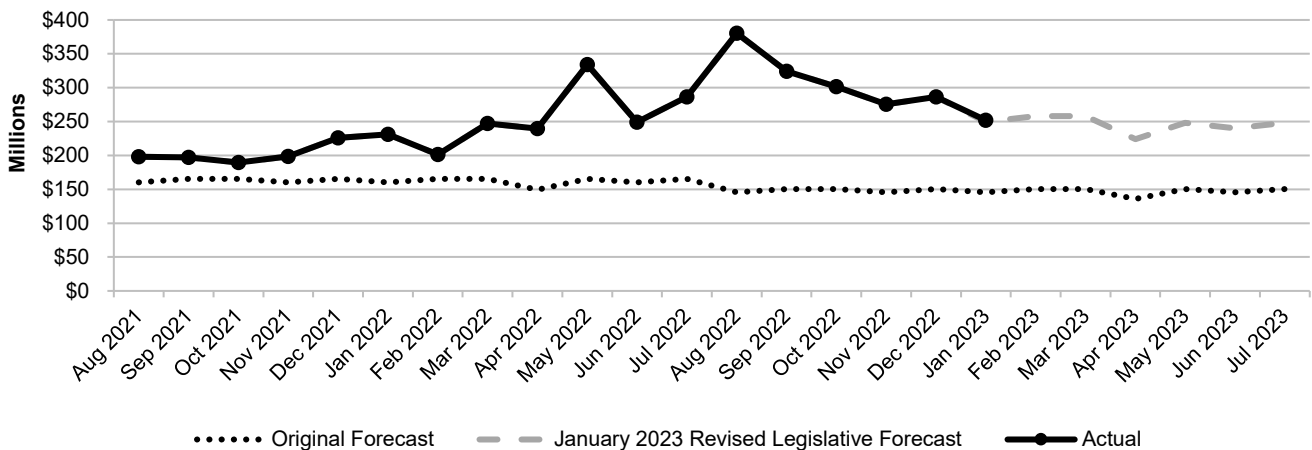
