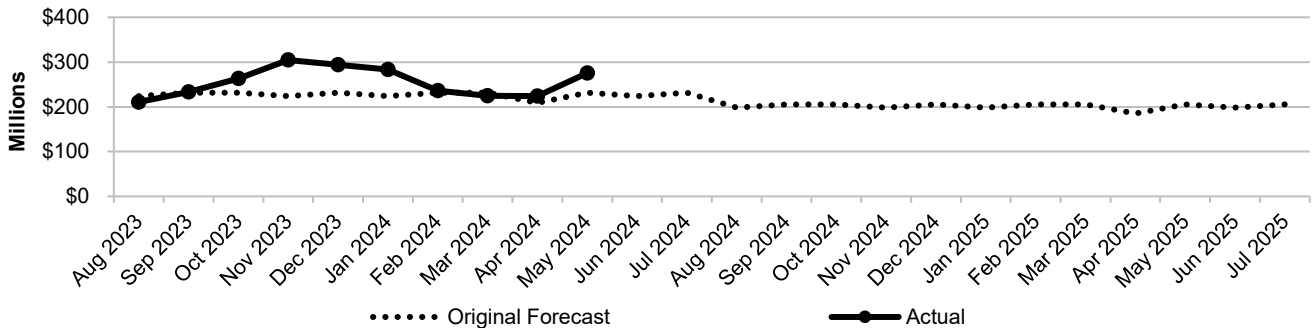
OIL PRODUCTION AND PRICES
