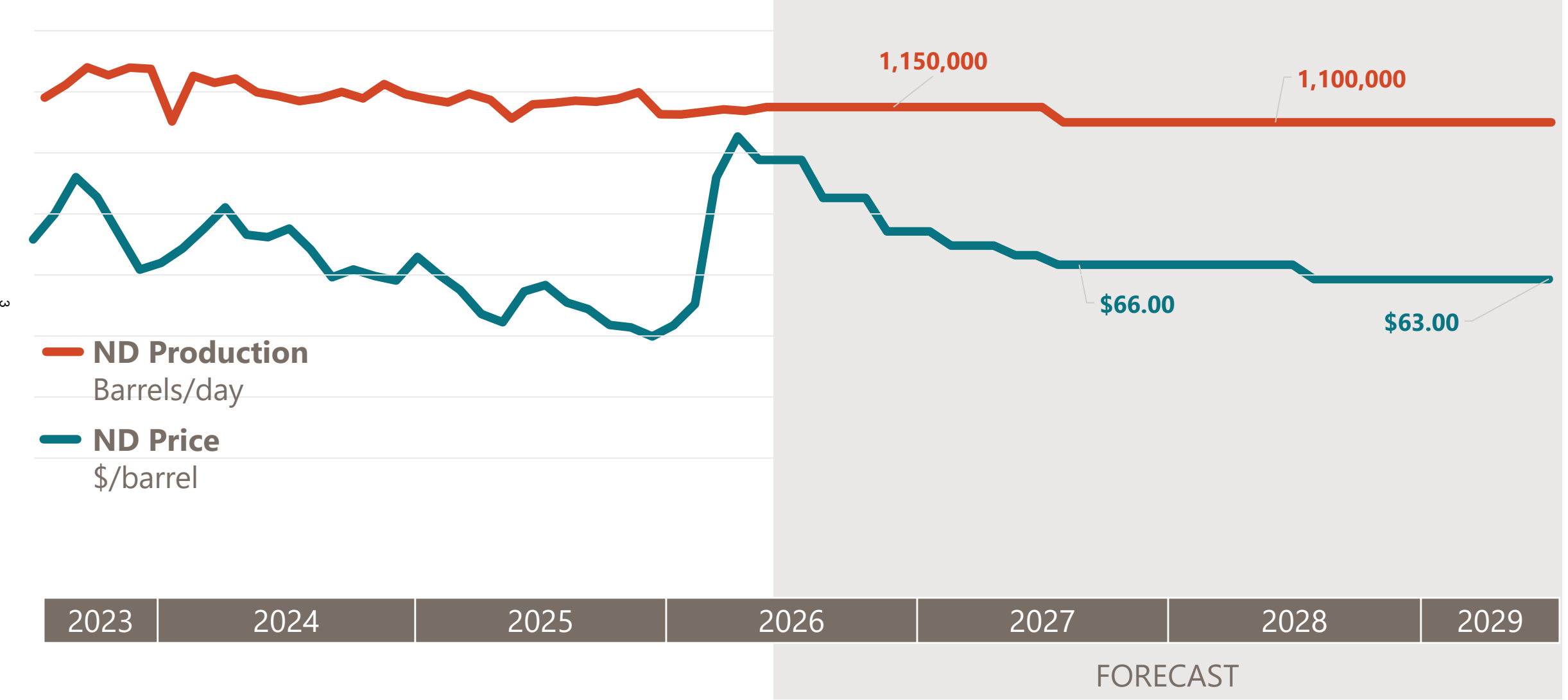

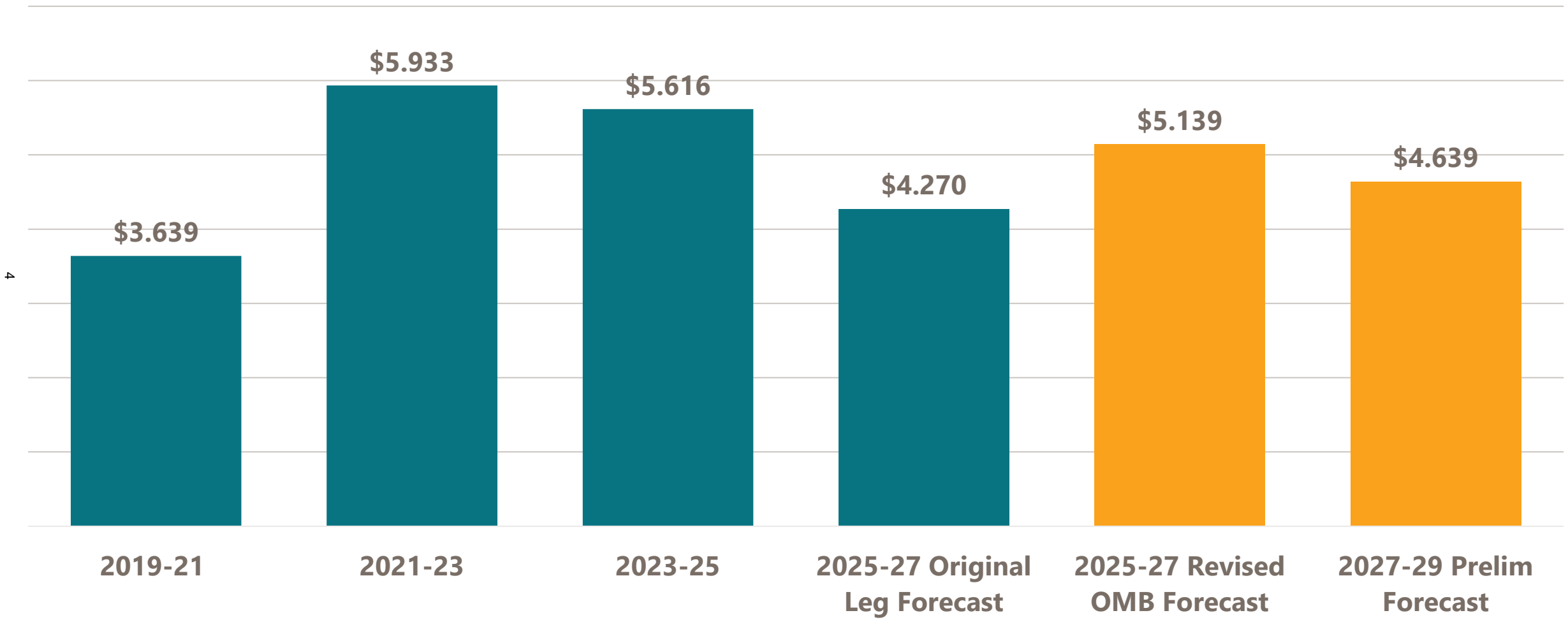

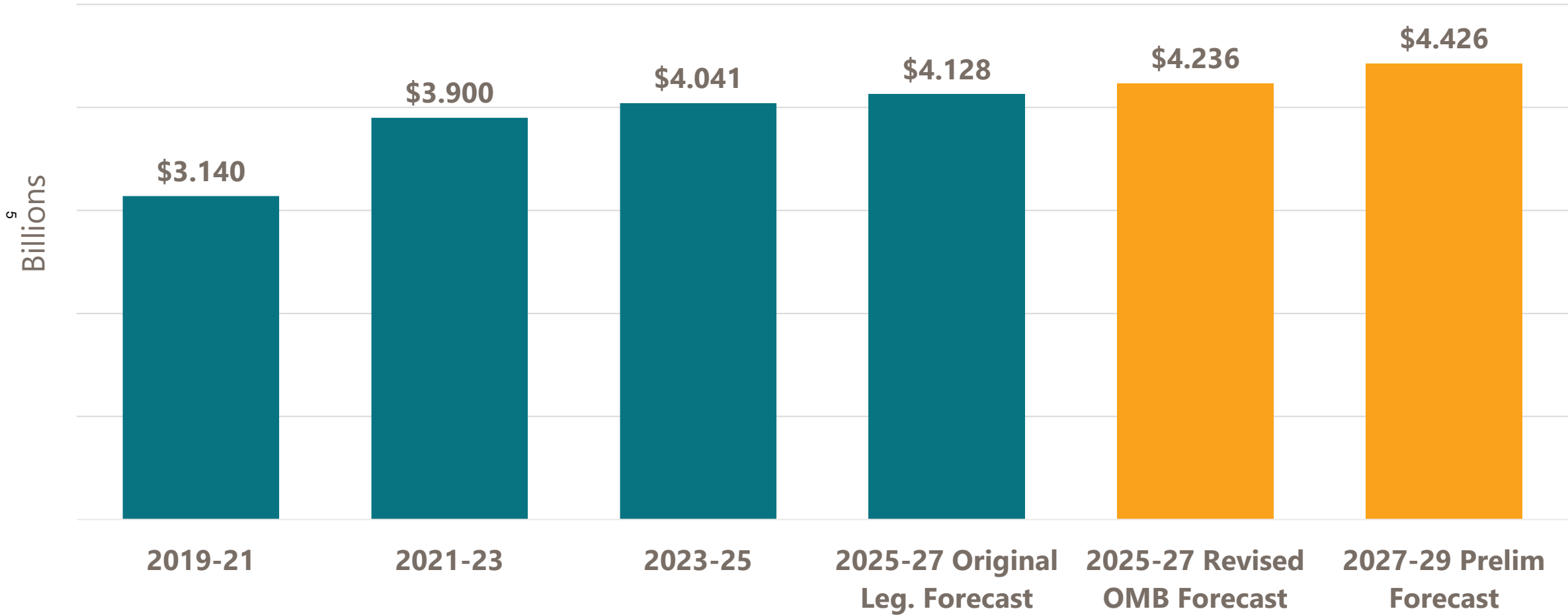


ND OIL TAX REVENUES

FOUR MAJOR TAX TYPES

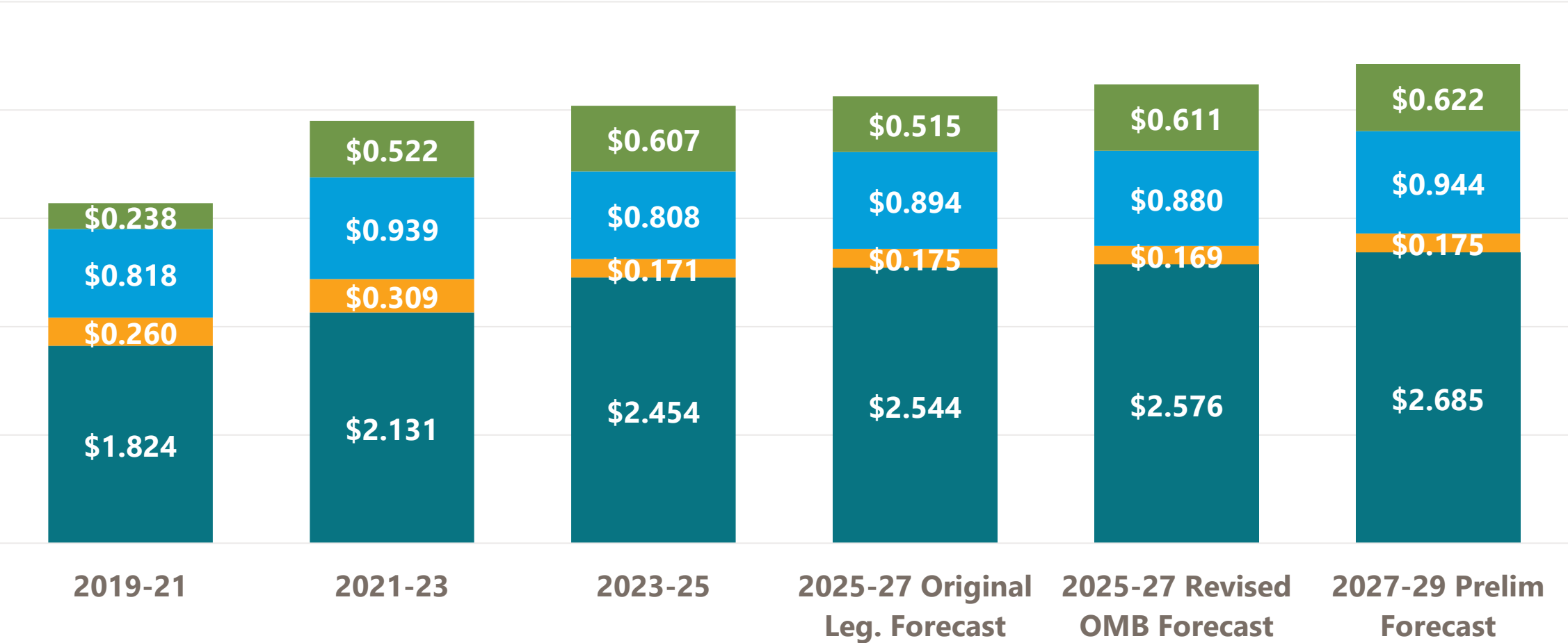

Request: \$8,393,567

Title of Grant: Growing Great Educators for Every North Dakota Student. Signed 05/29/2026

Purpose of Grant: This grant competition focuses on providing funding to support projects that:

- Increase student's access to effective teachers and school leaders.
 - Improve educator recruitment, retention, development and advancement.
 - Support strategic staffing and teacher leadership roles.
 - Improve student academic achievement and close achievement gaps.
 - Strengthen educator effectiveness in high-need schools.

Purpose of Grant: Identify qualified individuals from disadvantaged backgrounds with potential for education at the postsecondary level and encourage them to complete secondary school and undertake postsecondary education. Talent Search projects publicize the availability of, and facilitate the application for, student financial assistance for persons who seek to pursue postsecondary education and encourage persons who have not completed programs at the secondary or postsecondary level to enter or reenter and complete these programs.

Title of Grant: ESTART: Reentry, Employment in Skilled Trades, Adv. Manu, Reg. Apprenticeships and Training Initiative. Signed: 03/27/2026

Purpose of Grant: Across the State of North Dakota, individuals returning to the community from incarceration face significant barriers to securing stable employment, despite strong demand for workers in skilled trades, advanced manufacturing, and registered apprenticeships. To address this gap, Job Service North Dakota (JSND) is applying to US DOL for funding under the RESTART Reentry Employment Initiative Grant, designed to equip justice involved individuals with industry mechanized training leading to meaningful and sustainable employment. This initiative directly aligns with President Trump's administration's vision of Building the Workforce for the Golden Age by supporting pathways to self-sufficiency, strengthening the skilled trades pipeline, and meeting critical workforce shortages.

The RESTART initiative presents an opportunity to train justice-involved individuals for in-demand

occupations. Job Service North Dakota proposes serving a minimum of 200 participants through the REST ART grant. This grant will target individuals aged 25 and older through two (2) service areas. Cass, Burleigh, and Morton Counties represent some of North Dakota's largest population centers and are key hubs for the state's skilled workforce. These counties combined account for 36% of the job openings in the state. The RESTART initiative will begin on July 1, 2026, and run for 42 months up to December 31, 2029. The overall project timeline will allow for a three-month planning and implementation period. During the life of the grant, participants will be placed into apprenticeship and on-the-job training opportunities, retention efforts will be ongoing, and measurements will be tracked. During the final two years of the grant, work will begin on a sustainability package.
