Background Information Was any portion of the request presented during the previous legislative session? Yes Provide explanation: The Office of the Adjutant General received \$24,100,000 of federal authority (\$15,500,000 military construction dollars and \$8,600,000 federal state fiscal recovery fund (ARPA) dollars) through the agency's appropriation bill (SB 2016) for the construction of the Dickinson Readiness Center project. The agency also requested and received \$5,300,000 of additional federal funding through the September 2023 Emergency Commission/Budget Section due to significantly higher bids than the original projection. The agency is now requesting an additional \$500,000 of federal authority due to an increase in contingency funding. Last winter the Office of the Adjutant General expended additional funds on a deeper foundation to keep the project progressing throughout the winter months.
