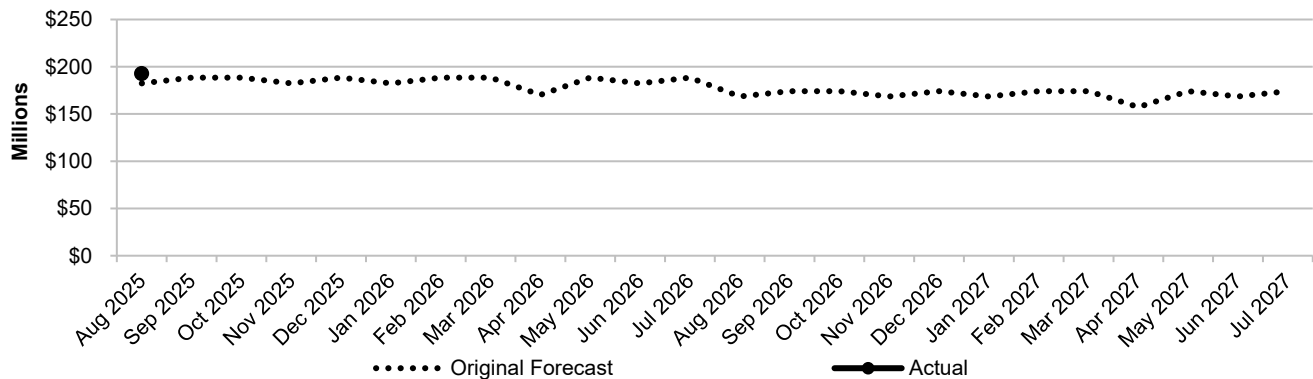
OIL PRODUCTION AND PRICES

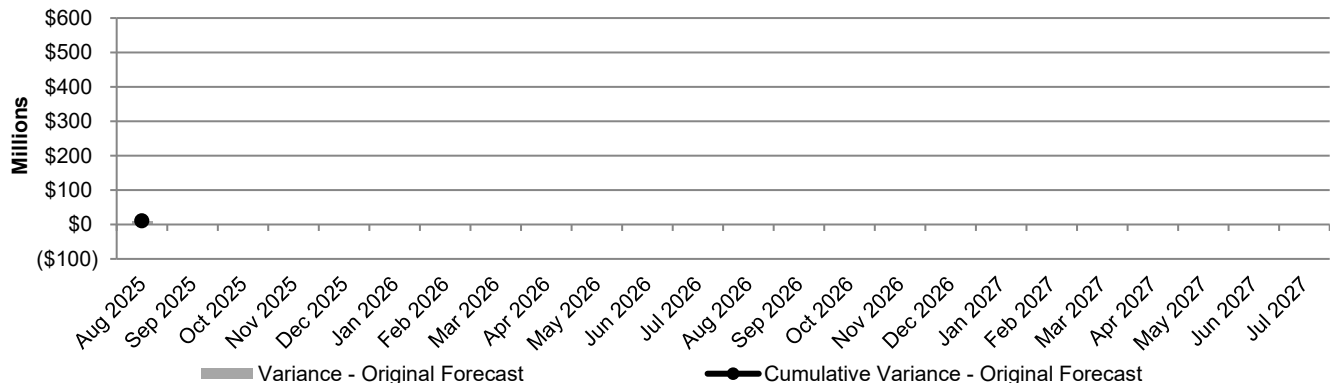
