In consideration of the upcoming bill introduction deadline, the Legislative Council staff will do its best to complete bill drafts received by noon TODAY, before the Monday, January 27 deadline.

#### From the Director

With most bills having been introduced, the focus of the Legislative Council staff turns more toward drafting amendments for individual legislators and standing committees. Earlier this week, my focus was on presentation of the legislative branch budget to the Senate Appropriations Government Operations Division.

The legislative branch budget is broken into 2 sections--the Legislative Assembly and the Legislative Council. The assembly portion generally applies to legislative session related expenses such as legislator and temporary staff pay. The estimated daily cost to operate the assembly is about \$95,000. The council portion of the budget accounts for the council staff and the interim process. When legislators attend interim committee meetings, the costs are paid from the council budget.

During the last interim, the Legislative Procedure and Arrangements Committee studied the impact of term limits and how term limits may affect legislative staffing needs. The committee recommended including in the council budget the addition of 25 full-time employees. Most of the proposed additional employees would be in 3 areas--policy analysis, program evaluation, and information technology. The goal of the staff expansion is to better prepare legislators who will have less experience and to ensure the only part-time branch of government has the tools and support necessary to remain a co-equal branch of government.

The legislative branch appropriation bill is <u>Senate Bill No. 2001</u>. You can find more details regarding the contents of the budget request in the <u>testimony legislation</u> provided to the committee. Also included with the testimony is a chart illustrating the proposed new positions. If you have any questions or would like additional details, we are happy to help.
