Preparing for Bill Crossover This Month

The 69th Legislative Assembly is one quarter of the way through its 80 legislative days. To date, 1,072 bills and resolutions have been introduced, the most since the 1997 session. The record is 1,424, set during the 1987 legislative session.

One month in, over half of the introduced measures are waiting for action. The house has 402 measures remaining to

be heard in committee and the Senate has 237 measures remaining to be heard in committee. Some measures are already being heard in committee by the second chamber.

All study resolutions and amendments to the Constitution of North Dakota must be introduced by 5:00 p.m. on February 25.

Referral to Appropriations Committee - Deadline Monday

All bills required to be heard by the Appropriations Committees before final passage must be moved out of standing committees by Monday, February 10. According to House and Senate Rule 329, all bills providing an appropriation of \$50,000 or more (for a Senate Bill) or \$100,000 more (for a House Bill) must be rereferred to the Appropriations Committee. Both the House and Senate rules also require every bill or resolution having a fiscal impact of \$200,000 or more on the appropriation for a state agency or department to be referred to the Appropriations Committee.

A member seeking to verify whether a bill must be rereferred to the Appropriations Committee may review the current version of the measure in LAWS to see if the measure contains appropriation sections totaling \$50,000 or more (for a Senate bill) or \$100,000 or more (for a House bill) or has a fiscal note with total general fund and other fund expenditures for the 2025-27 biennium totaling \$200,000 or more. Bills meeting these requirements should be leaving standing committees with a recommendation for a rereferral to the Appropriations Committee.
