Another One Bites the Dust

In previous newsletters we have addressed the increase in the number of bill draft requests and the number of bills and resolutions introduced. As we approach crossover, it seems like a good time to compare statistics from previous sessions with respect to the percentage of bills passed and failed.

The following chart shows the passage rate for the 26th legislative day for this session and each of the last 5 sessions.

On another statistical note, as of last Friday, there have been almost 134,000 live views and 17,000 subsequent views of video streams of legislative hearings and floor sessions. This amounts to individuals tuning in to view more than 1,000 hours of the legislature at work this session.

In addition to viewing time, nearly 4,600 registrants have submitted written testimony through the legislative branch testimony submission page.
