


You're My Best Friend

Adam Mathiak began working for the Legislative Council in 2013 as a fiscal intern and joined full-time as a fiscal analyst after graduating from Minot State University. His portfolio includes the budgets for the Industrial Commission and the Tax Department, the legacy fund, the strategic investment and improvements fund, and state general fund revenues and oil and gas tax revenues. He provides regular updates to the Legislative Assembly on

the status of oil and gas tax revenue collections and has created various flowcharts depicting the allocation of state revenues. In recent interims, he has staffed the Legacy and Budget Stabilization Fund Advisory Board, which reviews the status of the legacy fund, and the Government Finance Committee, which receives revenue forecasting data and reviews the state budget.
