Session may be over, but the legislature's work is not as preparations begin for the 2025-26 interim. In the coming weeks, the Legislative Management will meet to review the list of studies passed during the 2025 legislative session and decide which proposed studies, in addition to the mandatory studies, will be taken up for review during the interim. Once the Legislative Management finalizes its selected list of proposed studies, the subject matter of the selected studies will dictate which interim committees will be formed. These subject-specific interim committees will be in addition to the list of committees which are required to form pursuant to statute.

The eight statutorily mandated committees include the Administrative Rules Committee, Budget Section, Employee Benefits Programs Committee, Energy Development and Transmission Committee, Information Technology Committee, Legislative Audit and Fiscal Review Committee, Tribal and State Relations Committee, and Water Topics Overview Committee. Once the interim committee structure is established, legislators will be sent a questionnaire on which they may rank their preferred interim committees. The Legislative Management will review these preferences when assigning legislators to interim committees.

Committees generally will hold their first meeting in July or August and will enlist the help of the Legislative Council to provide staff services to the committees and conduct any research or bill drafting requested by the committees. Each committee will have roughly 16 months to complete its work conducting its assigned studies and receiving required reports.

In addition to the work of interim committees, work on measures for the next legislative session starts almost immediately upon the conclusion of the current one. The Legislative Council already has received the first bill draft request for the 2027 regular session. So, although session is over, the work of legislators and the Legislative Council certainly isn't!
