Legislative Management Updates

Interim Committee Structure

On Thursday, the Legislative Management finalized committee membership for 26 interim committees for the 2025-26 interim. The full committee structure and membership details are available here. In addition, the Legislative Management received information regarding the impact of scenarios involving lower than forecasted levels of oil production and lower oil prices, the impact of proposed federal funding reductions and rescissions, the status of redistricting litigation, and the opinion of the Attorney General relating to the veto errors.

2025-27 Biennium Estimated Oil and Gas Tax Allocations



The memorandum identifies the potential reduction of more than \$1.1 billion of oil tax collections and allocations if oil production and prices would decline during the 2025-27 biennium. The information is based on data presented by S&P Global in March 2025 indicating that oil production could decline below 1 million barrels

per day due to exhaustion of the most productive areas of the Bakken, restrained oil development due to company mergers, market uncertainties, or a combination of these factors. Also, oil prices and production could decline due to price decreases related to excess oil supply in the global markets causing oil producers in North Dakota to decrease production, shutdown of the Dakota Access Pipeline limiting export capacity and discounting North Dakota oil prices associated with increased rail transportation costs, or a combination of these factors.

Federal Funding Reductions and Rescissions

The memorandum entitled <u>Proposed Federal</u> <u>Funding Reductions and Rescissions</u> details the fiscal impact of the federal legislation and other reductions in federal funding. The federal budget reconciliation bill under consideration in Congress includes proposed changes to Medicaid and the



supplemental nutrition assistance program (SNAP) that could result in the state receiving less federal funding. Federal funding rescissions and expirations identified for the 2023-25 biennium to date total nearly \$104 million.

Attorney General Opinion Regarding Veto Errors

On June 10, 2025, the Attorney General released an opinion regarding the errors in the Governor's veto on Senate Bill No. 2014. The opinion indicated the Governor's objection letter, rather than his markings on the bill, demonstrated the intent of the line item veto.

The Legislative Management, in addition to the <u>legal analysis</u> previously provided by the Legislative Council, requested a <u>memorandum</u> analyzing the June 10, 2025, opinion.

Redistricting Litigation Update

On May 14, 2025, the U.S. Court of Appeals for the Eighth Circuit issued a significant decision in *Turtle Mountain Band of Chippewa Indians v. Howe*, holding that private plaintiffs may not bring lawsuits to enforce Section 2 of the Voting Rights Act through 42 U.S.C. § 1983. As a result, the appellate court vacated the district court's prior judgment, which had

imposed a redistricting map proposed by the plaintiffs, and ordered the case be dismissed for lack of a cause of action.



If the ruling stands, it will effectively reinstate the legislative district boundaries adopted by the Legislative Assembly during the 2021 special session, altering the current boundaries of Districts 9 and 15.
