

### Legislator Prefiling Deadline is Coming Up!



The bill prefiling deadline is quickly approaching. Legislators may prefile bills they wish to introduce for the 2025 legislative session through **Friday**, **December 20, 2024**. Bills must be prefiled using the Legislator Requests Application. By logging into your Requests Application (<u>full user guide linked here</u>), you can see all the bill drafts you requested during the interim

under your "Draft Requests" tab on your dashboard. Bill drafts that are complete will have a hyperlinked blue LC number.

If you would like to prefile a bill without adding any cosponsors, you can click the blue "Prefile" link to the far right of the bill draft LC number. If you would like to add cosponsors before prefiling, you can click on the "Request Cosponsors" tab and then the "Add/Edit" button to the right of your listed bill draft. Up to 5 cosponsors may be added on Senate bills and up to 11 cosponsors may be added on House bills. You



can set the deadline by which you would like your cosponsors to respond to your Desktop Icon cosponsor request. Once you have received confirmation from the desired number of cosponsors, you may prefile your bill by clicking on the "Requests Overview" tab and then on the blue "Prefile" link to the far right of your listed bill draft. This action will generate a pop-up summary box that lists any individuals who have agreed to cosponsor your bill and contains the final button to click to officially prefile your bill.

If you miss the prefiling deadline, you may resume filing bills on the first day of the legislative session. You may not add or remove cosponsors after you have prefiled your bill and prefiled bills only may be withdrawn from the floor after the legislative session begins. Prefiled bills will begin posting to the Legislative Branch website as they are processed.

# **From the Director**

Welcome to the first edition of *The Council*. Our goal is to share timely information regarding the legislative process and the activities of the Legislative Council. Also, we intend to include employee spotlights to help you better get to know the Legislative Council staff.

Because we know we will have to do some arm twisting to get staff members to "volunteer" for the spotlight, we are starting with the old-timers on the staff, Allen Knudson and me. With our 48 fulltime employees, we have a little over 300 years of experience. Allen and I account for nearly a quarter of those years with almost 75 years between us.

Because the most common questions being posed to me recently have related to the number of bill drafts being requested, my messages in the next few weeks likely will include updates on bill draft requests and introduced bills. We have received about 750 requests for bill drafts, which is similar to the number received by the first week of the 2023 legislative session. For several months, we have been trending about 1 to 2 months ahead of the previous interim's bill draft count. One area in which we have seen a decrease is the number of bills submitted by the judicial and executive branches through the agency bill introduction privilege.

We look forward to continuing with weekly updates and we welcome your comments and input.
