TESTIMONY OF

Joe Morrissette, Director of the Office of Management and Budget

Chairman Delzer and members of the House Appropriations Committee, I am Joe Morrissette, Director of the Office of Management and Budget. I am here to testify in support of House Bill No. 1025, which provides deficiency appropriations to eight different agencies. I will provide an overview of each request. Representatives from each agency are here to provide more detail and answer specific questions.

Secretary of State

The appropriation in subdivision 1 is to pay a court-ordered judgement in the case of Self Advocacy Solutions N.D. v. Jaeger, relating to election law. The judgement of \$97,500 was entered on October 23, 2020. Through June 30, 2021, interest of approximately \$87 is expected to accrue.

I ask that you amend this amount to \$97,587 to include accrued interest.

Office of Management and Budget

The appropriation in subdivision 2 is to pay a court-ordered judgement in the case of Brakebill v. Jaeger, relating to election law. The judgement of \$452,983.76 was entered on May 7, 2020. Through June 30, 2021, interest of approximately \$884 is expected to accrue.

I ask that you amend this amount to **\$453,868** to reflect the correct judgement amount and accrued interest.

We are now aware of two additional judgements that will need to be paid and I am asking for amendments to include the following:

- **\$103,000** for the court-ordered judgement and accrued interest in the case of Traynor Law Firm v. State, relating to the cost for removal proceedings against the Ward County Sherriff.
- \$40,025 for the court-ordered judgement and accrued interest in the case of SpoofCard, LLC v. Burgum, relating to a challenge to North Dakota's anti-spoofing law.

Attorney General

The appropriation in subdivision 3 is to pay the court-ordered judgement relating to the case of North Dakota Farm Bureau, Inc. v. Stenehjem relating to a federal challenge to ND corporate farm laws. The judgement of \$175,435 was entered on August 27, 2019. Through June 30, 2021, interest of \$5,707 is expected to accrue.

I ask that you amend this amount to **\$181,142** to reflect the correct judgement amount and accrued interest.

To simplify the bill and the process of paying these judgements, the amounts in subdivisions 1, 2, and 3 could be combined into one appropriation to the Office of Management and Budget, which could serve as the fiscal agent for paying these claims. If you choose to amend the bill in that way, the appropriation to OMB could be \$875,622 and current subsections 1 and 3 could be removed.

Tax Department

The appropriation in subdivision 4 is to meet deficiency needs in both the Homestead Tax Credit and Disabled Veterans Credit programs. These programs provide property tax relief for qualifying individuals. The Tax Department has a responsibility to reimburse the counties for property tax reductions granted pursuant to these programs. There is no authority for the department to withhold reimbursement or prorate the appropriated amount, so they must request a deficiency if actual program costs exceed appropriations.

The Homestead Tax Credit appropriation for 2019-21 is \$15.8 million and nearly \$8.4 million was spent in the first year. The deficiency request for the Homestead Tax Credit program is \$1.31 million.

The Disabled Veterans' Credit appropriation for 2019-21 is \$8,410,200 and over \$5.2 million was spent in the first year. The deficiency request for the Disabled Veterans Credit program is \$2.73 million.

North Dakota State University

The appropriation in subdivision 5 is a deficiency request of \$474,657 from NDSU to cover litigation costs relating to the A. Glenn Hill Center construction project.

Department of Health

The appropriation in subdivision 6 is a deficiency request from the Department of Health for COVID-19-related expenses. At the time the executive budget recommendation was finalized, the deadline for expenditure of Coronavirus Relief Fund moneys was anticipated to be December 30, 2020. Since that time, federal legislation has extended the timeframe to December 31, 2021. This change in federal guidance, as well as progress made responding to the pandemic and other factors, has diminished the need for this deficiency.

Department of Environmental Quality

The appropriation in subdivision 7 is a deficiency request from the Department of Environmental Quality for costs relating to the COVID-19 wastewater testing project for the period January 1, 2021 through June 30, 2021.

Adjutant General

The appropriation in subdivision 8 is the deficiency request for the Office of the Adjutant General is to repay Bank of North Dakota loans for disaster costs and Dakota Access Pipeline protest costs.

Mr. Chairman and committee members, this concludes my testimony. I ask for your support for House Bill 1025 with the requested amendments. I would be happy to answer any questions.

Chair and Committee Members: I am Dean Bresciani, President of North Dakota State University. I'm here today to provide information on one provision of HB1025 relating to litigation costs associated with the A. Glenn Hill Center on NDSU's campus.

After completing construction of the A. Glenn Hill Center in late 2015, the project's general contractor, Roers Construction, Inc. (the "GC") alleged that NDSU owed the GC an additional \$1,317,403 based on claimed delays and increased costs during the construction process. NDSU disputed the allegations, and NDSU was served with a lawsuit on January 16, 2018, which forced NDSU to defend itself in court. With the approval of the State Board of Higher Education and the Attorney General's Office, NDSU retained the law firm of Stinson LLP with offices in Bismarck and Minneapolis as litigation counsel.

Subcontractors and other parties involved in the construction project were brought into the litigation, and ultimately, there were a total of nine parties. Upon completion of extensive discovery, but prior to summary judgment motions and a possible trial, the parties reached a global settlement with the assistance of a mediator. The settlement negotiations were complicated because there were nine parties together with their attorneys and insurance companies. NDSU signed the settlement agreement on November 15, 2019 contingent upon the approval of the State Board of Higher Education, which was provided on December 3, 2019.

With this bill, NDSU is seeking repayment solely for the litigation costs associated this lawsuit, which totaled \$474,657. NDSU was required to defend itself against this suit and incurred substantial attorney's fees, expert fees, mediation fees and court costs as a result. We are asking for reimbursement for those costs. This bill would not be utilized for settlement payment purposes.

We ask that you pass HB1025 with this appropriation for NDSU. I, along with NDSU's litigation counsel, are available to answer your questions. Thank you.

TESTIMONY OF MAJOR GENERAL ALAN S. DOHRMANN NORTH DAKOTA NATIONAL GUARD BEFORE THE HOUSE APPROPRIATIONS COMMITTEE 29 JANUARY 2021 HOUSE BILL 1025

Good morning Mr. Chairman, members of the committee, I am Al Dohrmann, Adjutant General and Director of Emergency Services for the state of North Dakota. I am here today to testify in support of Subdivision 8 of House Bill 1025.

Subdivision 8 provides \$8,062,300 of loan authority from the Bank of North Dakota (BND), of which we are asking for \$3,130,540 for projected disaster related cost this biennium, and \$14,064,916 of BND loan authority to pay the remaining balance of the Dakota Access Pipeline protest loans with BND. The sum of these two loan repayments is now \$17,195,456. I will address the DAPL loan and will bring Mr. Schulz, our Director of Homeland Security, up to provide an update on the disaster costs.

Attachment #1 provides a breakdown of the DAPL cost and the payments made against loans totaling \$39,064,916 dating back to the Fall of 2016. As you can see, we have received \$10,000,000 of federal funds from a Department of Justice Emergency Law Enforcement Assistance Grant, along with \$15,000,000 of donations to pay down the principle, leaving us with \$14,064,916 in our deficiency. This amount is comprised of \$13,362,262 in principle and an estimated \$702,654 in interest through June 30, 2021.

Also within Subdivision 8 is \$8,062,300 for the state cost share related to presidentially declared disasters including the 2019 Spring flood (DR4444), the 2019 Fall flood (DR4475), the 2020 Spring flood (DR4553), the 2020 Summer flood (DR4565) and National Guard support for COVID-19 response efforts.

Before I turn it over to Mr. Cody Schulz, to update you on the four flood disasters declared throughout the biennium. I will address the now unneeded loan authority we received for National Guard COVID operations.

We received authorization of \$2,184,000 as a means to fund the 25% state cost share of the National Guard support to the COVID-19 response, which is included in the amount at page 2, line 18 of HB 1025. As of January 21, 2021, Federal Government announced they will retroactively fund 100% of the cost associated with all FEMA mission assignments for National Guard COVID operations through September 2021. With this new Federal authority, we will not need any of the loan authority for State Active Duty for COVID-19 response efforts; therefore, line 18 of page 2 can be reduced by this amount.

With that Mr Chairman, I will turn it over to Cody to provide an update on the remaining disaster declarations.

Good Morning Mr Chairman, and members of the committee. I am Cody Schulz, Director of Homeland Security. I would like to provide an update on the four flood disasters declared this biennium.

The four flood disasters incurred this biennium involved 30 counties throughout the state and have a total federal and state cost of \$42,241,560 with an estimated state cost share of \$5,750,160. Of this amount, we are estimating a need for \$3,130,540 to be paid out this biennium. This includes both principle and interest payments for the BND loan draws. The remainder or difference between the two state cost share figures we expect to be paid out in the 2021-2023 biennium and is part of our Appropriations request contained in HB 1016.

Mr Chairman, both of the items identified within Subdivision 8 are estimates and. any excess funding will not be expended.

We ask for your support of HB 1025 and will stand by for any questions you may have.



TESTIMONY OF

Joe Morrissette, Director of the Office of Management and Budget

Chairman Holmberg and members of the Senate Appropriations Committee, I am Joe Morrissette, Director of the Office of Management and Budget. I am here to testify in support of Engrossed House Bill 1025, which provides deficiency appropriations to various agencies. I will provide an overview of the bill. Representatives from each agency are here to provide more detail and answer specific questions.

Tax Department

The appropriation in subdivision 1 is the deficiency request for the Tax Department to meet deficiency needs in both the Homestead Tax Credit and Disabled Veterans Credit programs. These programs provide property tax relief for qualifying individuals. The Tax Department is required to reimburse the counties for property tax reductions granted pursuant to these programs. There is no authority for the department to withhold reimbursement or prorate the appropriated amount, so they must request a deficiency if actual program costs exceed appropriations.

The Homestead Tax Credit appropriation for 2019-21 is \$15.8 million and nearly \$8.4 million was spent in the first year. The deficiency request for the Homestead Tax Credit program is \$1.31 million. The Disabled Veterans' Credit appropriation for 2019-21 is \$8,410,200 and over \$5.2 million was spent in the first year. The deficiency request for the Disabled Veterans Credit program is \$2.73 million.

Adjutant General

The appropriation in subdivision 2 is the deficiency request for the Office of the Adjutant General to repay Bank of North Dakota loans for disaster costs and Dakota Access Pipeline (DAPL) protest costs. After the bill passed the House, I was made aware that the \$3.1 million loan repayment amount does not include accrued interest on the DAPL loan. It is calculated at a variable rate, so the exact amount of interest that will be accrued by June 30, 2021 is unknown. However, interest expense for the 2019-21 biennium is estimated to be between \$700,000 and \$750,000.

I ask you to consider increasing the Adjutant General deficiency appropriation by \$750,000 to ensure the state can pay the Bank of North Dakota the full amount of interest that will accrue by June 30, 2021.

Bank of North Dakota

The appropriation in subdivision 3 was added by the House to provide the partial repayment for the \$35 million loan authorized in 2019 Senate Bill 2001 for creation of the Theodore Roosevelt Presidential Library Endowment Fund. SB 2001 provides that the "governor shall repay the loan authorized in this section from funds appropriated by the legislative assembly." The loan was originated on November 13, 2020 and has a term that may not exceed six years.

Court-Ordered Judgements

Section 2 of the bill addresses state liability for court-ordered judgements. Pursuant to NDCC Section 32-12-04, a judgement against the state can only be paid by OMB when there is a specific appropriation for that purpose. The House version provides that these amounts be paid from the litigation funding pool appropriated to OMB for the payment of litigation expenses occurring during the 2019-21 biennium. The appropriation for this fund is \$3.5 million from the Strategic Investment and Improvements Fund. Through January 31, 2021, \$1,255,536 has been spent and \$2,244,464 remains unspent. The following amounts are requested for payment of judgements:

Secretary of State

 \$97,587 for the court-ordered judgement and accrued interest in the case of Self Advocacy Solutions N.D. v. Jaeger, relating to election law.

Office of Management and Budget

- \$453,868 for the court-ordered judgement and accrued interest in the case of Brakebill v. Jaeger, relating to election law.
- \$103,000 for the court-ordered judgement and accrued interest in the case of Traynor Law Firm v. State, relating to the cost for removal proceedings against the Ward County Sherriff.
- \$40,025 for the court-ordered judgement and accrued interest in the case of SpoofCard, LLC v. Burgum, relating to a challenge to North Dakota's antispoofing law.

Attorney General

 \$181,152 for the court-ordered judgement and accrued interest in the case of North Dakota Farm Bureau, Inc. v. Stenehjem relating to a federal challenge to ND corporate farm laws.

Other Deficiency Requests

Additional deficiency requests will be presented by:

- Department of Environmental Quality relating to COVID-related waste-water testing.
- Department of Human Services relating to the ability to transfer current biennium spending between line items to cover a potential shortfall in the community behavioral health program.





Chairman Holmberg and members of the Senate Appropriations Committee, my name is Cody Schulz. I am the Deputy Director of the Department of Emergency Services (DES) and Director of the Homeland Security Division. I offer this testimony in support of HB 1025 with the addition of \$750,000 for payment of interest to the Bank of ND on the outstanding loans for the Dakota Access Pipeline protest response.

Subdivision 2 provides \$3,130,540 to repay loans from the Bank of North Dakota (BND) for multiple flood disaster related cost this biennium. The original version of HB 1025 additionally identified \$14,064,916 to pay the remaining balance of the DAPL protest loans, including interest. The House did remove the DAPL portion in its entirety due to ongoing litigation, however in discussions with BND, the accrued interest through June 30, 2021 does need to be brought current. We are asking for an additional \$750,000 to cover the estimated interest on the DAPL loans. The sum of these two loan repayments is now \$3,880,540.

Attachment #1 provides a breakdown of the DAPL cost and the payments made against loans totaling \$39,064,916 dating back to the Fall of 2016. As you can see, we have received \$10,000,000 of federal funds from a Department of Justice Emergency Law Enforcement Assistance Grant, along with \$15,000,000 of donations to pay down the principal, leaving us with \$14,064,916 in our deficiency. This amount is comprised of \$13,362,262 in principal and an estimated \$702,654 in interest through June 30, 2021. We are asking for \$750,000 of funds due to variable interest rates between now and June 30, 2021. Any funds not utilized for the pay down of accrued interest will be turned back.


Subdivision 2 also identifies \$3,130,540 for the state cost share related to four presidentially declared disasters including the 2019 Spring flood (DR4444), the 2019 Fall flood (DR4475), the 2020 Spring flood (DR4553) and the 2020 Summer flood (DR4565).

The four flood disasters incurred this biennium involved 30 counties throughout the state and have a total federal and state cost of \$42,241,560 with an estimated state cost share of \$5,750,160. Of this amount, we are estimating a need for \$3,130,540 to be paid out this biennium. This includes both principal and interest payments for the BND loan draws. The remainder, or difference between the two state cost share figures, we do expect to be paid out in the 2021-2023 biennium and is part of our appropriations request contained in HB 1016.

Mr Chairman, both the amount identified within Subdivision 2, and the \$750,000 for DAPL loan interest are estimates and any excess funding will not be expended.

I ask for your support of HB 1025 with the noted addition and will stand by for any questions you may have.


