Chairmen Owens and members of the House Education Committee, my name is Michael Heilman and I am the Executive Director of the North Dakota Small Organized Schools (NDSOS). You are probably more familiar with my predecessor Mr. Elroy Burkle. I will not claim to have his grasp of school transportation funding but will use his expertise and past work to support my testimony.

Transportation is not an issue for just our small schools, it is a significant expense for all school districts providing transportation. The 154-member schools of NDSOS reflect most of the smallest and a few of the larger districts in the state.

The funding level in HB 1027 is identical to the funding level from the 2019 and 2017 legislative sessions. This is understandable given the current economic climate; however, transportation expenses continue to increase and NDSOS would support and greatly appreciate any increase to transportation funding.

The included tables reflect the historical funding for transportation and comparative funding for foundation aid from 2009 to 2021. State support for transportation goes back many decades and has gone from a high of 69.14% (92-93) to 39.67% in 18-19. While the state support for all programs (pupil aid, transportation, career and technical education, special education and other) has increased to 61%.

NDSOS supports HB 1027 with the recommended adjustments by Senator Schaible on page one to ensure that the next biennium reflects the better of the 2018-19 school year, or the prior year, whichever is greater.

- 3 Chairmen Owens and members of the House Education Committee, before you is a bill outlining
- 4 transportation payments for school districts for the upcoming biennium. Significant time was
- 5 spent during this interim on school district transportation costs and concerns regarding funding
- 6 based on funding levels, % of support, as well as new-found issues regarding the formula used and
- 7 how it translates based on the consequences of COVID this past year and this fall.
- 8 The funding here based on the dollars are held at an even level from the past biennium. Based on
- 9 our fiscal concerns this year we do understand why these numbers have been carried over. That
- being said transportation continues to be a struggle for school districts. With the rapid increase
- in staffing cost and equipment cost over the past decade, the rate of reimbursement has resulted in
- an ongoing decrease in % of state support for transportation. That state support being just about
- 13 40% this past biennium which is not reflective of the % of support overall for public education
- 14 from a state standpoint.
- 15 The greater struggle that we have in the upcoming biennium is due to circumstances beyond
- anyone's control yet are still impacted by the current formula. During the interim session this was
- 17 discussed, and recommendations were made on how to overcome this during this biennium. The
- suggested adjustment by Senator Schaible on page one to ensure that the next biennium reflects
- 19 the better of the 2018-19 school year, or the prior year whichever is great would create the
- 20 appropriate solution to get schools through this biennium.
- 21 With that adjustment we ask that you consider a positive report on this bill.

School district closure - Distribution of transportation payments.

- 1. If a school district ceases to exist, the superintendent of public instruction shall calculate the amount of transportation payments to which the former school district would have been entitled for providing transportation services during the school district's final year of operation and shall pay a percentage of the amount certified to each school district in the state which enrolls students who attended the former school district during the prior school year. Each school district eligible for payment under this section is entitled to receive the percentage of the total amount certified which is the same as the percentage of the number of the district's students who attended the former school district during the prior school year bears to the total number of students who attended the former school district during the prior school year.
- 2. The superintendent of public instruction shall pay the amount to which a school district is entitled under this section in the manner and at the time provided for other state payments in section 15.1-27-01.

SECTION 5. A new section to chapter 15.1-27 of the North Dakota Century Code is created and enacted as follows:

State transportation payments to school districts.

- 1. The superintendent of public instruction shall determine the total amount of payments to be made to the school districts for the transportation of students and shall pay the amount certified to each school district. Payments must be made in the same manner and at the time provided for other state payments in section 15.1-27-01.
 - A school district may not receive more than ninety percent of the actual costs incurred for the transportation of students.
 - 3. For purposes of this section, actual costs include the transportation operating expenditures reported to the superintendent of public instruction for the most recent year plus the eight-year average cost of transportation equipment determined by the superintendent of public instruction. Any district having contracted for transportation services may determine the actual costs for the first year the district provides its own transportation services by using the statewide average cost of transportation during the first year.
 - **SECTION 6. AMENDMENT.** Section 15.1-31-05 of the North Dakota Century Code is amended and reenacted as follows:


15.1-31-05. Open enrollment - Transportation.

A school district of residence may provide transportation to a student participating in open enrollment. If a district of residence does not provide transportation to a student participating in open enrollment, transportation may be provided by the admitting district. A school district may not receive transportation aid disbursements under subdivision a of subsection 1 of section 1 of this Act for transporting students who are participating in open enrollment, or who are enrolled pursuant to a written contract entered by the sending and admitting districts which waives the charge and collection of tuition for the student.

 - Fifty-two cents per mile [1.61 kilometers] for vehicles that have a capacity of (1) fewer than ten students: and
 - (2)One dollar and eleven cents per mile [1.61 kilometers] for schoolbuses that have a capacity of ten or more students; and
 - b. Thirty cents per one-way trip for each student transported.

Good morning Vice Chairman Elkin and Senate Education Committee. For the record My name is Senator Don Schaible, District 31. I am here to day to introduce HB 1027. This bill was the product of the Education Funding Committee this last interim of which I was the chairman.

The idea of this bill was for the state not to pay for transportation of an open enrollment student or tuition waver students outside of the residential district of where that student would live. That seemed like a simple bill to write and of course that was not the case. To make that simple change in code, we found out that existing language that we had and the current practice of how transportation was accounted for was different. This bill tries to correct that language with what we have been currently doing for years. Section 1 through 5 does that. Section 6 addresses the issue of cost of transportation outside on a student's district.

Dustin Assel of Legislative Council will walk through the sections of this bill and provide the rational of the changes suggested. With Mr. Chairman I would try to answer any questions that the committee may have.

TESTIMONY - HOUSE BILL NO. 1027 SENATE EDUCATION (ROOM - 216J - 9:00 A.M.) MARCH 9, 2021

Chairman Schaible and members of the Senate Education Committee, good morning. For the record, my name is Dustin Assel. I am a staff attorney with the Legislative Council. I staffed the most recent interim Education Policy Committee. House Bill No. 1027 (2021), which is before you today, was recommended out of the interim Education Funding Formula Review Committee. I was not the primary staff person on that committee, but I was involved with the committee and I did assist on drafting the legislation which is before you today. This testimony is provided in a neutral capacity. I am here only to provide background and information regarding the recommendations of the interim committee.

The bill was introduced by the Legislative Management at the request of the 2019-20 interim Education Funding Formula Review Committee.

Section 20 of 2019 Senate Bill No. 2013 directed a study of school transportation, including district routes, expenditures, reimbursement, and possible efficiencies. The study was assigned to the interim Education Funding Formula Review Committee. Currently, every session there is a section placed in the Department of Public Instruction's budget bill with language requiring student transportation aid payments to be made according to calculations under the formula as it existed on June 30, 2001. The department then references their aid payment worksheets that comply with the law as it existed on June 30, 2001, and updates the payment amounts to reflect current rates before making payments to the districts. Payments are done this way because during the 2001 legislative session, the Legislative Assembly completed a re-write of the K-12 education provisions and moved the rewritten provisions, including transportation aid payments, from title 15 to newly created title 15.1. However, the transportation aid payment codified sections were then subsequently repealed in 2003. As a result, there is not currently any language in North Dakota Century Code addressing student transportation aid payments, other than the session law language that is enacted each legislative session.

During the course of the interim committee's work on this topic, the committee asked for a bill that would recodify the transportation aid payment sections as they existed in 2001 with updated payment rates to reflect current practices.

EXPLANATION OF THE BILL

House Bill No. 1027 (2021) was recommended out of the interim committee and accomplishes the goals of the interim Education Funding Formula Review Committee. The bill consists of 6 sections. The bill creates 5 new sections to North Dakota Century Code chapter 15.1-27 regarding state aid to recodify the transportation aid payment sections as they existed in 2001 with updated rates, and amends section 15.1-31-05 regarding the transportation of open enrolled students.

The bill was also amended and engrossed by the House.

Section 1 of the bill lists the amount that the superintendent of public instruction shall pay each school district providing transportation in contract schoolbuses or district owned and operated buses. To reflect current practices and rates, the bill provides 52 cents per mile for vehicles with a capacity of 9 or fewer, and one dollar and eleven cents per mile for vehicles with a capacity of 10 or more. The section also provides for 30 cents per one-way trip for each student transported. Subsection 3 provides the reimbursement rate of 52 cents per day per mile one way for each mile over two miles for students transported by family transportation under section 15.1-30-02, which is the section on student transportation by family transportation. Subsections 4 and 5 reflect the law as it existed in 2001. There was a subsection 6 in the introduced bill which required the superintendent of public instruction to develop a uniform cost accounting system to calculate and administer the reimbursements. However, the

subsection was removed in the engrossment. I believe the subsection was removed because the accounting system already exists and the language is unnecessary.

Section 2 addresses transportation rates for special education students. Section 2 in the introduced version of the bill included language limiting a school district to one per student payment for transportation of a student, regardless of the number of times the student is transported during the day. The language was removed in the engrossment and the subsections were renumbered. The language in the current bill reflects the law from 2001 with updated rates, with the exception of the aforementioned amendment, with the same amounts as provided in section 1 of the bill.

Section 3 addresses the transportation of Career and Technical Education students. The language references and reflects the rates laid out in section 1 of the bill. Similar to section 2, section 3 of the bill also included language limiting a school district to one per student payment for transportation of a student, regardless of the number of times the student is transported during the day, in the introduced version of the bill which was removed in the engrossment.

Section 4 addresses the distribution of payments in the event of a school district closure and reflects the language of the previous law before the sections were repealed. This section was not affected by the amendment that created the engrossed version.

Section 5 addresses state payments to school districts and the procedure the superintendent of public instruction must follow when making the payments. The language reflects the law as it existed in 2001 before the sections were repealed. Subsection 2 states that a school district may not receive more than 90% of the actual cost incurred, which is a limitation that existed under the law before the sections were repealed.

Section 6 amends language in section 15.1-31-05 regarding the transportation of open enrolled students. Per request of the interim committee, language was added to the section to disallow transportation aid payments in situations involving tuition waiver agreements between school districts. The language prohibits a school district from receiving mileage payments under section 1 of the bill for transporting open enrolled students, or students transported by family transportation, who are enrolled pursuant to a tuition waiver agreement between school districts. The section still allows the district to receive the ridership payment provided for under subdivision b of subsection 1 of section 1 of the bill.

Chairmen Schaible and members of the Senate Education Committee, my name is Michael Heilman and I am the Executive Director of the North Dakota Small Organized Schools (NDSOS). Transportation is not an issue for just our small schools, it is a significant expense for all school districts providing transportation. The 154-member schools of NDSOS reflect most of the smallest and a few of the larger districts in the state.

The funding level in section 1 subsection 1 of HB 1027 is identical to the funding level from the 2019 and 2017 legislative sessions. This is understandable given the current economic climate; however, transportation expenses continue to increase. The included tables reflect the historical funding for transportation and comparative funding for foundation aid from 2009 to 2021. State support for transportation goes back many decades and has gone from a high of 69.14% (92-93) to about 40% in recent years a decline of nearly 30%. At the same time the state support for all programs (pupil aid, transportation, career and technical education, special education and other) has increased to about 60%.

NDSOS supports HB 1027 but would ask the committee consider language that would allow districts to have their payments based on the last year of complete data, the 2018-2019 school year or the prior year whichever is greater. NDSOS feels this adjustment is needed and the data provided supports that the 2019/2020 school term busing data was significantly impacted by schools being closed to face-to-face instruction after March 13. Also, many districts' transportation data for the current school term will be impacted due to hybrid learning models that were in place for a significant part of this school year. NDSOS supports language that would allow district transportation payment to be calculated reflecting the anomaly that COVID 19 has created for the past two school terms. That language would read as follows:

for the 2021-2022, and 2022-2023 school years, ridership and mileage payments shall reflect the better of the 2018-19 school year or the prior school year, whichever is greater.
