House Bill 1031

Government Finance Interim Committee was charged with studying the multiple fees that are charged by our agencies. The Auditors office was charged with gathering information on fees and presenting to the committee. We received that information in Feb. 2020.

The study found that there are approximately 1200 fees charged by state agencies. This does not include fees charged by North Dakota University System.

Included is some fee examples that have a significant gap between and time established and the last time modified.

Public Service Commission's grain storage license fees were established in 1895 and the last time they were modified was in 2005.

Secretary of State has tree mandated fees established in 1901 that had only been changed in the early 1990's.

A large number of the state agency fees were established in the early 1900's for which the fee amount is determined by the agency. The language authorizing these the agency to charge those fees has not been changed since establishment.

There are several license plates fees that have not changed since they were established in the late 1950's to early 1960's.

Some examples and fee numbers: Secretary of State 315 fees, Information Tech. 125 fees. NDSU Extension 59 fees.

We wanted it to be determined whether the fee covers the cost of administering this fee. That proved very difficult because some employees do multiple tasks and do not track their time for each task. Many of the fees are deposited in common funds which contribute to the difficulty of determining costs.

House Bill 1031 is an effort to start addressing some of these issues, such as are these fees appropriate, if they are appropriate, and should changes be made, including eliminating them.

It requires all fees are studied every 10 years and establishes a procedure for the studies and what they need to be to address. Legislative Management will establish which fees are studied and what committee will study them.

House Bill 1031

Government Finance Interim Committee was charged with studying the multiple fees that are charged by our agencies. The Auditors office was charged with gathering information on fees and presenting to the committee. We received that information in Feb. 2020.

The study found that there are approximately 1200 fees charged by state agencies. This does not include fees charged by North Dakota University System.

Included is some fee examples that have a significant gap between the time established and the last time modified.

Public Service Commission's grain storage license fees were established in 1895 and the last time they were modified was in 2005.

Secretary of State has three mandated fees established in 1901 that had only been changed in the early 1990's.

Many state agency fees were established in the early 1990's for which the fee amount is determined by the agency. The language authorizing these the agency to charge those fees has not been changed since establishment.

There are several license plate fees that have not changed since they were established in the late 1950's to early 1960's.

Some examples and fee numbers: Secretary of State 315 fees, Information Tech. 125 fees. NDSU Extension 59 fees.

We wanted it to be determined whether the fee covers the cost of administering this fee. That proved very difficult because some employees do multiple tasks and do not track their time for each task. Many of the fees are deposited in common funds which contribute to the difficulty of determining costs.

House Bill 1031 is an effort to start addressing some of these issues, such as are these fees appropriate, if they are appropriate, and should changes be made, including eliminating them.

Legislative Management will establish which fees are studied and what committee will study them.

Thank you Chairman and Members of Senate GVA,

My name is Vicky Steiner, District 37, Dickinson, ND

Because of COVID, the interim committee assigned this topic by Legislative Management had limited time to discuss it. the GVA committee added some needed clarifications with the approval of the interim chair of Govt Finance.

The bill addresses the issue of agency fees. Fees are a type of tax. There are currently 1257 fees applied to citizens by agencies. 355 fees are deposited in the general fund, others are deposited in the operating budget.

The bill seeks to inform the legislative body about the fees. Because of the number of fees, the project is split in two - year and four-year report time increments. Agencies like ND Game and Fish run by fees will not be included in the study. Its fees that go to the General Fund and part of an operating budget.

In Section 1, agencies that have less than 40 fees, the agencies have until July 1 of 2022 to make a simple explanation on each fee to the Office of Management and budget as described in the bill. OMB is agreeable to supervising and providing a compiled report for legislators by Sept. 1 in the even year of biennium. If the agency is unable to get the task done, they can ask for an extension from legislative management. Agencies with 41 or greater fees, and there are 7 of them, they will have 4 years to compile information on their fees. There was some concern about the time it might take agencies with large numbers of fees so they have 4 years to work on it. New fees, moving forward, may not come thru administrative rule but can come thru statute, Budget section or emergency commission. Each biennium as fees are deleted, increased or decreased, legislators will be notified of the changes thru legislative management reports.

Section 2 is a shall consider study. The study is not about specific fees but as a legislature, what are our expectations and guidelines to the state agencies regarding their creation of fees in the future. The study may inform us what the dollar amount is for the fees deposited in the general fund. We have the ultimate responsibility for the fees that our citizens pay. The emergency clause is so that agencies can begin work as soon as possible.

I stand in support 1031. Thank you for your consideration.

Mr. Chairman and members of the committee - I'm Robin Rehborg, Deputy Director for Driver Safety at the North Dakota Department of Transportation (DOT). I am here to provide you information regarding fees charged by the Department as it pertains to HB1031. Thank you for your time today.

The DOT's Driver License and Motor Vehicle Divisions collect funds through fees charged for services or products provided to the citizens of our state. There are over 100 different fees collected by these two divisions. The fees charged have been set according to North Dakota Century Code (NDCC).

The Driver License Division provides identification, licensing, and driver record management services. A variety of fees are collected for services or products provided and range from a written test fee to a crash report fee. All funding collected from Driver's License fees are deposited into the state Highway Fund per NDCC §39-06.2-19 and §39-06-49.

The Motor Vehicle Division administers programs relating to titling and registration of vehicles, including the motor vehicle excise tax. The division regulates motor vehicle dealers, interstate motor carriers, mobility-impaired parking privileges, and intrastate household goods carriers. A variety of fees are collected for different services and products provided, which can range from a title fee to a special license plate fee. Motor Vehicle fee collections are distributed to various other funds, but the Motor Vehicle program is funded before collections are distributed to other areas, per NDCC §39-04-39. For instance, the abandoned vehicle fee required by NDCC §23.1-15-11 is distributed to the Department of Environmental Quality.

Most transactions processed by the above-mentioned divisions have multiple fees attached to it. Here are a couple of examples:

Driver license: A written knowledge test fee is \$5, if passed there is also a \$15 license/permit fee. For a total of \$20.00. These are completed in the same transaction.

Motor Vehicle: When registering a vehicle there are multiple fees depending on the situation. For this instance, the entity is tax exempt, but will still pay the following fees:

It would be a complex and time-consuming project for DOT to calculate costs tied to each fee as described in Section two (a) of this bill. It would take a significant amount of time, requiring each transaction to be tracked individually to obtain the costs per fee. We have participated in similar studies in the past and have not been able to develop cost data to the detail required since most transactions have multiple fees required by multiple sections of statute.
