Good morning Chairman Vedaa, members of the committee, my name is Ryan Gardner, West Regional Manager for the North Dakota Parks and Recreation Department. I am testifying on behalf of the Department in support of SB 2093.

The North Dakota Parks and Recreation Department (NDPRD) vision is to enrich generations through experiences that connect people to places. We wish to pursue changes to section 55-08-05, specifically subsections 6 and 7, to allow NDPRD to better meet our local communities' requests, visitors needs and align with national trends.

The NRPRD oversees a total of 15 destination properties. Across these locations, the agency has 16 rental meeting spaces and dozens of outdoor gathering locations such as picnic shelters, amphitheaters, and acres of open green space. Driven by the need for rental space amongst many of our rural communities and our locations' inherent beauty, NDPRD continues to grow as a popular venue for weddings and other community events.

Currently, subsections 6 and 7 of century code 55-08-05 allow for the limited sales of alcohol by concessionaires on Fort Abraham Lincoln State Park's premises and the three properties NDPRD has located on United States Army Corps of Engineers land around Lake Sakakawea. These include Lake Sakakawea State Park, Fort Stevenson State Park, and Lewis and Clark State Park. These four locations makeup a quarter of our destination properties and mainly only service the communities located along the Highway 83 corridor.

As it stands now, visitors can bring their own alcoholic beverages onto NDPRD properties for consumption, given they follow all current state and local laws. Neither the individual nor the agency can bring in a vendor to provide such a service at this time at sites not described in subsections 6 and 7. This results in lost opportunities for local partnerships, local businesses, customer experiences, and Department revenues.

The proposed changes to subsections 6 and 7 creates equity and operational consistencies throughout the Department's portfolio. NDPRD can respond to the changing demand from our visitors and our nearby communities by allowing the appropriate concessionaires the opportunity to provide a service during events held by the public, the agency, and the community.

Therefore, the Department supports SB2093. Mr. Chairman, I would be happy to stand for questions.

Chairman Vedaa and Members of the Senate Government and Veterans Affairs Committee:

On behalf of the brewpubs, taprooms and members of the North Dakota Brewers Guild, we urge the Committee to render a DO PASS vote on Senate Bill 2093 as drafted at the request of the North Dakota Parks & Recreation Department. In particular, the changes in paragraph 6 offer licensed craft beverage producers an opportunity to showcase their products at properly permitted events at State Parks.

We appreciate the bill language clarifying and simplifying conditions to participate in events in state parks. This Century Code language provides potential opportunities for NDBG Members to sell locally made beverages which support small businesses across North Dakota and makes sense as tourism and destination trends continue to evolve.

North Dakota is home to almost 30 brewpubs and taprooms across the state and each one contributes to their local communities with charitable efforts, investments and employment. Additionally, our industry directly supports North Dakota's agriculture economy by using home grown grains to produce our products, generating more than \$200 million of annual economic impact.

Again, we respectfully request the Committee to give favorable passage to SB 2093. As always, we invite Committee Members to schedule a tour and a briefing at one of our North Dakota Brewers Guild Members to learn how this industry continues to support tourism and the economy of our State.

These include Lake Sakakawea State Park, Fort Stevenson State Park and Lewis and Clark State Park. These locations make up only 27% of our destination properties and mainly only service the communities located along the Highway 83 corridor.

The proposed changes to subsections 6 and 7 would allow NDPRD to best adapt to the changing demand from our visitors and our nearby communities by allowing the appropriate concessionaires the opportunity to provide a service during events held by the public, the agency and the community. It would also expand these opportunities across the state and not limit it to those four locations as earlier mentioned.

- 4 **SECTION 1. AMENDMENT.** Section 55-08-05 of the North Dakota Century Code is amended and reenacted as follows:
- 6 55-08-05. Charges for services.

- The director may provide special services within state parks, state campgrounds, state recreation areas, and reserves; provide special technical assistance services; and make rules for the use of those services. The director shall establish and cause to be collected charges, fees, and rentals for the use of all special services, and shall revise the same, when necessary, in the manner that the revenue derived will be sufficient to pay the cost of providing each service and to pay the principal of and interest on all bonds issued for projects furnishing the facilities for the services, and to maintain a reserve for the security of the bonds. The director may waive the collection of charges, fees, and rentals for the use of special services by health care-related charitable organizations conducting group camp activities without charge to participants. However, the director shall waive the collection of charges, fees, and rentals for the use of all special services by any care-related charitable organization sponsoring or conducting summer group camp activities without charge for fourteen days for children from age eight through age fourteen who have diabetes. Nothing in this section requires the director to provide camp services if the camp facilities are otherwise closed due to adverse administrative or fiscal impacts upon the department. Specifically, the director may:
 - Provide special parking space for automobiles or other motor-driven vehicles in any state park or state recreation area.

- 2. Provide special parking spurs and campgrounds for automobiles and sites for tent camping and special auto trailer coach parking spaces for the use of the individual charged for the space according to the daily rate which must be determined and fixed by the director consistent with the type of facility provided for the accommodation of visitors in any particular park and with similar facilities offered for tourist camping in the area.
 - Charge a fee for entrance to any pageant grounds created in any state park, state
 recreation area, or reserve for the purpose of having historical or other pageants
 conducted by the agent of any authorized agency.
 - 4. Provide water, sewer, and electric service to trailer or tent campsites and buildings and structures included in projects authorized by the legislative assembly.
 - 5. Provide facilities and allow for the sale to the public of food, nonintoxicating beverages, exceptand beer and wine sales as provided in subsectionssubsection 6 and 7, and other merchandise and personal services of a suitable nature, and make buildings, structures, and other recreational facilities available for use and occupancy by the public, or contract for the use of food trucks or the lease of the buildings, structures, and facilities to a concessionaire to be operated on the terms and compensation basis as the director determines to be in the best interest of the state. The duration of a concession agreement may not exceed twenty years. A bond must be required of each concessionaire in the amount the director determines, conditioned upon the faithful performance of all duties under the lease and proper accounting for all funds.
 - 6. Allow the sale of beer and wine by operating concessionaires on property leased to the department by the United States department of the army, corps of engineers under the management of the director, if the concessionaire also obtains holds the appropriate local and state retail licenses or an event permit required or authorized by section 5-02-01 chapter 5-02.
 - 7. Allow the sale of on-sale beer and wine by operating, liquor-licensed concessionaires for fourteen events per year on property under the management of the director which borders the Missouri River and which is within fifteen miles [24.14 kilometers] of a city-

- 1 with a population in excess of twenty thousand, if the concessionaire also obtains the 2 appropriate local and state licenses required by section 5-02-01. 3 8. Charge and collect motor vehicle permit fees in the amounts prescribed by the 4 legislative assembly, which fees are and must be imposed for the sole purposes of 5 paying capital costs of projects required to provide the special services herein 6 described and referred to, and of meeting the principal and interest and reserve 7 requirements of bonds issued to finance such projects. 8 9.8. Charge a fee for providing special technical assistance to groups requesting 9 information from the natural heritage inventory database. 10 10.9. Allow the sale of advertising in parks and recreation publications. The director may 11 make rules regarding advertisement contracts and charges, space availability, and 12 content.
 - **SECTION 2. EMERGENCY.** This Act is declared to be an emergency measure.
