I will keep this brief. SB 2235 seems much like a replica of SB 2136 passed out of this committee and out of the senate chamber recently with a unanimous do pass. This bill attempts to replicate an amendment recently brought on the floor of the Senate that failed which removes the requirement to attend a college with a physical presence in this state. One of the beautiful things that our state scholarships does is keeps our students in the state of North Dakota thereby increasing the odds that we will keep them in our workforce.

- 12 This investment is also an investment in our North Dakota colleges and programs which keeps the
