### HB 1518 – House Judiciary

Good morning, Chairman Klemin and members of the House Judiciary. My name is Jaci Hall and I am the Executive Director of the North Dakota Association for Justice. I am here today in support of HB 1518.

Every 68 seconds in this country a sexual assault happens. Every nine minutes that assault involves a child. In 2021, the Attorney General's Office indicated that 1,089 sexual offences under Chapter 12 were investigated.

North Dakota is not immune to these predators. With the rise of social platforms and opportunities for predators to find and assault men, women and children; support for victims is crucial.

A few weeks ago, this committee heard HB1145. It provided support to sexual assault victims who develop a disabling mental condition due to an attack. 99% of all victims suffer from a temporary or permanent mental illness after being assaulted. Although the bill was amended, HB1518 provides support the victims need to start the heal, while HB1145 gives them time to seek these services.

Victims should not be silenced or rushed to relive their trauma until they are ready. HB1518 gives victims the rights and the support they need to start the healing process.

I urge the committee to make a DO PASS recommendation on HB1518. I stand for questions.

I am submitting testimony in support of SB 1518 with amendments.


CDFNE is a North Dakota based non-profit organization providing forensic medical services to children and adult survivors of sexual assault in western North Dakota. Our organization serves individuals in 23 counties, with our headquarters in Bismarck. CDFNE nurses work with a variety of partners including law enforcement, advocacy agencies, and children's advocacy centers, as part of local sexual assault response teams. CDFNE currently has 22 Sexual Assault Nurse Examiners on staff who work throughout our service area.

Whether in the acute, delayed, or follow-up setting, our nurses see firsthand the effects of sexual violence. Sexual violence can have lasting impacts on a survivor's life. Therefore, we believe that trauma-informed care, privacy, safety, and the rights of survivors are vital. We must do all we can to lessen the burden on those who were assaulted and provide them with as many tools as possible to help them to reclaim their lives.

CDFNE has concerns with the original version of this bill. We have worked with the bill sponsor and other advocacy organizations regarding those concerns, which were addressed through amendments.

Therefore, today I am asking you to give a DO PASS recommendation to SB 1518 with amendments.

Chairman Klemin and members of the Committee, my name is Seth O'Neill and I am representing CAWS North Dakota in support of HB 1518. In 2021, our member programs served 1,139 new victims of sexual assault. Nationwide, one in four women and one in nine men report being sexual assaulted during their lifetime. HB1518 would provide for a list of rights that sexual assault survivors are entitled to. This would ensure that sexual assault survivors are notified of these rights and can assert them throughout the criminal justice process.

We have conferred with the bill sponsor on a few suggested amendments that provides clarity to the bill and conforms to current North Dakota law. Additionally, I would like to point out that most of the rights in this bill are already listed under 12.1-34-02. However, it is my understanding that the bill supporters would like a separate section specifically delineating the rights of sexual assault survivors. The new rights are the right to access the law enforcement report and acute forensic medical exam and the right to have an attorney or sexual assault advocate present when speaking to law enforcement.

We encourage the committee to give HB1518 a do pass recommendation with the amendments brought forward by Rep. Richter. I appreciate your time and I am happy to answer any questions you may have. Thank you.

### A CLOSER LOOK &



At least **298** of primary victims were under the age of 18 years old at the time of the assault(s).

In adult cases, 9% of the assailants were strangers. In child cases, 3% of the assailants were strangers.

In at least 29% of all cases, the assailant was a friend/acquaintance/date of the victim.

At least 32% of the assaults occurred in the victim's or assailant's home.

28% of new victims were people with disabilities. Of those, 18% were people with developmental disabilities. 23% had physical disabilities and 59% were people with mental health disabilities.

48% of the crimes were reported to law enforcement.



27% of adult victims contacted a sexual assault center about the crime within 2 days of the assault. 13% of adult victims contacted a sexual assault center within 3-30 days after the assault.



### ADVOCACY

- At least 14,976 services were provided to primary victims by crisis center advocates from January to December 2021.
- At least 22% of the victims were referred to sexual assault service providers by themselves, friends, or family members.

My name is Hanna Johnson and I'm grateful to be speaking to my home state in favor of HB 1518.

Today, I am here to advocate for survivors of sexual violence. I do not speak for only myself, but of the more than 125,000 survivors in the state of North Dakota. I am asking you to see us, to hear us, and to help us change the law.

I have been formally working to secure justice for survivors of sexual violence for seven months across the nation, but it is now a source of pride and joy for me that I can testify in favor of this bill in the state that raised me.

Sexual violence is an epidemic in every state in the United States of America, and legislation is needed now to act on this. The law as it currently stands often causes survivors to feel re-traumatized. While we can't make the experience of an assault any easier, we can help survivors feel a little less burdened by our judicial system. Every additional right is important, and I believe that is why this bill is essential. Survivors deserve to know that their state legislature supports them, and even the inclusion of one or two more rights could be life-changing for a survivor who wants to pursue justice.

Today, you have a chance to make history by helping to improve the lives of survivors. You have the opportunity to join 40 other states, two separate sets of the U.S. Congress, and the United Nations in guaranteeing these rights for survivors. Sexual violence transcends party lines and it affects all of us in some capacit. To improve the way that survivors experience the justice system after trauma, action is needed now. I stand with survivors. Do you?

Although not in-person, I want to express my gratitude for allowing me to submit written support and testimony for HB1518. My name is Tegan Amundson and I am writing to show my support for further protections for survivors of sexual violence in North Dakota. Not only as an individual, but as a family member, friend, and community supporter, I ask you to stand up for those who deserve unequivocal justice and support from the place they call home.

As a native of our great state, my whole life I have felt the love and support of my close-knit community. Yet, I have been witness to multiple loved one's who have survived sexual violence. Because even when safety seems tangible, ~76% of survivors knew their perpetrator. And as a young adult, it is even more disheartening to know that 83% of my peers who are 25 and under have experienced some form of sexual violence. This epidemic has found its way into schools, work, and personal spaces that should traditionally provide safety.

All of this is to say, sexual violence is a life-altering event for anyone to endure. By codifying further protections into our legislation, we can give survivors the right to justice that they deserve. Furthermore, by building out these protections, we are supporting a vision of a future in which survivors can hold their perpetrators accountable with no fear of backlash from a broken legal system. This issue is nationwide, but here in North Dakota HB1518 is offering an opportunity to implement changes that are critical to providing survivors with resources. I hope that you all will take this testimony and the others like it as proof that North Dakotans desire progress and treat this bill with the dedication that it deserves.

- 1 A BILL for an Act to create and enact a new section to chapter 12.1-34 of the North Dakota
- 2 Century Code, relating to rights of a sexual assault survivor.

#### 3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1.** A new section to chapter 12.1-34 of the North Dakota Century Code is created and enacted as follows:

### Sexual assault survivor rights.

- 1. As used in this section:
  - a. "Sexual assault counseloradvocate" has the same meaning as "counselor" as defined in section 43-47-01. The term includes means a victim witness advocate or a domestic violence sexual assault advocate certified under rule 34 of the North Dakota Supreme Court Administrative Rules.
  - b. "Sexual assault survivor" means an individual who is a victim of a crime defined under chapter 12.1-20 and, if the survivor is incompetent, deceased, or a minor who is unable to consent to counseling services, the parent, guardian, spouse, or any other individual related to the survivor by consanguinity or affinity to the second degree, or any other lawful representative of the survivor, unless the individual is the alleged assailantsection 12.1-20-03, 12.1-20-03.1, 12.1-20-04, 12.1-20-05, 12.1-20-05.1, 12.1-20-06, 12.1-20-06.1, 12.1-20-07, 12.1-20-11, 12.1-20-12, 12.1-20-12.2, or 12.1-20-12.3.
- 2. In addition to the rights provided under section 12.1-34-02, a sexual assault survivor must be afforded the following rights where applicable:
  - a. Preservation of evidence. A prosecuting attorney, law enforcement authority, criminal laboratory, or evidentiary storage facility may not destroy or dispose of

1 any evidence to a criminal offense before the limitation period for prosecution for 2 the offense has ended or the offense has been adjudicated. 3 <u>b.</u> Services available. To be informed by the prosecuting attorney and arresting law 4 enforcement agency of all appropriate and available public or private programs 5 that provide sexual assault counseling, treatment, or support for sexual assault 6 survivors, including rape crisis centers, assistance programs, victim assistance 7 hotlines, and social service agencies. 8 Notice. To be informed by the prosecuting attorney of their rights provided under <u>C.</u> 9 this chapter. 10 Acute forensic medical examination. When an acute forensic medical d. 11 examination is performed, the costs incurred by a health care facility or health 12 care professional for performing the acute forensic medical examination or any 13 preliminary medical screening examination may not be charged, either directly or 14 through a third-party payer, to the alleged sexual assault survivor. 15 <u>(1)</u> If the sexual assault survivor is a child, the costs incurred by a health care 16 facility or health care professional for performing the child forensic medical 17 examination or any preliminary medical screening examination may not be 18 charged, either directly or through a third-party payer, to the alleged child 19 sexual assault survivor or the child's parent, guardian, or custodian. 20 Upon submission of appropriate documentation, the attorney general, within <u>(2)</u> 21 the limits of legislative appropriations, shall reimburse the health care facility 22 or a health care professional for the reasonable costs incurred in performing 23 the medical screening and acute forensic medical examination. 24 Access to report and record. Upon request of the sexual assault survivor over the <u>e.</u> 25 age of eighteen, the prosecuting attorney, law enforcement authority, or health 26 care facility shall provide the survivor with a copy of the law enforcement report 27 corresponding with the victim's case number and the survivor's acute forensic 28 medical examination record. 29 Counsel.
