Madam Chair & Distinguished Members of the North Dakota Legislature:

My name is Jonathan O'Keefe, co-founder and owner of Strive Life Grand Forks. Strive Life Grand Forks was the only locally owned medical cannabis dispensary originally selected that is governed by the North Dakota Department of Health, Division of Medical Marijuana. Strive Life Grand Forks opened in May 2019 and was the second medical marijuana dispensary in the State of North Dakota.

I want to begin my testimony with gratitude. I am grateful for the leadership shown by the North Dakota legislature for molding the policy in century code for medical marijuana that was passed by North Dakota's citizens in 2016. Your support has helped thousands of North Dakotans seek a medical alternative that was not available to them prior to 2019. These North Dakotans, many of whom are Veterans of our military, seek relief from cancer, epilepsy, anxiety, and many more life-threatening diseases. We have been able to deliver this care under the safe and sanctioned supervision of the State. Help is delivered, and the community is safe and protected.

I am here as a business owner, state and federal tax payer, and North Dakotan whose family has been in North Dakota since it became a state. I graduated from the University of North Dakota, and am raising my family in Grand Forks. Prior to Strive Life Grand Forks, I operated three McDonald's franchises in North Dakota and Minnesota.

I am here today to testify in favor of Senate Bill 2201. A medical cannabis dispensary owner faces significantly more challenges than a traditional business owner. Unlike a traditional business, a dispensary or cultivation center, while legal to operate in North Dakota, is categorized as federally illegal. Despite being federally illegal, a dispensary or cultivator will pay up to 11% in federal taxes yearly. Guidelines drawn by the federal government mandate these businesses follow 280E tax law. Under 280E these businesses are not allowed to write off some of the most common business-related transactions such as lodging, gas or employee uniforms. Outside services all come at a premium price. Dispensaries and cultivators must hire specialized tax, legal and payroll consultants to remain compliant with State and federal law. Another obstacle is banking. FDIC insured banks will not bank these businesses, and that includes our state-owned bank.

Dispensary and cultivation owners pay tens of thousands of dollars to comply with the law, pay hundreds of thousands of dollars in State and federal taxes, and take extraordinary personal risk to do so.

I state these facts to give a broader view of the challenges these State-sanctioned businesses face. North Dakota compassion center certification for cultivators is \$110,000 and dispensaries are \$90,000. These are some of the largest fees in the country — more than Illinois, Oregon, Missouri, or Arizona, for instance. The State of North Dakota cannot change federal tax law or provide for safe federal banking. But the State of North Dakota does control this fee.

A reduction in fees will ease the burden State-sanctioned cannabis dispensary and cultivators face. The relief will help us pay our fair share of State and federal taxes, and will be put to good use paying for the specialized support we require unless or until safe banking is legal. We are North Dakota based businesses asking for your help. This change will have a positive impact on the residents employed by us and the patients we serve. Your leadership made this business possible and now I ask for your help in making them fiscally viable. Please support Senate Bill 2201 and help support the nearly 9,000 patients we serve across North Dakota.

Senate Bill 2201 Human Services January 18, 2023, 10:30

Good morning, Chairwoman Lee and members of the Senate Human Services Committee. My name is Jason Wahl, Director of the Medical Marijuana Program within the Department of Health and Human Services (Department). I am here to provide information regarding the fiscal note to Senate Bill 2201. The Department is neutral on the reduction of registration certification fees and agent fees.

The fiscal note submitted identifies a total reduction in revenue of \$358,000. This is due to the following two changes in state law:

- 1. A fee reduction of \$30,000 paid once every two years by manufacturing facilities and dispensaries. One dispensary is not impacted by the reduction as an administrative rule (NDAC Section 33-44-01-07.3) has the fee of the dispensary established at \$30,000 (located in a city with a population of 10,000 or less).
- 2. A fee reduction of \$100 paid once a year for agents of manufacturing facilities and dispensaries.

This concludes my testimony. I am happy to answer questions you may have.

Good morning, Madam Chair and members of the Human Services committee.

First, I just want to state that this is simply a business bill. I get that it's hard to ignore the product in which we're discussing, but I'm hopeful we can find a way to keep this valuable industry viable.

How did we get here? In 2016 voters approved the North Dakota Compassionate Care Act which created the medical marijuana program. The 2017 legislative assembly passed SB 2344 to provide the legalization of medical marijuana and required the State Department of Health to establish and implement a medical marijuana program to allow for production, processing, and sale of marijuana for medical use.

The reason I decided to introduce this bill madam chair came after reviewing the Medical Marijuana Program annual report. Something that stood out to me on page 7 of the report was there are now only three companies that own the eight registered dispensaries.

I decided to reach out to stakeholders across the state and see what obstacles they encounter within the program. Some of the items we have no control over, for instance, Insurance costs. Due to the nature of the business and risk involved annual premiums are heightened. Banking, traditional banking is difficult for this industry, again because of the product and the fact it is often cash intensive. This has increased costs, not only in monthly fees but also paying a percentage fee based off each deposit. Finally, tax codes. IRS Revenue Code 280E. For the record I am not an accountant, so I pulled this information from IRS.gov and this tax code deals with marijuana businesses. While many businesses can deduct normal overhead expenses, like advertising expenses, wages and salaries, and travel expenses. These small businesses, which provide a valuable service to our state's citizens with debilitating medical conditions, unfortunately cannot.

What can we do? We can take a serious look at the fees we charge these businesses in this industry. From what I remember in 2017, the registration fee for compassion centers was to make sure reputable business leaders were investing into this market space. Also, it was to help provide funding to get this industry off the ground and remain self-sustaining.

I decided to look up fees from other states, but I couldn't find a chart that spells out every state's fee charged to register and operate a dispensary, so I went to the department of health for the following states:

- Oregon \$4,000/annual
- Missouri \$10,000/annual
- Virginia \$10,000/annual
- Illinois \$60,000/biennium

I can't speak with certainty that North Dakota has the highest rates, but I am fairly certain they are one of the highest. This bill, as written, would reduce us to be in line with Illinois, but Illinois based off 2021 stats had 156,000 medical marijuana card carriers compared to our state's 7,958 qualifying patients.

The next item I would like to highlight is found on the top of page 8 of the annual report. This breaks down the expenses and revenues of the program since its inception in 2019. As you can see the state is netting approximately \$600,000 per biennium.

Madam chair, this bill's intent is to reduce the registration fees and renewal fees for Compassion Centers. Currently manufacturing facilities are charged \$110,000 per biennium and dispensaries are charged \$90,000 per biennium. This bill would reduce each by \$30,000 a biennium.

Manufacturing facilities would now pay \$80,000 a biennium, which is a 27% decrease, and dispensaries would pay \$60,000 a biennium or a 33% decrease.

If you remember from the fees charged by other states, we are still one of this highest fee states in the country, and I while I feel like it should be more of a decrease, I feel like this is a good start. Just like any other business, when the fee and tax environments are higher, those costs are typically passed along to the end consumer.

Madam chair, this bill also looks to reduce the fee for agents at compassion centers. This bill looks to reduce the costs for registry identification cards by 50% from \$200 down to \$100. Registered agents aren't just the employees that deal with the handling of product. It's also the accountants, attorneys, anyone that is associated with the company.

10 compassion centers (8 dispensaries and 2 manufacturing centers) X \$30,000, would reduce revenues by \$300,000/biennium.

416 agent cards X \$100 = \$41,600/

In closing, I'm hopeful this legislative assembly can find a way to reduce costs to the businesses that are providing a valuable option to our citizens with debilitating medical conditions. As we watch states around us continue to pass recreational marijuana, edibles last year in Minnesota and likely recreational this session, we need to be aware of these issues to help our North Dakota businesses.

The people of North Dakota put the medical marijuana program in place. Let's help make sure it's still there for them by reducing the burden on these businesses

I ask for a do pass and will stand for any questions.

STATE DEPARTMENT OF HEALTH -MEDICAL MARIJUANA DIVISION

Medical Marijuana Division - In November 2016, voters approved Initiated Statutory Measure No. 5 (North Dakota Compassionate Care Act) relating to medical marijuana and created North Dakota Century Code Chapter 19-24. In Senate Bill No. 2344 (2017), the Legislative Assembly repealed Chapter 19-24 and created and enacted Chapter 19-24.1 to provide for the legalization of medical marijuana. The bill required the State Department of Health to establish and implement a medical marijuana program to allow for the production, processing, and sale of marijuana for medical use. In Section 19-24.1-40, the Legislative Assembly established a medical marijuana fund. The department must deposit all fees related to medical marijuana into the fund and must administer the fund. Money in the fund is appropriated to the department on a continuing basis for use in administering the medical marijuana program. Therefore, the Legislative Assembly does not include an appropriation for the Medical Marijuana Division in the department's budget. The department presented a budget, funded through the continuing appropriation, totaling \$1,564,793, including 5 FTE positions, for the 2021-23 biennium. The Legislative Assembly approved salary adjustments of 1.5 percent on July 1, 2021, with a minimum monthly increase of \$100, and 2 percent on July 1, 2022, totaling \$12,120 and approved House Bill No. 1359 (2021) which included a fiscal impact on expenditures of \$4,000, resulting in estimated expenditures from the medical marijuana fund of \$1,580,913 for the 2021-23 biennium.

During the 2019-21 biennium, deposits in the medical marijuana fund of \$1,874,374, exceeded 2019-21 expenditures of \$1,254,332 by \$620,042, which, along with the 2019-21 biennium beginning balance in the fund of \$614,188, is available to the State Department of Health on a continuing basis to administer the medical marijuana program during the 2021-23 biennium. The department anticipates funding continued from the 2019-21 biennium of \$1,234,230, along with \$1,727,400 of estimated revenue collections during the 2021-23 biennium, will be sufficient to pay the estimated \$1,568,793 of program expenses during the 2021-23 biennium. The department anticipates approximately \$1,400,000 will be available in the medical marijuana fund at the end of the 2021-23 biennium and continued into the 2023-25 biennium.

Glossary

<u>Cardholder</u>: A qualifying patient, designated caregiver, or compassion center agent who has been issued and possesses a valid registry identification card.

Compassion Center: A manufacturing facility or dispensary.

<u>Designated Caregiver:</u> An individual who agrees to manage the well-being of a registered qualifying patient with respect to the qualifying patient's medical use of marijuana.

<u>Dispensary:</u> An entity registered by the department as a compassion center authorized to dispense usable marijuana to a registered qualifying patient and a registered designated caregiver.

<u>Health Care Provider</u>: A physician, a physician assistant, or an advanced practice registered nurse.

<u>Manufacturing Facility</u>: An entity registered by the department as a compassion center authorized to produce and process and to sell usable marijuana to a dispensary.

<u>Qualifying Patient:</u> An individual who has been diagnosed by a health care provider as having a debilitating medical condition.

<u>Registry Identification Card:</u> A document issued by the department which identifies an individual as a registered qualifying patient, registered designated caregiver, or registered compassion center agent.

<u>Usable Marijuana:</u> A medical marijuana product or the dried leaves or flowers of the plant of the genus cannabis in a combustible delivery form. However, the term does not include a cannabinoid edible product. In the case of a registered qualifying patient who is a minor, "usable marijuana" is limited to pediatric medical marijuana.

<u>Written Certification</u>: A form established by the department which is executed, dated, and signed by a health care provider within ninety calendar days of the day of application, stating that the patient has a debilitating medical condition. A health care provider may authorize an enhanced amount of dried leaves or flowers of the plant of the genus cannabis in a combustible delivery form to treat or alleviate the patient's debilitating medical condition of cancer. A written certification may not be made except in the course of a bona fide provider-patient relationship.

Background Information and Status of the Program

In November 2016, an initiated measure, known as the "North Dakota Compassionate Care Act," was approved by voters. In January 2017, the provisions of the North Dakota Compassionate Care Act were suspended through legislation passed by the Legislative Assembly. On April 18, 2017, a new state law became effective requiring the North Dakota Department of Health (NDDoH) to establish and implement a Medical Marijuana Program allowing for the production and processing, the sale and dispensing of usable marijuana, and medical use of marijuana. Since the effective date of the new state law, the NDDoH has been committed to implementing a well-regulated program that protects the health and safety of qualifying patients and the public.

State law requires the NDDoH to register no more than two manufacturing facilities unless the NDDoH determines additional entities are necessary to increase access to usable marijuana by registered qualifying patients and registered designated caregivers. Two manufacturing facilities received their registration certificates in fiscal year 2019.

State law identifies the NDDoH is to register no more than eight dispensaries unless the NDDoH determines additional entities are necessary to increase access to usable marijuana by registered qualifying patients and registered designated caregivers. The NDDoH established eight regions within the state where dispensaries would be located. Regions are comprised of a 50-mile radius from selected cities. The first dispensary opened in Fargo in March 2019. Additional dispensaries opened during the 2019 calendar year with the eighth, and final, dispensary opening in December 2019 in Dickinson.

An online application process is used for registering qualifying patients and designated caregivers. During fiscal year 2022, the number of registered qualifying patients continued to grow. As of June 30, 2021, there were approximately 5,750 registered qualifying patients. As of June 30, 2022, there were over 7,950 registered qualifying patients.

State Law Reporting Requirements

House Bill 1213 passed by the 67th Legislative Assembly modified NDCC Section 19-24.1-39. NDCC Section 19-24.1-39 requires the NDDoH to submit an annual report that contains the following information:

- 1. The number of registry identification card applications and renewals;
- 2. The number of registered qualifying patients, registered designated caregivers, and registered compassion center agents;
- 3. The nature of the debilitating medical conditions of the registered qualifying patients;
- 4. The number of registry identification cards revoked;
- 5. The number of health care providers providing written certifications for qualifying patients;
- 6. The number of compassion centers;
- 7. Any expenses incurred and revenues generated by the department from the medical marijuana program; and
- 8. Data for statistical purposes in a manner so that an individual person is not identifiable.

Data is reported as of June 30, 2022.

APPLICATIONS AND RENEWALS

Individuals applying to become a registered qualifying patient, designated caregiver, or agent submit their application through the North Dakota Medical Marijuana Program online registration system. The graphs below identify new applications and renewal applications submitted during fiscal years 2019 through 2022. As identified in the graphs below, there was an increase in applications received by the NDDoH (data from the Medical Marijuana Program online registration system).



Designated Caregiver Application Information



REGISTERED QUALIFYING PATIENTS AND DESIGNATED CAREGIVERS

An individual may possess more than one designated caregiver registry identification card (state law allows an individual to have up to five designated caregiver cards). Also, individuals may be considered an agent of multiple registered manufacturing facilities/dispensaries. Thus, card numbers are not reflective of the actual number of individuals with a registry identification card. The total number of registry identification cards as of June 30, 2019, 2020, 2021, and 2022 was (data from the Medical Marijuana Program online registration system):

The graph on the following page identifies information related to the number of qualifying patient registry identification cards active in the Medical Marijuana Program since the first month a dispensary was open in the state (March 1, 2019). As seen by the graph, the number of registered qualifying patients has increased significantly (data from the Medical Marijuana Program online registration system).



DEBILITATING MEDICAL CONDITIONS

A qualifying patient application requires a health care provider to complete a written certification. A health care provider must select at least one of the debilitating medical conditions authorized in state law. A health care provider may select more than one debilitating medical condition on a written certification (thus, the total number of conditions exceeds the registered qualifying patient data). The graph on the following page identifies the medical conditions selected by health care providers for the 7,958 registered qualifying patients as of June 30, 2022 (data from the Medical Marijuana Program online registration system). As the graph identifies, the top two conditions selected were anxiety disorder and post-traumatic stress disorder.



REGISTRY IDENTIFICATION CARDS REVOKED

In fiscal year 2021, there were 10 registry identification cards revoked (seven of which were qualifying patients). In fiscal year 2022, there were 16 registry identification cards revoked, broken out as follows (data from the Medical Marijuana Program online registration system):

- 12 qualifying patients
- 3 designated caregivers
- 1 agent

HEALTH CARE PROVIDERS PROVIDING WRITTEN CERTIFICATIONS

There were 340 health care providers who completed written certifications for registered qualifying patients as of June 30, 2022. This was an increase of 43 health care providers compared to June 30, 2021. A breakdown of the 340 health care providers is below (data is from the Medical Marijuana Program online registration system). Compared to the previous fiscal year, a slight increase in Advanced Practice Registered Nurses and Physician Assistants occurred.

- 55% Physicians
- 35% Advanced Practice Registered Nurses
- 10% Physician Assistants

House Bill 1283 of the 66th Legislative Assembly established a reasonable accommodation for veterans receiving treatment from a federal veterans' affairs (VA) entity. The accommodation was added to the qualifying patient application process. In lieu of a written certification, a veteran may be eligible to submit their medical records and a copy of their military discharge papers to the division. As of June 30, 2022, 276 registered qualifying patients were veterans who had used the reasonable accommodation.

Senate Bill 2201 Human Services January 19, 2023

During testimony on Senate bill 2201 provided by the Director of Medical Marijuana, Department of Health and Human Services (DHHS), to the Senate Human Services Committee on January 18, 2023, the committee requested additional information. This document summarizes information discussed during testimony. A fiscal note was submitted for the bill and identified a total reduction in revenue of \$358,000 for the 2023-2025 biennium.

The Medical Marijuana Program operates under a continuing appropriation as established in state law. The first year of expenses and revenue associated with the program was fiscal year 2018. Information on expenses and revenue presented to the House of Representatives Appropriations – Human Resources Division identified expenses, revenues, and an ending fund balance for each fiscal year since 2018. The information provided is on Page 4.

The Department was being conservative on the use of funds and has attempted to operate the program in the most efficient manner possible. The Department's decision on finances was greatly impacted by four areas:

 Litigation: starting in the summer of 2020, the department became aware of a possible lawsuit. This process started in February 2021 and included a request for over \$5 million in damages. The Department was aware of potential large attorney fees to defend the Department and anticipated a long litigation process. If the Department had been unsuccessful, the entire fund balance would have been eliminated and the Department would have had to approach the legislature. Thus, the Department chose a conservative approach making any changes impacting the fund balance while litigation was ongoing. Litigation was over in June 2022. Administrative rules impacting fees, including a reduction of the qualifying patient application fee from \$50 to \$25, were effective in October 2022. The marijuana industry is an industry with a high risk of litigation.

- 2. Information technology (IT): the Department procured a major IT system for tracking all marijuana and for a registration system used to register all qualifying patients, designated caregivers, and agents of manufacturing facilities and dispensaries. The Department will need to consider a revised or updated system along with a new contract. Thus, an adequate amount for replacement or a renewal contract for IT is necessary to be maintained in the medical marijuana fund.
- 3. Growth of the program: the program has shown a significant increase in the qualifying patient population that has exceeded the Department's estimated amounts. This led to an increase in revenue. The patient growth has led to the industry expanding operations which leads to additional revenue. Information related to program growth was also provided to the House Appropriations committee and is included on Page 5.
- 4. Vote on adult-use measure: an adult-use cannabis measure was on the ballot in November 2022. The Department was aware that if this measure had passed, the Department would need to immediately expend the Medical Marijuana Program and would be occurring additional costs. Again, using a conservative fiscal approach, the department was cautious about decisions being made with the vote on the measure.

The Department has started taking steps now that litigation has ended related to fees. Prior to changes being made to state law during the 2021 Legislative Session, the amount of fees was a set amount and had to be collected. State laws were modified to establish a maximum amount for fees, thus allowing the Department to collect a lessor amount. Administrative rules were modified in the fall of 2022 to reduce fees in two areas:

- The qualifying patient application fee was reduced from \$50 to \$25 (fee paid annually). The fiscal note for this change identified a revenue reduction \$194,000 for the current biennium.
- The registration certificate fee was reduced from \$90,000 to \$30,000 for a dispensary in a city with a population of 10,000 or less (fee paid once every two years).

With the growth of the program, the Department did hire a part-time, temporary individual to assist with calls and processing applications. There was

a request for an additional full-time equivalent (FTE) position, however it was not prioritized. If an FTE were authorized, there would be no impact to the general fund. The original budget when the program was implemented, included 6 FTE. Due to efficiencies gained during implementation and the status of the program, only 5 FTE have been utilized. Also, the Department has seen an increase in requests for data regarding marijuana, marijuana use, and impacts of marijuana in the state. The Department is looking at options to be able to fund a position to be able to assist in data collection.

One item that was identified to the committee related to agent fees. If the committee were to pass the bill, the maximum annual application/renewal fee for an agent registry identification card would go from \$200 to \$100. If the committee believes the maximum amount should be \$200 in a biennium, the Department suggests having the maximum amount be \$125 for each year and remove the requirement that the fees associated with the required criminal history record checks must be paid by the compassion center or the agent (NDCC Section 19-24.1-18, Subsection 3(a)). If the committee determines to leave the maximum agent fee at \$200, it could still remove the language requiring the criminal history record check be paid by the compassion center or the agent or the agent.

An agent of a dispensary or manufacturing facility is required to have a criminal history record check upon initial application and then every other year after. Currently, the Department must obtain a \$41.25 check from an applicant to submit to the Bureau of Criminal Investigation (BCI) with their fingerprints. This creates an inefficient process. If state law were changed, the Department would not be required to obtain a check and could be billed monthly by BCI. The agent fees collected would assist in paying for the criminal history record checks performed.

For a designated caregiver, an applicant also is required to pay the fees associated with the required criminal history record checks (NDCC Section 19-24.1-04, Subsection 3). The committee may want to consider removing this language as well.

FUND HISTORY

In November 2016, voters approved Initiated Statutory Measure No. 5 (North Dakota Compassionate Care Act) relating to medical marijuana and created Chapter 19-24. In Senate Bill No. 2344 (2017), the Legislative Assembly repealed Chapter 19-24 and created and enacted Chapter 19-24.1 to provide for the legalization of medical marijuana. Senate Bill No. 2344 required the State Department of Health to establish and implement a medical marijuana program to allow for the production, processing, and sale of marijuana for medical use. In Section 19-24.1-40, the Legislative Assembly established a medical marijuana fund. The State Department of Health must deposit all fees related to medical marijuana into the fund and must administer the fund. Money in the fund is appropriated to the department on a continuing basis for use in administering the medical marijuana program. Therefore, the Legislative Assembly removed funding for the Medical Marijuana Division from the State Department of Health's base budget in 2019.
