Testimony on HB 1067 2025 Legislative Session House Human Services Committee Chairman Representative Mathew Ruby January 13, 2025

My name is Donene Feist, I am the Director for Family Voices of North Dakota. I come before you today to request support for HB 1067 and to additionally provide information on issues that we are seeing at Family Voices.

Family Voices of North Dakota is statewide health information and education center who serves families of children with special health care needs in ND. Each state in the country and our territories has one family organization that has been designated as a family to family health information and education center by HRSA federally. We are that entity for ND.

We provide emotional and informational support to many families across North Dakota who have a child who has an ongoing medical diagnosis such as asthma, heart conditions, physical disabilities, and emotional/behavioral issues. Our staff, who all are parent to children with special health care needs, provides assistance to families by helping them access and navigate services; explaining what the services mean, how systems work, and where the funding comes from; and by providing emotional support to assist with their unique and individual needs.

We are very supportive of the bill as it extends the age limit for the medically fragile waiver and the autism waiver to the age of 21. We are also supportive of expanding Medicaid coverage to children who are lawfully present in the U.S. but whose parents have not met the five-year waiting period or obtained forty qualifying quarters of Social Security coverage.

An area of concern that we have is this:

The majority of North Dakota's children with disabilities who are being served under one of our various 1915c Medicaid Waivers (Autism Waiver, Developmental Disabilities Waiver, Medically Fragile Waiver, Children's Hospice Waiver) must be on Medicaid. North Dakota recognizes this fact and allows for a FAMILY income and asset disregard for Medicaid eligibility. Only child income would count and in almost all cases, the child does not have any income and/or assets. Unfortunately, this changes in families where there is divorce resulting in child support or death of a parent (or a parent drawing a social security benefit), then child support and/or Social Security survivor or retirement benefit are determined child income and the state assesses a cost share or a recipient liability.

In a recent scenario, a mother found out after the sudden death of her spouse, that her child with complex health needs would now have a cost share when accessing In-Home Supports through one of our 1915c Medicaid Waivers. The cost share was so large that the Social Security benefit barely covered the cost. On top of the loss of income in her home and dealing with grief, she

then had to pay for a service that she did not have to when her husband was alive. These families not only take a loss of income, most times the Recipient Liability is at least as much as or higher than the SS benefit or child support.

Because of the dire circumstances of these families we consulted with one of our national partners is the Catalyst Center at Boston University who is the National Center for Health Insurance and Financing for Children and Youth with Special Health Care Needs (CYSHCN). Their role is to: promote universal, continuous, and affordable coverage for all CYSHCN; close benefit and financing gaps; promote payment for additional services; and build sustainable capacity to promote financing of care. They could not identify another state who as a death benefit or from child support utilize this as income for the child which changes their Medicaid eligibility.

As HB 1067 opens up the section on Medicaid eligibility, we are asking the House Human Services Committee to work with the Department and Legislative Council to draft an amendment that would exclude Social Security survivor and/or retirement benefits as well as child support payments as child income for purposes of Medicaid eligibility.

# Testimony House Bill No. 1067 House Human Services Committee Representative Ruby, Chairman

January 14, 2025

Chairman Ruby, and members of the House Human Services Committee, I am Krista Fremming, Assistant Director of Medical Services with the Department of Health and Human Services (Department). I appear before you in support of House Bill No. 1067, which was introduced at the request of the Department.

Section 1 of this bill allows Medicaid coverage, and therefore federal matching funds, for children who are in the U.S. legally without regard to the length of time they or their parents have resided in the United States. We estimate that up to an additional 180 children may receive Medicaid coverage each year if this bill passes.

During the 2023 ND legislative session, Senate Bill No. 2181 passed that allowed for Medicaid coverage for pregnant women who are legally in the U.S. without regard to length of time they have been in the U.S. or qualifying quarters of social security coverage. We are recommending the same change be made for children. This will allow us to provide children who are here legally with access to health care services and connect them with cost effective preventive care.

Currently 36 states plus the District of Columbia provide Medicaid coverage to lawfully present children without a 5-year waiting period.

There have been situations since Oct. 1, 2023 (date we implemented the 2023 Senate Bill No. 2181) where we were able to provide coverage for a pregnant woman who did not meet the 5-year waiting period or have enough qualifying quarter of social security coverage but had to deny her children coverage due to the current law. Passing this bill would ensure the family unit is eligible for Medicaid and children aren't left without coverage we are able to grant to their pregnant mother.

There have also been a few situations in our state where a human service zone or the Division of Juvenile Services had custody of a child who was legally present in ND, however due to the five year, forty-quarter ban, the child did not qualify for Medicaid and their services had to be funded with state general funds.

Fortunately, there are not many children who fall into this category, but for those who do, their care is typically costly, as it may involve inpatient and residential levels of care. For example, the monthly cost for a child to receive treatment at a psychiatric residential treatment facility is around \$19,000. Without the passage of this bill, the state will incur general fund expenses of around \$236,877 in the 2025-27 biennium. This factor has been included in the fiscal estimate of the bill. By passing the bill, we can obtain federal matching dollars for all the children who fall into this situation, regardless of if their custody is transferred to a zone or the Division of Juvenile Services.

The fiscal impact of Section 1 for the 2025-27 biennium is \$356,491 in general funds and \$604,829 in federal funds.

We are requesting an amendment to the effective date of Section 1 of this bill, which we have drafted and included in the attached document. The amendment would change the effective date to April 1, 2026. As we analyzed the IT systems changes that would be needed if the bill passes, we concluded that a few additional months for development and testing are needed. If the amendment is adopted, the fiscal impact would need to be amended as well.

Section 2 of the bill increases the age limit for participation in the Medicaid children's autism and medically fragile waivers to age 20. Currently the age limit is 18. This change would enable children who are currently participating in the waiver to remain as participants at ages 19 and 20. If this change is not made, 23 children will age out of these waivers in the coming biennium. The transition period from youth into adulthood is critical, and disruption of services and supports for these young adults would make the transition more challenging. There is no fiscal impact associated with this change, as there are a set number of waiver slots each year, and each slot is funded in the Department's cost to continue budget.

#### PROPOSED AMENDMENTS TO HOUSE BILL NO. 1067

A BILL for an Act to amend and reenact sections 50-24.1-02.6 and 50-24.1-26 of the North Dakota Century Code, relating to medical assistance benefits and Medicaid waivers; and to provide an effective date.

**SECTION 1. AMENDMENT.** Section 50-24.1-02.6 of the North Dakota Century Code is amended and reenacted as follows:

#### 50-24.1-02.6. Medical assistance benefits - Eligibility criteria.

- 1. The department shall provide medical assistance benefits to otherwise eligible persons who are medically needy persons who have countable income that does not exceed an amount determined under subsection 2.
- 2. The department shall establish an income level for medically needy persons at an amount no less than required by federal law.
- The department shall provide medical assistance benefits to children and families coverage groups and pregnant women without consideration of assets.
- 4. The department shall provide medical assistance benefits to otherwise eligible pregnant women who are lawfully present in the United States.
- 5. The department may require, as a condition of eligibility, individuals eligible for Medicare part A, B, or D to apply for such coverage.
- 6. The department shall provide medical assistance benefits to otherwise eligible children who are lawfully present in the United States.
- 7. The department shall disregard social security survivor income and courtordered child support for children under the age of eighteen years who are enrolled in a Medicaid 1915(c) waiver.

SECTION 3. EFFECTIVE DATE. Section 1 of this Act becomes effective on July 1, 2026.

## Testimony House Bill No. 1067 Senate Human Services Committee Senator Lee, Chairman

March 10, 2025

Chairman Lee, and members of the Senate Human Services Committee, I am Krista Fremming, Assistant Director of Medical Services with the Department of Health and Human Services (Department). I appear before you in support of House Bill No. 1067, which was introduced at the request of the Department.

Section 1 of the bill was amended by the House Human Services committee. Section 1 directs the Department to disregard certain income for children who are enrolled in 1915(c) waivers, effective July 1, 2026. Social security survivor income and court-ordered child support will become disregarded income types for these children if the bill passes. The fiscal impact for this change is estimated to be \$62,724 for the 25-27 biennium and \$125,448 for the 27-29 biennium.

Section 2 of the bill increases the age limit for participation in the Medicaid children's autism and medically fragile waivers to age 20. Currently the age limit is 18. This change would enable children who are currently participating in the waiver to remain as participants at ages 19 and 20. If this change is not made, 23 children will age out of these waivers in the coming biennium. The transition period from youth into adulthood is critical, and disruption of services and supports for these young adults would make the transition more challenging. There is no fiscal impact associated with this change, as there are a set number of

waiver slots each year, and each slot is funded in the Department's cost to continue budget.

Section 3 of the bill is requesting a delayed effective date to allow the Department time to update the necessary systems and processes.
