For the record my name is Jason Sutheimer, Human Resource Business Partner within the Office of the Adjutant General. Thank you for the opportunity to speak on behalf of this bill today.

This bill was introduced by the Office of the Adjutant General (OTAG) at the request of the North Dakota Public Employee Retirement System (NDPERS). Based on the timing of when cleanup bills needed to be submitted by NDPERS, they requested our agency submit this cleanup bill.

During a recent hire in the Security section at Fraine Barracks, conversations took place with NDPERS as to which retirement plan to enroll our security positions. Our security positions have both classified and non-classified team members performing similar job duties. Previous NDPERS guidance was the "status" of position the team member held determined which retirement plan they were enrolled in. After further conversations and analyzing the retirement plans further, NDPERS made the determination that all security team members should be enrolled in the same retirement plan regardless of their classified status.
