Mr. Chairman and members of the Judiciary Committee, I am Jeremy Olson, State Representative, District 26, representing most of McKenzie and Dunn Counties. I am the prime sponsor for HB 1094 as part of the Military and Veteran's Caucus goal of enhancing the benefits and quality of life for our active-duty members and veterans in North Dakota. The goal of HB 1094 is to increase the availability of special allocation big game tags to a wider variety of charitable organizations, including veteran organizations.

Currently, the only charitable organizations that are eligible for a special allocation hunting license are 501(c)(3). This bill would change it from a 501(c)(3) to just 501(c) types of charitable organizations. This would open the opportunity up to not only veteran charitable organizations, which are 501(c)(19) and 501(c)(23), but also to other charitable organizations, such as a 501(c)(4) community service oriented oganizations, that don't fall into a 501(c)(3) type of organization.

This will not have any immediate impact on the current number of special allocation hunting licenses, the available tags will remain the same. This change will allow these other organizations the opportunity to apply for the licenses to benefit its charitable efforts and it will be a more competitive process.

Please accept this testimony in support of HB 1094.

Intent of this bill:

Allow eligibility for Veteran Service Organizations to apply to be considered for issuance of up to two special allocation hunting licenses as other non-profits are eligible.

Background:

- Currently NDCC 20.1-05.1-02 Discretionary special allocation hunting license authorization, allows a federal income tax exempt organization under 24 U.S.C. 501 (c)(3) to apply for up to two special allocation hunting licenses.
- NDCC 20.1-05.1-02 allows ND Game and Fish to determine, by lottery if necessary, the non-profit organizations applying for special allocation hunting licenses which will receive up to 2 licenses for,
 - No more than
 - 2 elk licenses
 - 2 moose licenses
 - 2 antelope licenses
 - No more than
 - 10 white-tailed deer licenses
- Recipients of the allocated hunting licenses may sell or raffle licenses to raise funds for their organization and/or programs.

Need for bill:

- Veteran Service Organizations are under 24 U.S.C. 501 (c)(19) and currently not eligible.
- Veteran Service Organizations should be eligible to participate in this program.

Outcome of bill:

- Will allow Veteran Service Organizations to participate, if they chose, in this program.
- This bill would also open the eligibility to other non-profits such as 501(c)(4) which are community service oriented.

When this opportunity was originally proposed, several North Dakota Sportsman and Outdoor groups supported the bill.

The thought was funds which could be raised, through raffles and auctions, would greatly benefit an individual groups efforts in their work to enhance education, conservation, habitat, etc.

This was especially true for the North Dakota Bowhunters Association's entity, the North Dakota Bowhunters Foundation. Early in the program, The Bowhunter Foundation benefited by receiving a Moose tag and with its fundraising effort, greatly improved their mission to provide funding for activities which advance the sport of archery, promote the cause of education, encourage community betterment, and assist people to learn more about Archery and Bowhunting in North Dakota.

TESTIMONY OF JOHN BRADLEY NORTH DAKOTA WILDLIFE FEDERATION HB BILL 1094 HOUSE ENERGY AND NATURAL RESOURCES COMMITTEE JANUARY 17, 2024

Chairman Porter and members of the House Energy and Natural Resources Committee:

For the record, I am John Bradley, executive director of the North Dakota Wildlife Federation. I'm here today representing our thousands of members in 16 affiliated wildlife and sportsmen's clubs across North Dakota that make up the North Dakota Wildlife Federation.

NDWF is opposed to HB 1094, as written. NDWF is open to the intent of the bill to expand the lottery to other organizations for their fundraising efforts. In the 2023 session, we supported SB 2294 which expanded the special allocation lottery to veteran groups organized under 501C(19). However, If the intent of the Committee is to expand the types of organizations that are allowed to apply, then NDWF believes that the Committee should amend the bill so that no funds that are generated from the special allocation lottery can be used for political or lobbying activities.

NDWF's Board of Directors has a major concern that this bill will lead to additional tags being allocated through future legislation. We would oppose any bill that increases the number of tags available in the special allocation lottery and reduces tags available in the general lottery.

Lastly, NDWF would like to see the amount donated back to conservation increase, protecting the resource that is at the core of the fundraising opportunity (20.1-05.1-02 5 C).

Dear members of the House Energy and Natural Resources Committee,

Please join me in opposing House Bill 1094,

The very limited amount of special allocation licenses should be used for the benefit of North Dakota public wildlife. The current pool of eligible nonprofits already encompasses a wide variety of organizations, which is unfortunate. The passing of this bill would open the floodgates for even more unrelated organizations.

Should our public wildlife be funding things like the local telephone cooperative or labor union?

Please continue to limit the eligible nonprofits to what is currently in place and oppose this bill.

Opposition Testimony to House Bill 1094

Relating to Discretionary Special Allocation Hunting Licenses

As a wild game chef and someone who works in the outdoor industry here in North Dakota, I hope you will join me in opposing House Bill 1094.

This bill raises significant concerns about the future of our state's hunting culture and the fairness of the special hunting license allocation process. I acknowledge and appreciate the sponsor's motivation to include veteran's organizations in the raffle allocation for special hunting tags, which is undoubtedly a noble cause. However, I urge you to reconsider the broader implications of extending this opportunity to all 501(c) organizations, as outlined in the bill.

If House Bill 1094 is passed, it would allow every type of 501(c) organization - ranging from charitable organizations to business leagues, and even politically affiliated groups - to apply for and potentially win the coveted special hunting licenses. While the inclusion of veteran's organizations is commendable, this legislation opens the door for far-reaching consequences that deserve careful scrutiny.

Consider, for example, the possibility of a business league like the *North Dakota Petroleum Council* or the *Lignite Energy Council* winning one of the prized elk or moose tags instead of your local church groups or wildlife conservation organizations? These energy organizations have significant financial means over a group of high school students hoping to raffle off an elk tag for a church mission trip. Is this the kind of outcome we want for our hunting community - where big business wins out over local groups with more modest resources?

Additionally, this bill would allow 501(c)(4) political advocacy groups to enter the raffle as well. Groups like the *North Dakota Democratic Party*, the *North Dakota Republican Party*, the *Americans for Prosperity*, and *Common Cause North Dakota* would be eligible to win and raffle off one of the hunting tags, potentially using them for political purposes or fundraising. Imagine the backlash from your constituents if one of these politically charged organizations were to win an antelope tag or deer tag? How would you respond to an uproar from your community if one of these political entities applies for and wins one of the special allocation tags?

I urge you to carefully consider the unintended consequences of this bill. While it is crucial to support and honor our veterans and other deserving groups, the current version of House Bill 1094 opens up the raffle system to organizations with vastly different motivations and resources.

Please vote NO on House Bill 1094.



3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

- 4 **SECTION 1. AMENDMENT.** Section 20.1-05.1-02 of the North Dakota Century Code is 5 amended and reenacted as follows:
 - 20.1-05.1-02. Discretionary special allocation hunting license authorization.
 - Subject to the restrictions under this section and in addition to the special allocation licenses authorized under section 20.1-05.1-01, if determined appropriate by the director based on the sustainability of the species population, the director may issue to eligible organizations the following annual special allocation hunting licenses:
 - a. Not more than two elk licenses, but the total issued under this subdivision may not exceed two percent of the general lottery allocation of elk licenses for the season.
 - b. Not more than two moose licenses, but the total issued under this subdivision may not exceed two percent of the general lottery allocation of moose licenses for the season.
 - c. Not more than two antelope licenses, but the total issued under this subdivision may not exceed two percent of the general lottery allocation of antelope licenses for the previous season.
- d. Not more than ten white-tailed deer licenses.





- 2. An eligible organization may apply annually to be considered for issuance of up to two special allocation hunting licenses under this section. Applications under this subsection must be filed at the times, in the manner, and containing the information required by rules adopted by the director. If more applications are filed than the number of licenses under this section available for that species for a season, the director shall determine by lottery which organizations will receive the available licenses.
- 3. An eligible organization that obtains a license under this section and conducts a raffle or auction to determine the recipient of the license must conduct the raffle or auction in compliance with rules adopted by the director. An eligible organization that obtains a license under this section shall submit reports concerning a raffle or auction as the director requires. An individual may apply to receive an elk or moose license through a raffle or auction under this section as well as through the game and fish department general lottery. If an individual receives an elk or moose license under this section, the individual is not eligible to receive an elk or moose license through the game and fish department general lottery that year and may not obtain an elk or moose license under section 20.1-05.1-01 that year. If an individual receives an elk or moose license under section 20.1-05.1-01, the individual is not eligible to receive an elk or moose license under this section that year.
- An individual who has been convicted of illegally taking a moose, elk, or bighorn sheep is not eligible to apply for or receive a license under this section.
- 5. For purposes of this section, "eligible organization" means an organization that:
 - a. Is exempt from federal income taxation under section 501(c)(3) or 501(c)(19) of the Internal Revenue Code [26 U.S.C. 501(c)(3): 26 U.S.C. 501(c)(19)] and provides with its application a copy of the letter from the internal revenue service to that effect.
 - Is on file as a nonprofit corporation in good standing in the office of the secretary of state-;
 - c. Agrees in its application to contribute at least tentwenty percent of the net proceeds of any raffle of a license under this section to a conservation-related project to be conducted in this state and approved by the director: and
