## TESTIMONY ON HOUSE BILL 1102 Judiciary Committee Jan. 13, 2025

## Dwight Love, Interim Police Chief City of Grand Forks, ND

Mr. Chairman and members of the committee, my name is Dwight Love and I'm the Interim Police Chief for the Grand Forks Police Department. I am providing this testimony in support of HB 1102.

The Grand Forks Police Department currently has one (1) investigator assigned to cybercrimes. They partner with BCI agents in Fargo, ND to collaboratively investigate offenses to include all crimes involving internet and/or electronic means. This involves having the training, experience and equipment necessary to collect a wide range of digital evidence found on electronic devices used in all crimes from domestic violence to the sexual exploitation of children.

Local BCI agents assigned to Grand Forks would make the investigative process more efficient by adding local access to advanced cybercrimes technologies while reducing travel/distance for the cases that need their assistance. This additional support would help reduce the backlog in cybercrime investigations for our police department and the surrounding regional agencies by reducing the usage of BCI agents located in Fargo, ND.

The Grand Forks Police Department and the City of Grand Forks would welcome the opportunity to integrate BCI agents into our region and within the department. The City would support these BCI agents in various ways such as IT support, office space, etc.

For these reasons, the City of Grand Forks and the Grand Forks Police Department request a DO PASS on HB 1102.

In mid-October 2023, I was asked by now retired Chief Nelson to request that the Bureau of Criminal Investigation (BCI) embed two agents with GFPD. The major law enforcement emphasis for these agents will be focused on cybercrime, with an additional emphasis on sex crimes that exploit children.

While the Grand Forks Police Department is fully staffed, its detectives lack the expertise to specifically work in cybercrime and lack the computer forensics expertise and other law enforcement capabilities unique to BCI.

Further, my understanding is that other major cities in North Dakota have agents with similar expertise embedded in their police departments, making this a common practice.

As such, I began working with Chief Agent Harstad to bring Chief Nelson's request to fruition. Initially our efforts were directed to include the costs for these two agents in the BCI budget and until mid-June, this was the plan as highlighted by Director Grabowska's mention of this in the BCI/AG office legislative briefing in West Fargo.

However, the executive branch decided it was best to request a separate appropriation for these agents resulting in the necessity of HB1102. I spoke with Chief Agent Harstad in this regard and BCI continues to support this mission with the Grand Forks Police Department and this specific bill for the appropriation.

This effort is a major point of emphasis for Mayor Bochenski and the city is renovating two offices to house these agents. Further, the City of Grand Forks has budgeted \$148,000 to offset costs associated with training for these agents and required computers and other equipment necessary for their success. They are prepared to provide additional resources as required.

These costs borne by the City of Grand Forks include, but are not limited to:

#### Total Grand Forks Costs to add two Agents for biennium: \$148,000 plus office space

\$12,000	Office furniture
\$64,000	Computers and forensic equipment
\$60,000	Training and travel costs
\$12,000	Internet and firewall

The costs borne by the State of North Dakota include, but are not limited to:

#### Total State Appropriated Costs for two Agents for biennium: \$775,000

\$480,000	FIE for two agents
\$161,000	One-time equipment costs
\$44,000	Cost of forensic software
\$90,000	Cost for cell phone unlocking devices

The State's costs will be increased due to recent changes in costs at BCI and an amendment will be introduced in Appropriations Committee. It is anticipated that this increase will be

between \$40,000-50,000 for the biennium, some of which will be salary, which is a reoccurring expense as well as software costs.

I urge a due pass on this bill as clearly these agents are not only a needed resource for the Grand Forks Police Department, but also for the Grand Forks Sheriff's Department. These agents will serve the northeastern North Dakota law enforcement community in this unique law enforcement capacity while being housed in the Grand Forks Police Department.




Bureau of Criminal Investigation Cyber Crime Unit - What do we do?


- Specialize in recovering and analyzing digital evidence from computers, cell phones and cloud platforms.
- 2. We use specialized tools not normally available to other agencies to retrieve deleted or encrypted files and unlock devices.
- 3. We focus on combatting child exploitation, working closely with the National Center for Missing and Exploited Children to identify, track and apprehend offenders.
- 4. We provide expert testimony in court on digital evidence findings.
- 5. We assist and support local, state and federal agencies with high-profile and complex cases.
- 6. We handle massive amounts of recovered data, making sure the data is secured and efficiently analyzed.
- 7. Beyond investigations Cyber agents continually stay current on emerging trends and certifications.
- 8. Cyber agents educate schools and communities on internet safety.


#### What processes do we use?

- When Cyber agents received a case through CyberTips, law enforcement referrals or direct investigations, they prioritize the case based on urgency. Those involving children or an immediate public threat are a priority.
- Cyber agents collect the digital evidence and use specialized tools to collect the data.
- Cyber agents analyze and interpret the data, locating photos, videos, chat messages, or financial transactions, connecting this information to suspects, then share that information with law enforcement and courts.
- 4. Cyber agents write detailed reports of their findings and provide expert testimony.

# TESTIMONY ON HOUSE BILL 1102 House Appropriations – Education & Environment Division January 31, 2025

## Todd Feland, City Administrator City of Grand Forks, ND

Mr. Chairman and members of the committee, my name is Todd Feland and I'm the City Administrator for the City of Grand Forks. I am providing this testimony in support of HB 1102.

The Grand Forks Police Department has seen a large increase of cyber-related crimes where digital evidence needs to be collected. From 2023 to 2024 there was a 100% increase of internet crimes against children and search warrants and subpoenas for the collection of digital evidence has tripled since 2022.

The Grand Forks Police Department currently has one (1) investigator assigned to cybercrimes. They partner with BCI agents in Fargo, ND to collaboratively investigate offenses to include all crimes involving internet and/or electronic means. This involves having the training, experience and equipment necessary to collect a wide range of digital evidence found on electronic devices used in all crimes from domestic violence to the sexual exploitation of children.

Local BCI agents assigned to Grand Forks would make the investigative process more efficient by adding local access to advanced cybercrimes technologies while reducing travel/distance for the cases that need their assistance. This additional support would help reduce the backlog in cybercrime investigations for our police department and the surrounding regional agencies by reducing the usage of BCI agents located in Fargo, ND.

The City of Grand Forks and the Grand Forks Police Department are also well aware that there will be a cost share to house these agents within GFPD. This cost share will help in various ways such as IT support, office space, travel and training. We estimate that cost share to be under \$200,000 per year for both agents. These costs will be absorbed into our existing budgets.

For these reasons, the City of Grand Forks and the Grand Forks Police Department request a DO PASS on HB 1102.
