The North Dakota Game and Fish Department (Department) relies heavily on seasonal employees to accomplish many of our most important field activities throughout the summer months. Most of these seasonal employees are enrolled at or a recent graduate of a college or university majoring in a wildlife, natural resources, or other closely related program. Many of these seasonal employees work for the Department for 2-3 summers. Several of them end up being hired on for full-time permanent positions with the Department. In fact, around 68% of our current Biologists and Game Wardens began their careers with our agency working as a seasonal employee.

Between 2014 and 2022, the number of individuals applying for seasonal positions with the Department dropped over 70%.

The proposed bill would allow the Department to establish educational and community outreach programs to promote public understanding of fisheries and wildlife management and promote interest in pursuing careers in these fields. We feel having a program in place that would allow high school students to experience our work environment is critically important before they get to college and declare a major. Importantly, this bill would allow the Department to create a program which would allow participants to be involved in field activities. This program would include riding along with Department staff in compliance with established program guidelines. Such activities may include early morning pheasant crowing count or fish spawning to provide eggs to the fish hatcheries. These types of hands-on experiences are what our agency is hoping will ignite a passion in these individuals to start their lifelong career in North Dakota's outdoors.

The North Dakota Chapter of Backcountry Hunters and Anglers supports H.B. 1174, which would allow the Game and Fish Department to establish educational and community outreach programs. Current projections from the U.S. Bureau of Labor Statistics show a 4% increase in demand in the labor market for Wildlife Biologist and there is always a need for more Game Wardens to enforce the state's conservation laws.

By establishing these programs, where the public can see first-hand, what it means to be in a Wildlife Conservation career, we believe they're more likely to enter the career field where they may not have had an interest before.
