As a government teacher, I stress to my students the importance of participating in the government. We spend a lot of class time discussing different ways that students can participate such as voting and being knowledgable about candidates and issues. As a class we cover voting rights and how hard Americans have worked throughout history to gain the right to vote. Most high school seniors taking a government class understand the importance of voting. Many are excited to vote for the first time during their senior year. North Dakota Civics and Government Benchmark C.6\_12.4.5 states students should demonstrate active participation in civic life. Many seniors did not have this free time and it discouraged them from voting after school because of the interference with many after school activities. Please consider voting yes on House Bill 1178 because it will encourage eligible seniors to vote as it is our civic duty to do so. Thank you.

We met locally and spoke about the bill, and then met with Legislative Council so she could see the process from start to finish. What you have before you is our finished product, HB1178.

This bill essentially directs all local school boards to adopt their own policy, allowing students 18 and older the opportunity to vote in elections. I am going to let Zofia present the bill to you, as it was her idea and she put the work into organizing this hearing. But I'd like to make a few points before I hand it over to her:

- Not all counties in North Dakota have multiple polling locations. Where we live Mercer County we have one
  polling location, so it can take nearly an hour to get to that single polling location, depending upon where you
