Dear Representative Kiefert:

The Valley City-Barnes County Development Corporation is requesting establishment of a Natural Gas Last Mile Fund of \$5 Million for communities under 10,000 population to assist with natural gas pipeline extensions to homeowners and businesses. In Valley City, the natural gas line is located on the north side of the Interstate and needs to be extended to the south side.

Communities with a population of 10,000 and under do not have the financial resources to support infrastructure costs including extension of the natural gas main line. The Public Service Commission limits the amount of funds that the natural gas provider can invest per home, which exacerbates the problem.

Another deterrent is the first party that pursues and installs a gas line to their home or business pays 100 percent of the cost with a five-year window to recover costs.

The first party is also charged with the responsibility of collecting from other homeowners, and businesses that access the line. Consequently, nothing happens.

Natural gas is needed for housing and business development and would save operating costs. Using natural gas would also help communities save on electrical consumption and cost, which impacts the entire community. Natural gas consumption is also important at the State level.

The cost of all forms of infrastructure, specifically natural gas lines, water and sanitary sewer main lines, and storm sewer systems are strangling rural communities and any potential they have for growth – residential, commercial, and industrial. Investment in rural North Dakota communities is essential and very much needed. Thank you.

Natural Gas to rural communities City of Parshall January 23, 2025

Good Morning Chairperson and Legislative members. I would like to thank you for this opportunity to testify on the issue before this committee for HB 1275. I am Kelly Woessner, City Auditor of the City of Parshall and I am here to represent our small community on the Ft. Berthold Reservation. We are located in the Bakken area and have constant flaring and waste of the natural gases in this part of ND. I attended the last session and testified for a study to be performed. We were asking the State of North Dakota to help smaller communities obtain support and funding to be able to utilize this natural resource for heating our homes. Well, we are a step closer. The cost of this venture is astronomical and communities like ours would need financial help. This advancement is a start.

Refineries still need to be built; transmission lines still need to be in place in order for infrastructure to be installed. I know that testimony during the last legislative session, there was discussion on transmission lines versus distribution lines. The way I see it is a line that gets a commodity to its final point means the same thing and if we can get these lines to the communities that are interested in installing natural gas for their residents, it will give them a reliable source for heating their homes.

North Dakota winters can and have been brutal, like this last weekend and pipelines are a sure way to get the people what they need for heating and everyday life. I have had a lot of calls because homes have frozen water lines that have broken for various reasons including that they have run out of propane. Natural gas won't solve the breakdown issues, but is could resolve the running out of gas issues. At this time propane and fuel oils are instrumental in heating most of the homes in small communities. There is no infrastructure to directly feed these commodities. It has to be trucked and hauled. In the winter months this becomes an obstacle for delivery drivers to get their product to where it is needed. Our community is constantly called in to remove snow for a propane or fuel oil customer to get their tanks filled. With a Natural gas pipeline into our communities, there would be less problems getting that needed commodity for heating or cooking. There would be no need to watch the tank and have to call out for a delivery and hope they arrive before your tank runs out.

The option for industry and businesses coming to our area in the State are limited. They look for the benefits of utilities such as natural gas, when they decide where to build. Growth and expansion with that commodity could open so many more doors and options for rural North Dakota and help our smaller communities grow. Natural gas may not be for everyone, but the future doesn't wait for anyone. Technology advances and waits for no one.

We have been in discussion to get a distribution line to our area including the communities of New Town, Parshall, and Plaza at an estimated cost of \$80,000,000. This does not put it into the city limits. Our residents then would have to pay for it to get on their properties. This proposed State funding is a start and would help benefit the communities that are interested in pursuing this needed progress to move forward.

House Bill No. 1275 Testimony Kristine Anderson, Regulatory Affairs & Corporate Counsel Dakota Natural Gas, LLC House Energy and Natural Resources Committee January 23, 2023

Chairman Porter and members of the Committee, my name is Kristine Anderson. I am the in-house corporate attorney for Dakota Natural Gas, LLC, and I also handle regulatory affairs for the company. DNG supports House Bill 1275 because it is an excellent step forward to encourage expansion of natural gas access throughout North Dakota.

Reliable energy is a vital component of society, impacting everything from quality of life to human progress, and that will remain the case in perpetuity. Residents and businesses that have natural gas service generally take it for granted, but there are thousands of people living in areas around the state that do not have any access to natural gas. DNG is focused on providing gas to them, because the lack of access to this essential service affects the quality of life, standard of living, and economic development for those communities. Since finding creative solutions to bring natural gas to new areas is DNG's forte, this bill falls squarely within an area that DNG knows something about.

Expanding a natural gas distribution system to a sizeable area that is contiguous to or near existing service is expensive; and building a distribution system for an unserved area that is some distance away is even more expensive. In 2022, the Interim Energy Development and Transmission Committee identified the cost of building distribution systems as lying between \$750,000 and two million dollars – and that is just the beginning, depending on where the service will be. Unlike many industries, natural gas distribution companies are rate-regulated, so they cannot simply decide to set high rates to recoup their costs of construction quickly. In fact, it generally takes ten to fifteen years for the cost of building a new natural gas system to be earned back before a system becomes profitable.

HB 1275 is an excellent step forward, because it may help expand natural gas distribution to unserved communities, or parts of communities, that are near existing service areas. While a \$5,000,000 grant fund may not be enough to tackle expanding natural gas distribution to parts of the state that are not near existing service territories or interstate pipelines, it could be enough to make a real difference in the lives of some of the State's unserved residents.

DNG has stood before North Dakota's legislative committees multiple times in recent years in support of efforts to expand natural gas distribution, and it will continue to do so. Without intervention from the legislature, unserved areas are likely to continue to remain unserved because, if the economics don't make sense, the distribution facilities simply cannot be built. Funds like those contemplated in this bill should be dedicated to expanding gas to unserved areas where expansion is an otherwise unecomonic proposition rather than being offered for use in currently served areas. Only through financial support and creative approaches can natural gas access be expanded to bring an essential service to those that currently lack access to it. I encourage you to take this step in the right direction.

Thank you for the opportunity to share DNG's support with you. A grant fund such as that proposed here is another step forward in the endeavor to expand natural gas access within North Dakota. I respectfully request that you support it. Please give House Bill 1275 a do-pass recommendation.
