#### **Testimony in Support of HB 1340**

Dear Chairman Ruby, Vice-Chair Grueneich, and Committee Members

I am writing to express my support for HB 1340, which amends and reenacts subsection 4 of section 39-21-39 of the North Dakota Century Code, relating to motor vehicle window tint.

This bill changes the percentage of window tint that can be applied to the front driver and passenger windows from **fifty percent** to **thirty-five percent**. This bill also has a small grammar fix as well.

This change allows a slightly darker tint that can be applied to the front driver and passenger windows of a motor vehicle. Thirty-five percent light transmittance is a good overall percentage provides more protection from the sun and snow reflection, glare reflection while still being safe in driving. This captures the citizens' needs of wanting the tint for sensitive eyes, to protect the interior vehicle from the sun, which makes the vehicle cooler inside for pets. The tint allows protecting belongings inside from the heat and theft protection as not so noticeable at a glance by people walking by.

This will allow North Dakota to be closer in line with other states' tint laws. There are about 15 states that have tints higher than thirty-five percent and all the other states are thirty-five percent or lower.

I yield many complaints and concerns from my constituents as why North Dakota tint law is so restrictive on the front driver and passenger windows. They also ask why Law enforcement vehicles can have tint darker than century code states, not to mention the out of state vehicles that pass through our state and get stopped for tint violations.

If HB 1340 passes I would consider tinting the Sheriff vehicles in our fleet to help preserve the equipment inside our vehicles from the sun and the heat.

My name is Deondre Hawk, and I am a resident of Bismarck, ND. I am writing to express my strong support for legislation that allows for the use of the proposed 35% in our state. As someone who has personally experienced the benefits of darker tints, I believe this legislation would have a positive impact on public safety, health, and overall quality of life for residents.

35% window tints would provide an added layer of privacy and security for individuals and families. In an era where personal safety is a growing concern, darker tints help shield occupants from prying eyes. This is especially important for vulnerable populations, such as women traveling alone or families with young children. Additionally, darker tints can deter theft and break-ins by making it more difficult for criminals to see valuables inside vehicles or properties.

One of the most compelling reasons to support darker tints is their ability to block up to 99% of harmful ultraviolet (UV) rays. Prolonged exposure to UV radiation is a known cause of skin cancer, premature aging, and other health issues. By allowing darker tints, we can help protect drivers and passengers from these risks.

Darker tints significantly reduce glare from sunlight, headlights, and reflective surfaces, which can improve visibility and reduce eye strain for drivers. This is especially beneficial during early mornings, late afternoons, and nighttime driving, when glare is most problematic. By enhancing driver comfort and safety, darker tints can contribute to a reduction in accidents caused by impaired visibility.

In the event of an accident or break-in, darker tints can help hold shattered glass together, reducing the risk of injury from flying shards. This added safety feature is invaluable for protecting occupants in vehicles. making darker tints a practical choice for public safety. The benefits of darker tints extend far beyond aesthetics, offering tangible improvements in safety, health, energy efficiency, and privacy.

Chairman Ruby and Committee Members,

I am submitting testimony in support of HB1340, which amends and reenacts subsection 4 of section 39-21-39 of the North Dakota Century Code, relating window time on motor vehicles.

The amendment in this bill would lower the percentage of permittable light transmission through the front driver and passenger side windows of a motor vehicle from fifty percent to thirty-five percent.

Allowing this change would put North Dakota in a more consistent position with most other states. Currently only 8 states and the District of Columbia are more restrictive than, and four other states are equal to North Dakota in tint restrictions. Thirty-six states have equal or less restrictive tint laws compared to what is proposed in HB 1340. For this reason, I believe it is a good compromise with the traditional arguments law enforcement has made against window tint versus the benefits of having slightly darker tint.

Traditionally, law enforcement has argued against darker tint for officer safety on traffic stops, as very dark tint can limit an officer's ability to see into a motor vehicle to observe threats and see violations of law. However, thirty-five percent light transmittance still lows visibility into a motor vehicle, even at night, while still providing the added benefits in reducing glare for drivers with light sensitivity, protection from modern high glare LED lighting, reduced interior temperatures, reduced UV damage, and protection from car break-ins.

Chairman Ruby and House Transportation Committee members, I respectfully request you vote a **Do Pass** on HB 1340.


Chairman Ruby and Transportation committee, my name is Steve Vetter from district 18 which is Grand Forks along the Red River to Manvel.

We are talking about Front driver and passenger window.


